



### Sen. Forry & Rep. Collins Partner on State Budget Secure over \$1.3 million in Funding for South Boston programs and services

enator Linda Dorcena Forry and Representative Nick Collins joined their colleagues in the Massachusetts Legislature to pass a \$36.5 billion state budget for Fiscal Year 2015 (FY15). The spending plan makes important investments in local aid, education, and human services, especially in the areas of substance abuse treatment and prevention and mental health care.

"I am honored to say that my colleagues and I have passed a fiscally responsible and comprehensive budget that provides the necessary resources and capital to maintain Massachusetts' standing in the increasingly competitive economy," said Senator Linda Dorcena Forry. "I was successful in securing funding for programs throughout the First Suffolk District and am proud of the results that Representative Collins and I were able to achieve on behalf of the South Boston community. These state funds will allow neighborhood programs to thrive and continue to serve residents of South Boston and provide an opportunity for a better future," concluded Senator Forry.

"Many valuable programs and advocates fought for support in this year's budget. Nothing is ever guaranteed and it takes fierce advocacy in the House and Senate to deliver for our community," said Rep. Nick Collins. "Partnering with Senator Forry in that effort, I am pleased to report that South Boston did very well in this year's budget. With help of state funds, local programs will get the support they need to provide the kind of services necessary to maintaining a high quality of life in our community, no matter what an individual's circumstance."

With youth development a key priority on their agenda, Sen. Forry and Rep. Collins secured new funding for the South Boston Community Health Center's Youth Ambassador Program and the South Boston Leadership Initiative, which provide leadership development programs for local youth.

To address important family service needs, Sen. Forry and Rep. Collins secured funding in the FY15 budget for three agencies that have demonstrated measurable impact on the South Boston community. The budget includes funding for Julie's Family Learning Center which provides services to families and single mothers, helping them break the cycle of poverty. The FY15 budget also allocates funding for the Labouré Center's Recovery **Connections Program which supports** children and families affected by substance abuse. South Boston En Accion also received new funding for the implementation of leadership training programs, English-Spanish/ Spanish-English Immersion classes, ESOL classes and instruction in STEM studies for youth and families in South Boston.

levels across the Commonwealth, particularly relative to the opiate epidemic, Sen. Forry and Rep. Collins were able to secure state funding for the Gavin Foundation, the South Boston Collaborative Center and the Answer House to provide critical substance abuse prevention and treatment services.

The budget includes numerous additional health and human services provisions including \$60 million in MassHealth investments and \$47.5 million for nursing homes to reduce the gap between Medicaid payments and uncompensated care.

With South Boston's legacy as a community that honors its veterans, Sen. Forry and Rep. Collins worked to secure authorization and funding to build the Massachusetts Iraq & Afghanistan Fallen Heroes Memorial on the South Boston Waterfront. The Memorial will honor all post-9/11 military service members of the Commonwealth who died while serving in Iraq, Afghanistan and other operations across the globe. Additionally, in order to support services and programs for the City of Boston, Sen. Forry and Rep. Collins helped secure roughly \$169 million in state aid for the City of Boston and \$291 million in Chapter 70 funding for the Boston Public Schools.

Passed with overwhelming support in both the House of Representatives and the Senate, the budget now awaits approval from the Governor.

back on it. hen the Conquistadors ruled, the Aztec empire stretched as far as the Rio Grande, not past it. Spain was a Catholic nation. The Vatican had issued "Papal Bulls" or orders requiring the Spanish to give all aid and assistance to Franciscan Monks in establishing missions to convert the natives. The Indians were not overly receptive to conversation and these missions quickly took on the actions and appearance of military outposts, which partially explains why a church like the "Alamo" resembles a fort instead. It also explains why so many of the lower southwest towns and cities have Christian names with the furthest northern outpost, San Francisco. In the southwest, San Antonio was the northern-most intrusion and one never fully established due to constant Indian attack.

The Missions usually had small, walled and fenced areas for livestock, and housing for the clergy and workers. That was about the extent of the "colonization" of South Western North America by the Spanish - land that everyone agrees, if it belonged to anyone, it belonged to the Indians.

Alfonso Caso, archaeologist, lawyer, cultural history expert and famed Mexican human rights leader wrote a study on Mexican culture dating back to pre Columbian History. He contends the majority of Mexicans are Mestizos. He further states Whites, Mestizos and Indians are distinct, separate cultures and races. Finally, in 1810, with upheaval in the mother country of Spain, Mexico went through at least five forms of government until 1829 when Santa Anna took control and stabilized the country. However, because Indians were constantly raiding Santa Anna, it advertised in northern American newspapers looking for settlers. His idea was to have "Notre Americano" act as a buffer between the Indians and Mexican settlers farther south. Well it worked. In fact, it worked so well Santa Anna decided the Gringos got too good a deal and wanted to "re-negotiate" terms and also remind the American settlers who was in charge. The result, of course, was "Remember the Alamo".

Later when the last great Indian war chief Geronimo surrendered he was asked why he did because he hadn't been defeated by the U. S. Cavalry. "I did it to save my people. Whenever we would go to fight the soldiers, the Mexicans would attack our women, children and old people".

The Aztec Empire never extended into North America. The Spanish Conquest of southwest America neveramounted to more than military outposts with fancy Christian names. Mexican independence didn't change the Spanish failure to establish community and control. Neither Mexican nor American governments owned America.

It's extremely amusing to see a sign at the protest in Marietta, California state "Hey Caucasians go back to Europe". "It's funny because, recently, scientists have found that an "ice bridge" connected Europe through Greenland to Newfoundland and may have brought Europeans long before the land bridge believed to have crossed the Bering Strait. All of which is fine for scientific or

# Window Into The State House

Window Into The State House provides our readers a synopsis of important issues of interest, past and current, that are being proposed, debated or acted upon by the Massachusetts Legislature. Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education.

We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

#### SENATE REJECTS CHANGE IN TIP-POOLING ON19-20 VOTE

The Senate rejected by a onevote margin an amendment to a jobs bill that would have allowed shift supervisors and others to share in pooled tips. The vote was a blow to the Dunkin Donuts Franchise Owners Association, which had gained the support of liberal Democrats for a change in the law. Sen. Marc Pacheco's tip pooling amendment to an economic development bill was voted down 19 to 20 after an impassioned speech by Sen. Ken Donnelly, who said the bill would water down the pay of fast-food workers and remove the incentive for the fast service restaurants to pay their supervisors more. "There is a reason the AFL-CIO has made this a labor vote," said the Arlington Democrat and former Professional Firefighters of Massachusetts official. Donnelly said Pacheco's amendment would also remove the provision that gives workers triple damages if they are successful in wage lawsuits, which Donnelly said allows employees to take their employers to court for "wage theft." The House included on a voice vote a

### CENSUS BUREAU: US BREWERY BUSINESS "BOOMING"

The number of breweries in the United States doubled between 2007 and 2012 and brewery industry shipments rose in value to more than \$28 billion over that period, a nearly 34 percent increase, according to data released Tuesday by the U.S. Census Bureau. Employment in the industry rose over the same period to 26,077, an increase of more than 17 percent, although the average number of employees per establishment dropped from 56 in 2007 to 30 in 2012. The data from the bureau's new industry series, also showed winery employment rose to more than 37,600 in 2012, up from 33,390 in 2007, and total product shipments of wineries was evenly split between red and white, with a slight edge to red. While beer and ale merchant wholesalers reported sales of \$57.7 billion in 2012, up 10.7 percent, sales for wine and distilled alcoholic beverage merchant wholesalers were up 23.6 percent over the five-year period, hitting \$78.3 billion in 2012. In March, state officials and the Massachusetts Brewers Guild unveiled a Massachusetts Craft Brewers Passport to support and promote more than 60 craft breweries across the state. Many Bay State breweries feature locally-grown and malted grains, fresh hops and indigenous yeast strains, as well as apples, herbs, honey, maple syrup, cranberries, peaches, oysters, pumpkins and blueberries. - M. Norton/ SHNS

#### TARR CONFIDENT REDRAFTED ANIMAL ABUSE BILL WILL PASS

Senate Minority Leader Bruce Tarr is hopeful that new animal cruelty prevention and punishment legislation will pass before the end of the formal sessions on July 31. The Gloucester Republican hailed a new redrafted version of his "PAWS Act" which would update the state's animal abuse laws with acts of cruelty punishable by up to seven years in prison, up from five years, with a fine increased from \$2,500 to \$5,000. The act also requires veterinarians to report suspected acts of abuse to law enforcement and creates legal protections for mandated reporters. "Protecting animals is part of protecting all of us," said Martha Smith-Blackmore, a veterinarian with the Animal Rescue League of Boston who conducted the necropsy on Puppy Doe.

### WEEKEND MBTA BOAT SERVICE GAINING IN POPULARITY

Weekend commuter boat service, which will be available through Columbus Day weekend, is gaining in popularity. The MBTA reported Tuesday morning that 3,662 people used the boats over the July 5-6 weekend, which was the busiest since weekend service between Hingham. Hull, Georges Island and Boston was launched seven weeks ago. The weekend boats have drawn nearly 18,000 customers for an average of 1,272 per weekend day, and ridership topped 2,000 on a single day for the first time last Saturday when 2,128 people used the boats. "We are very pleased that summer travelers have chosen this convenient and affordable way to get in and out of Boston or visit Georges

Island," said MBTA General Manager Beverly Scott said in a statement. Each Saturday and Sunday, there are 14 round trips between Hingham and Boston's Long Wharf, according to the T, with a number of boats making stops at Hull, Georges Island, and Logan Airport. - M. 

# Jim Brett Honored by the Disability Law Center

ew England Council President & CEO – James T. Brett was honored by the Disability Law Center with the Edward M. Kennedy Leadership Award for his dedication and advocacy of people with Intellectual Disabilities at their Annual Benefit Dinner in Cambridge Massachusetts on Tuesday, June 17.

"Your work exemplifies the Disability Law Center's mission to promote the fundamental rights of all people with disabilities fully and equally in the social and economic life in Massachusetts," said Executive Director Christine Griffin.

Mr. Brett has served as the President & CEO of the New England Council, a non-partisan

business organization representing businesses throughout the six New England states, since 1996. Prior to joining the Council, he served in the Massachusetts House of Representatives for over 15 years. Throughout his career, Mr. Brett has been an outspoken advocate for people with intellectual disabilities. In May 2011, President Barack Obama appointed him the Chairman of the President's Committee for People with Intellectual Disabilities. Mr. Brett also currently serves as the Chairman of the Massachusetts Governor's Commission on Intellectual Disability. In addition he is the President of the Board of Directors for the Massachusetts Association for Mental Health. Mr. Brett is a member of the Board of Directors of the John F. Kennedy Library Foundation. He also serves on the Board of Advocates of Bay Cove Human Services, Inc., and on the Advisory Board of The New England Center for Children. In 2013, The University of Massachusetts – Boston established the James T. Brett Chair in Disability and Workforce Development, the nation's only endowed Chair in Disability and Workforce Development.

He also received numerous awards for his outstanding public service, leadership, citizenship and generosity. As a legislator, he was recognized for hisoutstanding service as an advocate for disadvantaged individuals and disabled veterans. He has also been recognized for his humanitarian work by Action for Boston Community Development (Lifetime Public Service Award) and Hospice of Boston (Humanitarian of the Year). ### **Clocks Dedicated at Doty Memorial Mile Swim**



n Saturday, June 14, 2014, overcast, drizzly skies fortuitously perked up just before the start of the Third Annual James J. Doty Memorial Mile Swim held at the L Street Bathhouse (Curley Community Center) in South Boston. Fifty-one swimmers from as far away as Maryland and Maine came out for the event. Of those swimmers, 49 finished the entire 1-mile loop, with Nathaniel Dean of Arlington, Mass., finishing first in a time of 22:44, and also won the men's non-wetsuit division. First non-wetsuit female finisher was Katherine Owen of Arlington, Mass., in a time of 25:45. Among the swimmers who opted to wear wetsuits, Katie O'Dair of Watertown, Mass., finished first for the women with a time of 24:00 and John Minigiello of Boston was the first wet-suited man to cross the line in 24:01. (Full results are listed below.)

But the day was not just about placements, finisher awards, and fast swimming. Rather, what turned out to be a beautiful summer afternoon in South Boston was dedicated to the memory of a legendary swimmer and community builder, former professional marathon swimmer Jim Doty who passed away in 2012 after a long illness.

Prior to the start of the race, swimmers and members of the Doty family along with friends of the family and other members of the community participated in a heartfelt remembrance of Jim Doty and a dedication ceremony for the two new clocks that have been installed at the L Street Bathhouse in his memory. Several friends, swimmers, and family members spoke of how Jim had influenced their lives and their swimming pursuits and thanked him for his generosity of spirit, time, experience, and passion for life.

Close friend and swimming partner Dr. Joel Saperstein—a retired orthopedist whom Jim nicknamed "Dr. Chicken" for his hesitancy to jump in Gloucester Harbor one day in December 1969-spoke of how much he misses Jim every day. Sharon Beckman, a law professor at Boston College who swam the English Channel in the 1980s and trained occasionally with Jim said that Jim was responsible for creating a lot of lifelong friendships in the swimming community. Jim's daughter Elinor Juviler also spoke at the ceremony about how much her father loved swimming.

Of the dedication ceremony, Massachusetts Open Water Swimming Association President Greg O'Connor says, "It feels good to see the open-water swimming community give back to someone who gave so much of himself." The clocks that have been installed at the L Street Bathhouse will aid swimmers training in the harbor, "and that seems a fitting memorial," O'Connor says.

To celebrate Jim's accomplishments and to formally dedicate the clocks, the Boston Fire Department's fire boat cruised past spraying water, a fitting and exuberant tribute for a man who is missed greatly by friends and family alike.

Many thanks are in order for the Doty family, the Curley Community Center, the New England Marathon Swimming Association, Stan Luniewicz, Fred Ahern, Bob McCormick, and the cast of volunteers who helped put on the event. and adventures all around New England. He picked up open water swimming in his 30s to lose weight and soon became a top competitor in the elite ranks of marathon swimmers. From participating in the 24-hour La Tuque relay event in the 1960s to setting numerous distance and speed records to and from the Boston Lighthouse, Graves Light, around Cape Ann, and several other iconic locations, there isn't a body of water in New England that Jim didn't swim. Jim was also responsible for forming the nonprofit New England Marathon Swimming Association (NEMSA), which is dedicated to promoting swimming and a clean aquatic environment in New England. Jim re-started the Boston Light Swim back in the mid-1970s after a long hiatus; the 8-mile BLS is the oldest open-water swim race in America dubbed "The Granddaddy of American Open Water Swims," and is used by many open water swimmers as a launching pad for more arduous challenges like solo crossings of the English Channel.

Cranberry would then load the bases in the top of the seventh but couldn't push across the tying run as Jack Rogers and the Playwright hung on for the key victory.

Wednesday's action began much like the night before as the hot hitting Mark Prezios and the STATS took on the Dragons. In the top of the first inning, Prezios homered and scored in a ten run uprising by the STATS. Everything was looking good. Except the Dragons have some "battlers" and they were not about to let one rough inning cost them the game. Instead, they went to work and scored two runs in the first and added four runs in the second, 10-6. We now had a game folks but this one was about to get away from the STATS crew. In the third inning, walks, homeruns, and a couple of errors led to a thirteen run inning for the Dragons and they were now ahead to stay, 19-10. Adam Beers (4 hits, homerun, 7 RBI) was the clutch performer while brother, Jake stayed strong on the mound to earn the very much deserved come from behind victory.

Wednesday's nightcap began much like the game before as Cranberry jumped all over rival Underdogs and plated twelve runs in the very first inning. The cushion was more than enough run support for Jay Malley who cruised through five innings allowing only four hits in a 16-3 win.

With just four weeks to go in the season the standings are beginning to really tighten. It's a three team race in the Lucas (A) division between Southside Tavern (6-2), Shenanigan's (6-4-1), and Lincoln Tavern (5-3). Shenanigans and Southside will play on July 17th @ 6pm. That game (and all the others) will have an impact on how this race for the top plays out.

Meanwhile over in the Feeney (B) division, it's a four team race that has Cranberry Café (7-3) holding on at the top but are being chased down by STATS (7-4), The Playwright (7-4), and the Underdogs (7-5). STATS and Cranberry play each other on July 23rd @ 730 then again on July 29th @ 630. Those two games will be a big factor on positioning.

\*Every week, we run part of a segment from Danny Picard's daily iTunes podcast, "I'm Just Sayin." He can also be heard weekends on WEEI 93.7 FM and seen on Comcast SportsNet New England. This week, Danny talked Celtics with Comcast SportsNet columnist Rich Levine:

**DANNY PICARD:** One of the bigger stories this summer here in Boston is what Danny Ainge and the Celtics are doing. First, let me get your take on this. What did you think of what Danny Ainge did in the NBA Draft, and specifically, with his two first-round picks?

**RICH LEVINE:** You know, I think those two picks and then what happened with Avery Bradley resigning, I don't feel like there is a take to be had until the Rajon Rondo thing works its way out. Maybe we wait until September when we see that they won't trade him until the trade deadline. But right now, it doesn't make sense. When you looked at them coming into this offseason, it's like, "Okay, what do they need? Where do they need help?" And obviously they need a big man. Their best player, and their only certified All-Star is a point guard. They have Avery Bradley, who they had to re-sign, was thought to be -- at one point, at least -- a shooting guard of the future. And then you go in on draft day and you take two guards. And then you have a guy like Chris Johnson, who you sort of found that potential diamond in the rough last year. And he still has a lot to prove, but he's shown that he can play in the back court and he's slated to make less than a million dollars in each of the next three seasons because of how they came about him. So there was already sort of a bit of an overload, and they just packed it on. So I don't know. If the idea is to keep Rondo for the long term, then you have to imagine that one or a few of these guys would be used in a package to get Kevin Love, or whoever that might be. Or if Rondo is not in the future and they end up trading him, then you

have your back court in tact without him. But right now? I don't know. I guess, if anything, they've given themselves the ability now to trade Rondo and not be stuck without a point guard, at the very least.

**DP:** Not to say I don't like Marcus Smart, but when you have the No. 6 overall pick and you're not going to make a trade, man, I just think that taking a guard that can't shoot didn't make sense. At least take a guard who can shoot at that spot. I'll get to potential trades in a few minutes, but just to look at all the guys available with that sixth pick, did you like the Marcus Smart pick? Or were you thinking, "Julius Randle, take him." Or were you thinking a little outside the box and saying, "Hey, maybe Doug McDermott is going to be a top 10 pick, so why not just take him now?"

**RL:** I mean, that would be perfect for a lot of the Boston fans if they got McDermott. It may have been a very safe pick by Danny Ainge. But coming into the draft, I had sort of made peace with either Aaron Gordon, who I think that they would have taken if he was there. I think he was their number one sort of realistic guy. And Smart and Randle. I liked them a lot. I guess a lot of the Randle thing depends on what you're going to do with Jared Sullinger, because in that sense, they're obviously not the same player, but I don't necessarily know that those guys would be able to co-exist very well. And then again, you say that you're not going to take Randle because you have Sullinger, and then they took Smart when they have Rondo. So it's sort of going against the same principle on that. With Randle, I think he's going to be great. He reminds me a little bit of Charles Barkley. he

sort of has that tenacity. But he has this foot issue, and people are still trying to figure out what the truth is. He has screws in his feet right now, and he's going to have to get them removed at some point, which will take a surgery, and then who knows what happens after that. There's the fact that Randle skipped his second workout in Boston to be part of some GQ Magazine internship thing like Rondo did a summer or so ago. So he skipped that, and I think he was making it pretty clear that he wanted to go to the Lakers. But there's something about Smart. I don't know man, he just has the mentality. And I know that it's easy to maybe get carried away with that. People do so to avoid talking about his shooting and stuff like that. But he has a way about him, where one guy and one mentality can change a lot. And maybe he has that. I think that, mentally, even though he had that one big mess-up in college, I think he's a great guy to have around.

**DP:** I'm sitting there watching the draft and I'm going, "When are they going to announce that the Minnesota Timberwolves have traded Kevin Love to the Celtics?" I was just waiting for it. Rich, I really thought it was going to happen. And now we hear the report that Danny Ainge, behind the scenes, still has a "relentless pursuit" of Kevin Love? **RL:** Listen, until Kevin Love is on another team -- one thing we know is that the Timberwolves have to trade him. If they don't, it would just be so unbelievably stupid to the point where you can't even consider them holding onto this guy and losing him for nothing. They have to trade him. There are only maybe three or four teams that have a legitimate chance of packaging the picks or just having the assets to get this done. And the Celtics are one of them. They might not have the best live talent, or current guys, but they have so many draft picks. Again, you ever have a guy in your fantasy league that is just so obsessed with making trades, he just beats you down over the head, over and over? I think that's Danny Ainge. He knows that Minnesota has to do it, and he's not going to stop until Love goes somewhere else, or until the Timberwolves finally give in and bring Love here.

**DP:** I guess I was just hoping that the Rondo and Love handshake at Fenway Park meant more than Marcus Smart at No. 6. That's all I was hoping for on draft night.

RL: If only Flip Saunders was in on that to make it a three-way handshake. Believe me, I think Love would love to end up here. I really do. Every single NBA star who has come through Boston has loved the city and has had nothing but good things to say about it, recently. I know there have been some issues in the past, but Pierce, Garnett, Ray Allen. Shaq is one of the biggest divas in the world, and he loved Boston. I think Minnesota doesn't really know what to do. They know that they traded Kevin Garnett away and it was a disaster for them. And I think right now to make the same trade with the same type of player, they're kind of nervous, and they want to make sure they go about it the right way. Because I don't know that they can really afford to miss again on such a move.

**DP:** That brings me to my Avery Bradley contract theory. But first, I want to see what you thought of Bradley's new four-year, \$32 million deal. **RL:** I want to wait to see what happens with Rondo, just because Avery Bradley, as a starting shooting guard in a not super-crowded back court, that's a lot. But it's changing. The salary cap is higher this year. I think the market is dictating that. But I'd like to hear your theory on his contract.

**DP:** My theory is, there have been reports on Minnesota's end, that, if they're going to trade Love, they also want to get rid of 31-year-old guard Kevin Martin, who last summer signed a four-year, \$28 million deal. And you know about the whole matching salaries bit. Kevin Martin is 31. The Timberwolves have to pay that. If they know they have to pay \$7-8 million a year for someone, why not just bring in a guy like Avery Bradley who is only 23 years old, and ship the 31-year-old somewhere in the process of making the Kevin Love trade. Is that a crazy theory, that this Avery Bradley contract has something to do with potentially Kevin Martin being moved with a Kevin Love to Boston?

**RL:** I definitely find that interesting. The numbers matching up, and the fact that, that seems to be one of the biggest issues with a trade getting done with the Golden State Warriors right now, is that Golden State doesn't want to take back Kevin Martin. So yeah, if the Celtics can do that, that obviously gives them a leg up. But the one thing, I know that after Bradley officially signs the contract, he can only be traded one-for-one. He can't officially be a part of a multi-player deal. But I do think that's a great theory, to be honest. Right now, it's either get

Kevin Love, or clear the deck and hop to get lucky in the draft. That's what the Celtics are staring at right now. So yeah, I think that's a great theory. Let's go with it.

DP: Finally, put yourself in Rajon Rondo's shoes. After the draft, after the Avery Bradley signing, before any type of potential trade. How do you feel? And what's your message to the Celtics' organization, moving forward? RL: I think that there is a decent chance that, maybe at the end of every week Danny Ainge calls Rondo and says, "Listen, I just want to let you know what's going on, to keep you in the loop. Because we want you a part of this." If that's the case, Rondo, growing up the way he did in the NBA with Pierce and KG and those guys, and losing his friend Perkins in a trade the way he did, I think he really does understand that this is a business. So I'm sure that the Celtics and Rondo both have the same feeling. Like, "Listen, we both want to win, we both want to win together." But the most important thing is winning, and if that takes finding a place for Rondo like they did with Pierce and KG where he gets a chance to compete. I'm sure Rondo wants to figure it out. I think Danny and Rondo are being open and honest. They're going to try their best, but if the Celtics can't build around him, then they'll do their best to send him to a winner. And if I'm Rondo, I'd say, "Okay, that's great. Do your best."


