A firefighter inhaling toxic fumes or being struck by a flaming beam or destroying their back, while lugging an unconscious victim to safety, might be too injured to continue their career and forced to retire.

A firefighter suffering this fate and requiring a disability in 1994 would, today, receive a little more than \$30,000 a year in pay.

Twenty years later the Boston City Council, already being generously paid in excess of 87 thousand dollars a year is actually considering a raise of about 25 thousand a year. The rationale being that the council hasn't seen a raise since 2006. Overlooking the fact only two of the present councilors were even in office in 2006, somewhere a firefighter struggling with a cane or through daily therapy unable, perhaps, to enjoy any family life because of their new limitations must be scratching their heads.

Casino Goes To Everett – Now What For Boston?

Poker is not for everyone. Gambling can become an addiction. Money talks. Politics is a tough game. Casinos are even tougher. The clichés go on.

A casino may be a boon to the economy in the short run, but what is its impact in the long run? South Boston has escaped the potential impact of traffic through its streets on the way to the Ted Williams Tunnel from the South Shore that may have been a result of a Revere casino. The Wynn Resorts casino going to Everett will have that impact on Charlestown and it remains to be seen whether a truce is brokered between Mayor Walsh and the Vegas mogul.

It is likely that with a license designation in hand and the odds in his favor, a prudent Steve Wynn will figure out a way to reach an

accommodation with Marty Walsh, especially if he can avoid a costly lawsuit and a stiffened bureaucracy. Coming up with a multi-modal transportation plan that works will be critical and cooperation with Boston will be crucial.

Let's face it; both Revere and Everett were in need of an injection of economic stimulus. The argument can be made, and apparently was a factor, that Everett with no oceanfront (the Mystic River is not a very navigable waterway after reaching Charlestown), dwindling industry and a haven for the Big Box stores was more in need of the boost that they now expect from this decision. As for Revere, the impact of the loss of thoroughbred racing on the heels of the loss of greyhound racing has made the Suffolk Downs site either a real estate developer's dream property or will give the City an opportunity to carve out an economic development niche that will attract the kind of mix of industrial, commercial and residential interests that will re-fuel its economy. But, that will take time, patience and ingenuity. It's an opportunity nonetheless, especially if the Commonwealth designates it a Gateway City.

Back to Boston. Boston is booming, as residential and commercial real estate prices attest. Observers have opined that having a casino nearby, while a tourist attraction, is not what Boston needs to be noted for globally. Boston has so much going for it, as evidenced by the number of international flights arriving at Logan Airport and the contracts for large scale Conventions coming that the Mayor's attention to the city's core industries are what should occupy his time. Generating economic opportunity for the neighborhoods is a tall order and needs to be his priority.

In a bet, there is a fool and a thief. Mayor Walsh and Steve Wynn are neither of these. They will be back at the negotiating table. Walsh knows that as a former union leader and now the leader of a major international city. Wynn knows that as a businessman.

and we are all doomed unless we all pay more in taxes. (In fact: The most recent study out just last week said that the ice in the Antarctic is at all-time record levels, more wide spread and dense than at any time since records have been kept).

The conversation then moved on to the IRS and NSA and other federal agencies and now the gathering grew to about 10 or 12 people involved; about half of them were locals and the rest from out of town; all of whom had similar gripes. "The IRS expects us to believe that only the websites and files that had the emails that Congress was demanding regarding the harassment of various groups crashed and only those emails, the ones that could show possible illegal activity, could not be retrieved?" asked a young local dad, pushing his toddler son in a stroller. The same parent then brought up the NSA which, because of all the whistle blowers, everyone now knows that they were collecting millions of phone records from innocent law obeying citizens, yet they continued to deny it for months. "How about Obamacare?" another brought up. "You can keep your plan and the cost would drop? They knew it was a lie when they were selling it to the public because they believe the American people are morons. Or at least they were hoping we were."

The conversation then switched to the state level. "Deval Patrick actually thought he could tell us that he knew nothing about the more than one thousand illegal immigrant children that were quietly sent to Massachusetts and we were actually going to believe him. 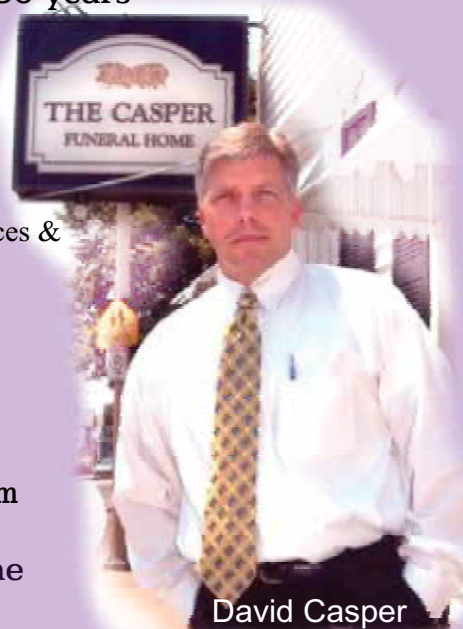

Reading Between The Lines

“Can Do”

Ward Churchill is a former University of Colorado professor, charlatan and America basher, who lost his position after writing a paper labeling the 3,000 murder victims of 9-11 as “little Eichmann’s”, suggesting that those who worked in the World Trade Center towers represented technocrat collaborators with the military industrial complex. This was, of course, a reference to the Nazi commander, a non-military collaborator, in charge of the system that murdered 6 million Jews. As always the best examples are right here where America really began, South Boston.

In 1630, the ship ‘The Mary And John’ arrived off the Massachusetts coast. A scouting party landed their row boat on an outcropping, which became known as Old Harbor. Today the area is known as Old Harbor Street. That first boat had two brothers named Gillette. One brother named Nathan took his branch of the family, eventually, to Wisconsin. Over 270 years later, his descendant named King Gillette would return to his family’s first landing of South Boston. Borrowing money to forge his inspiration, Gillette built a factory in South Boston to manufacture the invention. That invention physically

and socially would “change the face of the world”. His disposable blade made what was a costly, sometimes painful, grooming procedure – shaving – available to the common man. For the next 70 years Gillette was the world leader in shaving and its equipment.

If necessity is the mother of invention, competition must be the father. As more companies began matching or even passing the quality of the Gillette brand, profit began to shrink. Gillette’s had a large research and development team, along with other makers, trying to create the next generation of cleaner, closer, smoother, safer shaving systems, namely a 2-blade system. The problem was that the shavings quickly clogged and the razor became useless.

Enter a South Boston engineer from “I” Street Frank Dorion. Dorion’s solution was hailed as the “greatest shaving invention since the first single blade itself”. Sadly Frank died in 1973 at a very young age after his invention in 1970, the Trac-Two Double Bladed Disposable Razor. Because of Frank’s invention, MACH 3, Quatro and all other multiple blade systems are making our lives just a little easier.

The next example goes back to WWII, and has that “only in Southie” quality. During the war, a couple of life long friends were arguing over which service produced the better pilots. Marine pilot, Bill Deegan, naturally felt that the “flying leathernecks” were unmatched. His friend Robert E. Lee known as “Pickles” held out for the “flying doggies”, not surprising considering he was a pilot in the U. S. Army Air Force.

The debate was good natured but long lasting, starting when they joined their respective branch of the

military. Finally Bill Deegan had reached his limit. No more talking. “If you want to know who the best pilots are, be down L and 8th Street tomorrow at 10:00 A.M.” Deegan told Pickles. Sure enough Pickles was on the corner at 10 when a roar filled the air. Bill Deegan had gone down to the South Weymouth Air Base and signed out a fighter. As Pickles looked a plane came up and over the L Street Bath House, streaked by Pickles at L and 8th and up L Street. To add to the degree of difficulty, Deegan was flying vertically. That means instead

of flying horizontally, with his wings pointing East and West, Deegan went the length of L with his wings pointed north and south.

Obviously, Ward Churchill never met any South Bostonians. If he had, and after recovering from a beating for talking bad about America, he would know that inventiveness and action, not words or attitude, are the hallmark of America and South Boston. They are indeed ours and no amount of these radical 60’s America-hating cowards will ever change that, or take it away.

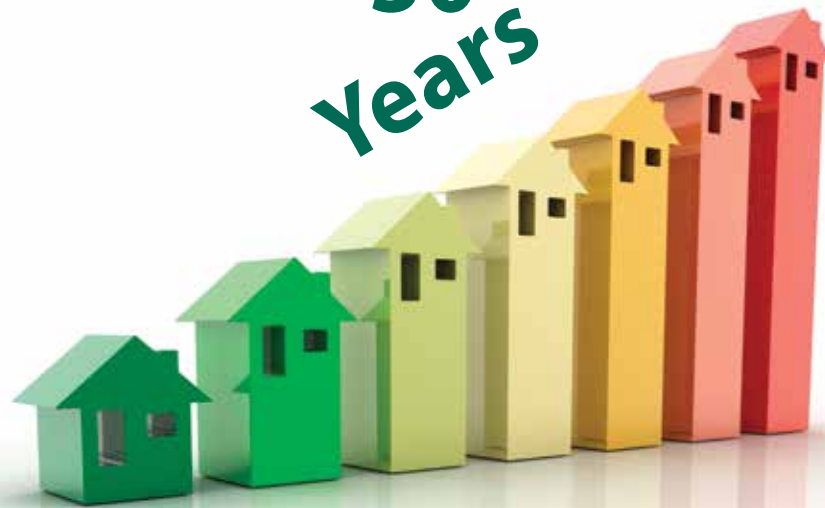

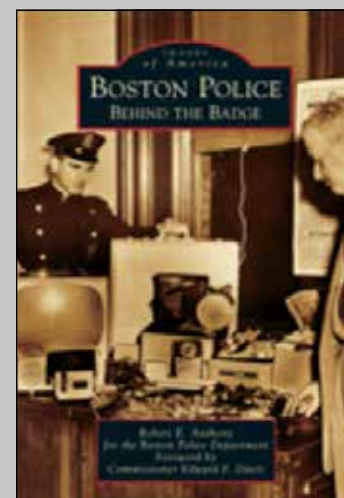

Every week, we run part of a segment from Danny Picard's daily iTunes podcast, "I'm Just Sayin." He can also be heard weekends on WEEI 93.7 FM and seen on Comcast SportsNet New England. This week, Danny talked Patriots with Comcast SportsNet's Mike Giardi:

DANNY PICARD: Well, the Patriots go to Minnesota and pick up their first win of the season. When you look back at that win, do you say, "That was the Patriots getting back to the way they do business," or do you look at it and say, "This was a Minnesota team that, without their best player, wasn't really a tough matchup"?

MIKE GIARDI: I thought going into the game that the Vikings aren't a very good football team. I think they proved that. But obviously not having Peterson, their best player, a guy that the Patriots would have had to spend a great deal of time focusing their energy on stopping, you take him out of the equation, and it made things a lot easier. Matt Cassel is a below-average quarterback. He's one of the worst starting quarterbacks in the league. So, what you take from it is, after giving up that opening touchdown, the Patriots defense just got nasty. They were in lockdown mode. They made life very difficult for the Vikings. Offensively, not a good game. I understand why Tom Brady was not exactly beaming after the contest. So, you take the win, there were some things to build off of. But I don't think you can get crazy and be like, "Well that's the patriots' defense," or, "This is the way it's going to be going forward." And I'm not sure you're going to get much of a test [in Week 3] either with Oakland.

DP: Some people are giving Brady [heat] for being a little upset. I don't understand it, because the people that are giving him [heat] are the people that understand the Patriot Way more than anyone. And isn't that the Patriot Way, to not be satisfied, even with a win in Week 2, to want to be a perfectionist? I mean, isn't that attitude the reason this Patriots organization has been so good

in the past anyways?

MG: You know what, I heard the same stuff that you did. And I actually had to answer the question myself from some people. To me, that is the epitome of talk radio trying to come up with some sort of storyline. And one of the things I've always appreciated about you is that you just tell the truth. And that, to me, was so far -- we used to give him credit for this. They won a game, but they didn't play well, and Brady would sit there and say, "It wasn't good enough." Now he does it and we think he doesn't like the offense is trending and he's not getting the weapons around him that he wants. No. They have to be better, and he knows that. He knows that if they're going to be the kind of team that we've talked about them being, then the guys around him have to be better and he has to be better. So I have no problem with him being like that. I think people need to just relax.

DP: After Week 1, one thing we all agreed that needed to improve, is the offensive line. We saw it after the loss in Miami. I think that was the biggest issue for this team. How do you think the Patriots offensive line looked in Minnesota. Maybe put aside who they were going up against, and I guess, just strictly tell me what you saw from the offensive line. Were there improvements, and where were those improvements?

MG: Definite improvements, some of them I'm not going to get too excited about. Some of them was back to what I thought. And back to what I thought was Nate Solder and Sebastian Vollmer playing at a high level. They struggles mightily in Week 1, both of them. And look, the Dolphins have a great defensive front, that's a fantastic group, so most teams are really going to struggle against that group. But both of

those guys were just completely -- that's about as bad as I've seen them play in a long time. And I think they rebounded and played more like I expected, in Minnesota. They gave Tom time on the edge. They played smart. I know Solder had a few penalties, and I don't want to discount those, because they show a lack of discipline and are things that can't happen. But in terms of when he had to pass-block and when he had to run-block, he did both extremely well. I thought Vollmer was good as well.

DP: And on the defensive end, four interceptions. A couple of them were just Matt Cassel throwing them up. Look, we knew this Patriots defense was going to be a defense that had the potential to make big plays. So regardless of how they make them, it's got to be encouraging inside that locker room to make them, especially after the Miami game, where they didn't make the big plays and they didn't make the big tackles. To bounce back here, and really, regardless of how you make them, just make them.

MG: That's the thing. We can put lesser marks on the win because of who they did it against, but we'd be raising a lot of questions if they gave up 20-24 points against a Vikings team without Adrian Peterson. So, aside from that first drive, they did exactly what they wanted to do defensively. They got a ton of pressure on Cassel. Coverage sacks, sacks where you're beating guys straight-up. And the Revis effect is evident. I have said it for a long time, he's been one of my favorite players in the league to watch, maybe my most favorite player to watch on the defensive side of the ball, long before he got here. The interception was, the guy studies film, he has a photographic memory, he saw a formation again that
