

#### AAA REPORTS FIRST GAS PRICE INCREASE SINCE SEPTEMBER

Gas prices in Massachusetts shot up 11 cents a gallon over the past week, an increase analysts attributed to rising crude oil costs. AAA of Southern New England reported Monday that its latest survey found unleaded gas averaging 2.17 per gallon, which is still 8 cents per gallon lower than a month ago. A year ago, gas in Massachusetts was averaging \$3.36 per gallon. AAA said gas prices in Massachusetts are currently ranging from a low of \$1.99 to a high of \$2.49. - Michael Norton/SHNS

### MHA: OBAMA BUDGET "VERY BAD NEWS FOR HOSPITALS"

Massachusetts hospitals say President Barack Obama's new fiscal 2016 budget proposal is full of "very bad news," namely billions of dollars in reductions in payments to health care providers. In its "Monday Report" released over the weekend, the Massachusetts Hospital Association reported that Obama is seeking \$350 billion in cuts to health care providers as part of the president's proposals to reduce overall health care spending by \$423 billion. As the Republicancontrolled Congress begins reworking Obama's budget, the association is raising concerns about reductions in spending on inpatient rehabilitation facilities, long-term care hospitals, critical access hospitals, off-campus hospital outpatient departments and home health agencies, as well as reduced payments to hospitals in connection with bad debt and medical education. "The proposed cuts are very bad news for hospitals that have been constricting themselves at the same time that they are undertaking innovative care delivery models within ever-shrinking operating margins," the association reported. "The good news is that a president?s budget proposal is usually dead on arrival. The House Budget Committee will begin work on its own document soon and while the president?s proposal will not be considered in mass, individual provisions are often adopted in the Congressional blueprints." - Michael Norton/SHNS BAKER BACKS UNIVERSAL VACCINATIONS

Gov. Charlie Baker supports universal vaccination programs, he said Friday, responding to a question about a public health issue brought to the fore by politicians' comments and measles cases blamed in part on parents who choose not to vaccinate their children. "Massachusetts has one of the best universal immunization programs in the country. I was proud to work on strengthening that program when I served in state government back in the 90s," Baker told reporters after a Cabinet meeting. He said, "I think universal vaccination programs are a good thing." Baker, who previously led Harvard Pilgrim Health Care, said when the fiscal crisis sapped the state budget, the health plans "all stepped up" and wrote checks to support vaccinations. According to published reports, some parents believe vaccines cause other health problems, including autism, though experts say that is completely unsubstantiated by science. - Andy Metzger/SHNS

### POLLACK: SNOW "OPENED OUR EYES" TO TRANSPO INVESTMENT SITUATION

With snow-induced gridlock channeling the public's focus on the shortcomings of the public transit system, Gov. Charlie Baker's transportation chief said Thursday "people will decide" if more investment is needed in the system. "Obviously the events of the last week have really opened our eyes to the cumulative effects of the investment we've made and the investment we haven't made in the system," Transportation Secretary Stephanie Pollack told reporters. Rep. William Straus, a Mattapoisett Democrat

who led House transportation policy efforts last session, said Wednesday that passage of a November ballot law repealing the 2013 law linking the gas tax to inflation left a \$2 billion deficit over ten years. Pollack said the administration would work with the funding it has. "Initially, I'm going to put out a capital spending plan that spends what we have and doesn't spend what we don't have. And then people will decide whether we should be investing more than that, but I've got to balance it," Pollack said. Gov. Charlie Baker plans to fill a \$768 million midyear budget hole in part by taking \$40 million out of transportation spending, a move that the governor says won't affect services. "The Legislature was kind enough to give the MBTA money over and above the dedicated revenue number from last year - \$135 million," Pollack said. "Our budget is running in surplus, both because the T has effectively cut costs and because fares revenue is higher than it was. So what the Legislature is saying is, 'Given other needs statewide, since you can cover some of your costs, you should.' That's what we did." - Andy Metzger/SHNS

#### MASS. LAWMAKERS SEE NUMBERS IN FAVOR OF GMO LABELING BILL

Proponents of labeling requirements for food products containing genetically modified organisms (GMO) say they have enough support in the Massachusetts House and Senate to get a bill to Gov. Charlie Baker's desk if the legislation is surfaced for floor votes. According to Massachusetts Coalition for GMO Labeling, 125 House members and 29 Senate members have signed on as co-sponsors of the bill, which is being pushed by organic farmers and groups like MoveOn. org and MassPIRG. The coalition on Thursday released supportive statement about the legislation from Reps. Ellen Story (D-Amherst), Todd

Smola (R-Palmer), Michael Moran (D-Brighton) and Stephen DiNatale (D-Fitchburg), as well as Sens. Bruce Tarr (R-Gloucester) and Joan Lovely (D-Salem). "Over the last two years, we have increased the number of cosponsors on GMO labeling legislation more than sevenfold," Story said in a statement. "This issue resonates with everyone because it is a reasonable request about a basic right we all should have: tell us what is in our food. I truly believe that this will be our year to pass this bill." - Michael Norton/SHNS

#### STATE REPORT IDENTIFIES SHIFT IN MASS. HEALTH INSURANCE PLANS

Membership in health maintenance organization insurance products across the commercial market in Massachusetts declined by 10 percent, or 209,000 people, from 2011 to 2013, according to a brief released Thursday by a state agency. The Center for Health Information and Analysis (CHIA) reported that the Massachusetts commercial health insurance market grew by 73,000 members, or 2 percent, from 2011 to 2013. The growth was exclusive to preferred provider organization (PPO) products, which experienced a 16 percent increase due in large part to trends at Blue Cross Blue Shield of Massachusetts, the largest commercial payer in the state. Massachusetts HMO membership declined by six percentage points, falling to 46 percent of the market in 2013, CHIA reported, while PPO membership rose to 50 percent of the market. According to CHIA, the shift may have implications for adoption of patient care coordination and alternative payment methodologies "as both are associated with HMO products." CHIA reported that on average, Massachusetts HMO members pay higher premiums and receive higher benefit levels and lower medical cost-sharing than PPO members. - Michael Norton/SHNS

Never the less the Patriots integrity, honor and success has been under attack and questioned. That means our entire region's support and honor and integrity was under attack as well. Their victory was a defense and an


answer for us all.



### **Letter To The Editor**

Residents of Gate of Heaven parish: "These real estate deals are conducted behind closed doors!"

As Boston residents awoke to another huge property tax increase in their mail box recently, residents are also expressing their frustration with their voices not being heard. Those on fixed income and families with children in private schools are financially struggling to continue to live in South Boston, and help is not on the way, as demonstrated by the recent increase in the property taxes.

At a controversial meeting several weeks ago, with a representative of the mayor's office and the BRA both in attendance, the developer, and his unofficial "government relations liaison," with close ties to the mayor's office, were telling residents of the Gate of Heaven neighborhood why adding more condos will be best for South Boston residents. As this political operative was discussing the need for more luxury condos in South Boston, several residents politely but firmly interrupted him and began to talk about the huge increase in property taxes that the City of Boston just accessed on its residents.

Additionally, the developer's associates admitted that they are engaged in a closed door meetings with the mayor and City Councilors. People were shocked to learn that a major decision to possibly turn the old Gate of Heaven School building into luxury condos would be conducted in a back room with the developer, political consultants and the mayor's office.

Some of the same people and "liaisons" supporting the current luxury condo proposal were involved with the Gate of Heaven Rectory and Gym boondoggles. Will this mayor let this happen again against overwhelming neighborhood opposition, so that a few people can get rich?

As the developer and political operatives continue to seek support from the mayor and members of the Boston city council behind closed doors, the community is fighting back. The Gate of Heaven neighborhood is working hard to welcome other options, some of whom submitted bids to the archdiocese.

Last year, a poll conducted by South Boston Today newspaper, reported that well over 90% of residents of South Boston were in opposition to this luxury condo proposal. Additionally, the mayor conducted his own poll of abutters and found 85% were opposed to these luxury condos. At the same time, over 700 South Boston residents attended a community meeting at The Tynan Community School and the vast majority was in opposition to the luxury condos.

As the meeting concluded at the site of the old Gate of Heaven School, one longtime resident stated, "Where is the justice? Where is the fairness?"

The excuses were endless, but the awareness has been there at least for the last 5 years according to records uncovered by the Boston Herald. MBTA officials, blaming dismal performance on old subway cars and buses, have failed to file reports detailing the troubled system's needs for at least five years, 2 years during General Manager Beverly Scott's tenure — and have yet to get a new database up and running to track maintenance costs despite having the funds.

The Herald reported that the last time the public got an updated report about the T's maintenance backlog was in 2009, when former John Hancock President and CEO David D'Alessandro took an independent look at the T's aging system and estimated it would cost more than \$3 billion to fix it. By last March, experts were warning the cost could be twice that amount, or \$6 billion, according to an analysis by Gov. Charlie Baker's current transportation czar, Stephanie Pollack, who was then associate director of the Dukakis Center for Urban and Regional Policy at Northeastern University.

T officials admit that a new database that would detail the so-called "state of good repair" costs — created with the help of a \$1 million federal grant — is still not functional, even though former Gov. Deval Patrick's administration got funds for it several years ago.

With the T collapsing in recent weeks under the weight of a series of historic snowstorms, Baker has called its delays unacceptable, saying Monday that it's "pretty clear that they need a new operating plan." A source close to the administration went further, saying without data on what needs to be maintained, it's difficult to create plans to keep the T running before any new cars arrive, which for the beleaguered Red and Orange lines won't be until 2019 at the earliest.

"The T has been figuring out how to survive day to day. And under the Patrick administration, the plan was for 10 to 15

years in the future. That's good, but having done that, and with no current plans to acquire any new vehicles ... for the next four years, how are they planning to run the system during that time period?" one source said, summing up the Baker administration's frustrations. "Knowing how old they are, how could you not have a game plan?"

T spokesman Joe Pesaturo did not address questions about why the T hasn't provided a maintenance update in years. But he acknowledged that the agency received \$1 million in federal funds "several years ago" to create a so-called asset management plan, which included a new online database to keep track of maintenance costs. The T expects to complete the database "this summer," though Pesaturo defended the drawn-out process as "painstaking."

When Ms. Scott accepted the position in December of 2012, she presumably accepted the System, warts and all. Scott received a 3-year contract and an annual salary of \$220,000. It was noted in a boston.com article published in November 2012 around the time of her appointment that while she was the head of Atlanta's Transportation System (MARTA), that in order to improve her management performance she was directed to meet monthly with a psychologist "for individual coaching and consultation." In addition, Ms. Scott had requested an audit. The KPMG audit found MARTA to be in deep trouble, with an operating budget deficit of as much as \$33 million a year, a shortfall that is being made up by dipping into reserves. The audit projects the complete depletion of the system's reserves in 2018. The "current economic model is unsustainable," the audit said. Mass DOT officials chose to disregard these revelations and expressed confidence in Ms. Scott and finalized her contract.

Ms. Scott is no longer on the hot seat, but pundits and political observers will dissect the state of the MBTA, Ms. Scott's tenure and Gov. Baker's decisions for days and possibly weeks to come.

### **Sheriff Tompkins Calls For More Recovery Support**

iting the need for more addiction recovery beds and diversionary programs, Sheriff Steven W. Tompkins offered support for Boston Mayor Marty Walsh and the Dimock Center in their focus on addressing the issue of substance abuse and recovery at tomorrow's "Breakfast of Champions" program at the Dimock Center.

"More than eighty-five percent of our

population is in our care and custody due to drug and/or alcohol related offenses," said Sheriff Tompkins. "Rather than locking people up who would be better served by addiction recovery and diversionary programming, we should be looking expansively at alternatives to incarceration. I commend Mayor Walsh and the Dimock Center for their powerful commitment to the issue of

addiction and recovery and all of the leaders assembled for discussing this important issue."

Included among the many educational, vocational and behavioral programs that the Suffolk County Sheriff's Department offers, its focus on addiction and substance abuse includes addiction recovery units, which help chemically dependent inmates and detainees in their

efforts to change their behaviors, beliefs and attitudes in order to successfully integrate back into society. In addition, the Department also offers 90-day substance abuse recovery programs at both the House of Correction and Nashua Street Jail, an Opioid Peer Prevention program, and, in collaboration with the University of Massachusetts at Boston, the Department offers ACEP (Boston Addiction Counselor Education Program), as well as other programming.



### State Panel On Oversight Of 2024 Olympics To Be Formed

he Boston Globe is reporting that State Representative Mike Moran of Brighton has filed legislation to form a commission with oversight authority over the finances of the Olympics. This oversight commission would be empowered to review "the public safety, economic, and social impacts" of the 2024 Summer Olympics. Failure to provide the commission with "any information formally requested" could result in the withdrawal "of any and all public funds related to the Olympic bid.""

Moran stated, "We're trying to find space in the process for the State to get some independent analysis of what the Olympics means for us on the state level." A similar type of Commission was set up in for the Chicago Olympic bid a few years back. Speaker of the House Robert DeLeo and Senate President Stan Rosenberg have both expressed concern about tax payer dollars and want to see what

benefits the Olympics would have across the state.

The bill filing comes as the Boston Olympics Committee has come under scrutiny having been accused of not being fully transparent. The Walsh administration has agreements with the Olympic Committee forbidding it from making certain aspects of their contracts from being publicized.

Mayor Walsh responded to the idea of the Oversight Commission saying, "I don't need legislation to explain to me how important it is to have transparency," Walsh said. "If we need legislation to have transparency, then we should just forgo the bid altogether." SBT will follow this as the process develops.

The EITC is a powerful tool in the fight against income inequality. "Our goal is to combat poverty as a systemic, citywide issue," explains Mayor Martin J. Walsh. # Editor's Note Immigration Reform And Its Economic Impact Needs To Be Debated

he Deferred Action for Childhood Arrivals program (DACA), by all accounts, could affect more than 5 million unauthorized immigrants living in the United States by making them eligible for work permits and federal benefits. The massive economic impact of this program must be carefully considered and debated in Congress.

Polling data to date suggests that President Obama's action to implement DACA is opposed by a majority of Americans, when informed that the policy allows unauthorized immigrants "to avoid deportation and seek jobs in the United States." Granting work permits to millions of unauthorized immigrants, according to many economists, could lead to severe labor displacements and surely would drive competition for scarce, well-paying jobs.

T.A. Frank, writing in the New Republic concerning blue collar Americans, states: "Even as these Americans have lost their well-paid manufacturing jobs, Washington has looked the other way while millions of low skilled unauthorized immigrants have competed with them for low skilled service jobs."

With elevated passions and tremendous costs at stake, the time is now for Washington, in particular, the Senate, to debate these defining issues. The American people deserve to have a matter, as complex as Immigration, fully vetted on the floor of the Capitol.

### Mediocre Red Sox Rotation Has A Lot To Prove


