We'll Pay You To Act Civilized? Has It Really Come To This?

I've never met Boston City Councilor Tito Jackson of Roxbury. From what I've read, he seems like a good and decent guy, who cares deeply about the violent crime running rampant in his district. He should care. There is a dangerous minority of kids and young adults running wild shooting, stabbing, selling drugs and pretty much terrorizing the innocent folks, who reside there and who just want to be able to live their lives in safety and peace. But the solution that Councilor Jackson is proposing is, for lack of a better word – nuts.

Window Into The State House

These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

BIG MAY PUSHES TAX COLLECTIONS \$389 MIL AHEAD OF BENCHMARK

The latest tax collection data appears to underscore the belief that this year's state budget problems were not due to revenue problems. With one month left in fiscal 2015, tax collections are running \$389 million above the benchmark used for budgeting purposes, thanks to \$1.84 billion in May receipts that followed the state's first-ever \$3 billion month in April. The above-benchmark revenues bode well for a potential surplus in fiscal 2015 although the level of end-of-fiscal-year supplemental appropriation needs is not yet known and any surplus will also depend on Baker administration implementation of mid-year spending cuts. May tax collections were up 13.2 percent over May 2014 and fiscal-year-to-date collections are up 5.9 percent over the same 11-month period in fiscal 2014, not including more than \$183 million in large tax settlement payments. May revenues beat the monthly benchmark by \$228 million, mostly due to income tax collections. "The improvement in labor markets continues this month as evidenced by the increase in withholding, even after accounting for some possible acceleration of June payments into this month," Revenue Commissioner Mark Nunnally said in a statement. "We saw further evidence of recovery in the withholding performance with the growth of bonus-related revenues in the finance, insurance and biotech manufacturing industries." The recent two-month corporate and business amnesty program that ended May 15 resulted in collections of about \$15 million, less than the \$18 million forecast. - Michael Norton/SHNS

BOSTON TOPS CENSUS LIST FOR PER-PUPIL SPENDING

Doubling the national average, Boston led major school districts

across the country in per-pupil spending, according to a new U.S. Census Bureau annual report on public education finance. The data shows Boston spent \$20,502 for every student in its public schools in fiscal 2013. Nationally, school districts spent an average \$10,700 per student - up by just under one percent over the previous year. The bureau compared the 100 largest American school systems, based on enrollment. New York City came in less than \$200 behind Boston, followed by Anchorage, Alaska; Montgomery County, Md.; and Baltimore, Md. According to the Massachusetts Department of Education, 49 percent of Boston students scored proficient or higher on the 2014 MCAS, with 44 percent reaching that level in math and 27 percent in science. At the state level, Massachusetts was eighth in per-pupil spending in fiscal 2013 at \$14,515, a 2.6 percent increase over the previous year. New York topped that list at almost \$20,000, followed by Alaska, the District of Columbia, New Jersey, Connecticut, Vermont, and Wyoming. Massachusetts was ahead of Rhode Island by \$100. BAKER BILL PUTS BUSINESS REP IN CHARGE OF WORKFORCE BOARD

The Massachusetts Workforce Investment Board would be streamlined and renamed under new legislation offered by Gov. Charlie Baker that would reduce the size of the board from 65 to 33 members. Baker administration officials say the new Massachusetts Workforce Development Board would include 17 business representatives and seven workforce representatives, along with state government designees. A business designee would chair the board, which the administration

says would bring the state into compliance with the Workforce Innovation and Opportunity Act signed by President Obama in July 2014. In a filing letter dated Friday, Baker said the 65-member board is "unwieldy" and noted the federal law requires that a majority of the new board members be drawn from the business community, with at least 20 percent representing members of the workforce. Baker urged lawmakers to act promptly, saying the US Department of Labor has sent July as the target date to introduce the new board. The current board advises the governor on aligning its workforce system with state education and economic development goals. Matching the needs of employers with the skills of the state's workers has long been an objective of policymakers hoping to link the state's jobless with the unmet needs of companies with jobs that need to be filled. - Michael Norton/SHNS

STATE NOT MEETING RESPONSIBILITY TO FUND HEALTH CARE AGENCY

State government has not met funding obligations under a 2012 health care cost control law, instead pushing its share of costs onto the industries charged with reining in spending under the landmark reform law, according to hospital officials. The Massachusetts Hospital Association (MHA) and two other industry groups are pressing lawmakers to pass a bill (S 635) the groups say would "enforce the intent" of the 2012 law, which came six years after passage of the omnibus insurance access law often known as Romneycare. The MHA says state government was supposed to cover 33 percent of the costs of funding the Center for Health Information & Analysis (CHIA). But for the third straight year, it appears hospitals and insurers will be asked to cover all of the costs. In

its Monday Report, the MHA wrote that the "cost shift to hospitals and insurers is occurring at a time when CHIA is growing. MHA's Executive VP Tim Gens testified last week for the bill along with Conference of Boston Teaching Hospitals Executive Director John Erwin, Massachusetts Council of Community Hospitals Executive Director Steve Walsh, a former state rep and one of the chief architects of the 2012 cost control law. In state budget negotiations, the MHA is urging conference committee members to create an independent oversight board for CHIA that includes representatives of hospitals and "surcharge payers." - Michael Norton/SHNS

UMASS MEMORIAL LINKING WITH URGENT CARE GROUP

UMass Memorial Health Care has teamed up with an urgent care provider that will offer treatment for non-life-threatening injuries and illnesses at three central Massachusetts locations slated to open in July and October. "Patients can often be treated with the same quality of care, and much more quickly, at an urgent care center than in emergency rooms," said CareWell Urgent Care CEO Shaun Ginter in a statement. The affiliation began June 1, according to Thursday's announcement, which said the first urgent care centers affiliated with the hospital group will open July 15 in two Worcester locations. A third location in Northborough is expected to open in October, and other affiliated sites will open in the area over the next year and a half, according to the announcement. "This affiliation will help integrate care by establishing relationships between UMass Memorial emergency departments; primary care physicians and medical specialists, and CareWell Urgent Care providers," said UMass Memorial CEO and President Dr. Eric Dickson in a statement. - Andy Metzger/SHNS

"From Bad to Good"

Overlooked in all the courage of the terrorist shooting in Roslindale last week was the release, on bail, of Sean Ellis convicted of the murder of a Boston police officer. Detective John Mulligan was shot 5 times, in uniform, as he sat in a car in a parking lot where he was performing a paid detail. This will be the fourth trial for this convicted cop killer. BPD Makes Drug Arrest of a Norwood Man at Moakley Park

The Boston Police at recent meetings in the neighborhood had announced that they have every intention of using all the resources necessary to help stem the rising tide of drug use and dealing in South Boston. Though overall crime is down in the neighborhood, as was reported in last week's issue of South Boston Today, the use and sale of illegal and dangerous drugs is on the rise. Overdoses of hard drugs including Heroin are happening more frequently.

BPD sources report that last Saturday, June 6th at 5:45pm, a Norwood man, 23 year old Herbert Small, was arrested for possession with intent to sell Crack Cocaine at Moakley Park in the vicinity of Columbia Road. Neighbors have for weeks been complaining about the ongoing drug dealing at Moakley Park and had asked police to increase patrols there, and they have. The beefed up patrols have been paying off. A search of Small's motor vehicle revealed approximately \$3,500 in cash, which was seized on site and is being held pending an investigation. Another male on the scene was found to be in possession of marijuana and was given a civil citation for holding less than an ounce of the drug.

The increase of the use and sale of illegal drugs is not just happening in South Boston. Law enforcement officials report that it's a growing problem in every Boston neighborhood and is increasing in suburban areas as well. Residents are asked to report any suspicious activity to police who will investigate. If the epidemic of illegal drugs spreading through the neighborhoods is to be stopped it will take the cooperation of neighbors working with police.

Warrant Sweeps Underway – Arrests Being Made

As reported by Fox 25's Sharman Sacchetti, with Amy Lord's murder back in the spotlight and the conviction of her murderer, and the increase in heroin and other dangerous drugs proliferating once again on the city streets, there is a new effort from lawmakers meeting with police, pushing for them to go after offenders who should not be on the streets.

"Some of the worst case scenarios that we dealt with our last couple of years, the tragedies, we want to prevent them," Sate Representative Nick Collins stated when interviewed. Two years ago, in the wake of the murder of Amy Lord and the violent attacks on women in Southie, Collins called on police to round up criminals with outstanding warrants.

On Tuesday he was at the police station in South Boston along with Boston City Councilor Mike Flaherty to push for more sweeps of everyone from drug pushers to violent offenders. "We'd like to see them more regularly done," Councilor Flaherty said.

"It's an ongoing effort anyhow, but we are going to pick it up considerably in the weeks ahead and through the summer," said Boston Police Superintendent Bernard O'Rourke. After the meeting, Superintendent O'Rourke said warrant sweeps are done all the time, but police are stepping it up in the coming weeks. "We're going to target some of the impact players, something we've done in the past as well," Superintendent O'Rourke said.

their International Kiteboarding Film Festival, South Boston Neighborhood House was awarded \$5,000 for family fun nights, Quidditch Club Boston was awarded \$500 for Quidditch on the beach, YES was awarded \$5,500 for Stand-Up Paddleboard instruction, L Street Ice Swimmers was awarded \$1,000 for their cold water swim, and City Point Neighborhood Association was awarded \$1,500 for their Summer Sizzle.

This year's Better Beaches Program grants will fund traditional beach events like free concerts and sand sculpting competitions, family fun nights and beach festivals, including a late season beach party hosted by Boston Mayor Marty Walsh. It will also include a Quidditch tournament, story telling with the pirate Mary Read, a coastal illumination and sand painting by noted California coastal artist Andres Amadore.

Save the Harbor/Save the Bay also announced the expansion of their free **Boston Harbor Explorers** program at DCR's Carson Beach in South Boston, which is now one of the cleanest urban beaches in America. The program will be based at the McCormack Bath House on Day Boulevard, and run five days a week for 8 weeks in July and August.

Activities at DCR's Carson Beach will include free swimming and kayak lessons and beach soccer clinics, as well as environmental exploration, fishing, and art on the shore. Save the Harbor expects more than 2,000 youth and teens from area youth development and community organizations to take part this year.

"The region's public beaches are an extraordinary asset to the residents of Boston's waterfront neighborhoods

and beachfront communities from Nahant to Nantasket" said Save the Harbor's spokesman Bruce Berman. "It was a wicked winter. We want to thank the Department of Conservation and Recreation and the Metropolitan Beaches Commission and all our program sponsors and partners for making this a spectacular summer for the more than 1 million people who live just a short ride or drive from the coast.

Funds to support the **Better Beaches Program** come from the proceeds of the Harpoon Helps Cupid Splash pledge fundraiser, which was held this year on the first snowy Saturday of spring. Over the past 7 years, Save the Harbor's community partners in Nahant, Lynn, Revere, Winthrop, East Boston, South Boston, Dorchester, Quincy, and Hull have leveraged \$205,000 in small grants received from Save the Harbor/Save the Bay with \$815,722 in cash and in-kind contributions from local government and small businesses for a total investment of \$1,020,722 in 214 free events and programs for the region's residents and visitors alike.

Aleman Guilty Of 1st Degree Murder – Mandatory Life In Prison Without Parole

Rejecting his insanity defense, jurors on Monday convicted a Boston man of first-degree murder and kidnapping for the 2013 death of 24-year-old Amy Lord. Prosecutors say Edwin Aleman, 30, attacked and kidnapped Lord — a Wilbraham native living in South Boston — and forced her to withdraw money from several ATMs before stabbing her to death and leaving her body in a park.

Aleman was also convicted on charges related to two other attacks on women in South Boston within 24 hours of Lord's murder. He was acquitted of a charge of assault with intent to rape. Defense attorney Jeffrey Denner had argued that Aleman was not guilty by reason

of insanity. He said after the verdict that it's clear his client has needed mental help for a long time.

"The fury and rage that exploded in one 18-hour period to me is a reflection of just how sick he is," Denner said.

Suffolk County District Attorney Dan Conley says the jury got it right. "He's an angry man. He obviously took a tremendous amount of violence out on Amy Lord," Conley said. "But he is a criminally responsible man. He knew what he was doing." Aleman's first-degree murder conviction carries a mandatory sentence of life in prison without parole. His formal sentencing is set for Tuesday morning.

Gardner Museum Heist Author at the Library

Stephen Kurkjian speaks on his new book *Master Thieves: The Boston Gangsters Who Pulled Off the World's Greatest Art Heist*, an account of the still-unsolved theft of Boston's Isabella Stewart Gardner Museum. It is a case defined by superlatives: the largest art theft in history, carrying the world's greatest reward offer, and one of the FBI's biggest unsolved art crimes.

The principal reporter on the case for years, Mr. Kurkjian will discuss his gripping account of the heist of a quarter century ago, reveal the involvement of two criminal gangs battling for control of the Boston underworld, and the motive for the crime. 

The Boston Red Sox, despite sweeping the Oakland Athletics over the past weekend and finding themselves an ace in the making with 22 year old Eduardo Rodriguez, are at the bottom of the AL East.

Rodriguez threw six shutout innings against his former team, the Baltimore Orioles. He allowed three hits — all singles — walked three, and struck out seven. Rodriguez has allowed one run on eight hits over 20 2/3 innings in three starts, striking

out 21 and walking seven. The Orioles were hitless in six at-bats with runners in scoring position against Rodriguez. He left two runners stranded in the first inning and got a double play to end a threat in the fourth. The fifth inning was when the real work was done.

While the woes continue, on the second day of the major league draft Tuesday, the Red Sox selected three pitchers, two outfielders, a catcher, a first baseman, and a third baseman in their search for gold dust.

The Sox selected three straight pitchers in Rounds 6 through 8. They picked up Ohio State's Travis Lakins in the sixth round, South Alabama's Ben Taylor in

the seventh, and IMG Academy's Logan Allen in the eighth. They spent their ninth-round pick on first baseman Tucker Tubbs, out of Memphis, and their 10th-round pick on third baseman Mitchell Gunsolus, out of Gonzaga.

The Sox started the day by taking catcher Austin Rei, out of the University of Washington, with their third-round pick before adding center fielder Tate Matheny, from Missouri State, in the fourth round. They selected high school senior Jagger Rusconi, who committed to USC commit out of West Ranch (Calif.) High School, in the fifth round.

This week, Comcast SportsNet NBA Insider A. Sherrod Blakely joined the show

DANNY PICARD: Going into the NBA Finals, how did you envision this series playing out when Kyrie Irving was in the Cleveland Cavaliers' lineup?

A. SHERROD BLAKELY: When he was healthy, I thought that Golden State would still win this thing in six games. I liked the fact that Golden State has, what I consider, better balance. They have high impact players at both the offensive end of the floor and defensively. Whereas Cleveland, even with Kyrie Irving and LeBron James being one of the best one-two punches in terms of scoring, defensively, I thought that Cleveland was going to have some issues. As much as we want to talk about the great job that Cleveland did in winning Game 2, you've got to be mindful of the fact that for Steph Curry, it was probably the worst game he has played in the NBA. So the fact that you went to overtime with Golden State's best player having the worst game he's ever had, I'm not sure I'd be feeling all that confident if I'm Cleveland.

DP: You're right, Steph Curry was bad in Game 2. But how much of that also had to do with how Matthew Dellavedova was covering him with some pretty good defense? I

think it was a combination. I think it Curry had a bad night, but also, you have to credit Dellavedova for the defensive performance that he put on, being in Curry's face and all over him the entire game. Are you one to give Delly any credit for that?

ASB: Oh definitely. I definitely give him credit. He did a really good job. He did the job that they assigned him to do, and that's great. But I don't believe he can limit Steph Curry over the course of a playoff series like that. If we're talking about a six, seven game stretch, I think Delly can have one or two games like that, but I don't think he can really limit Steph Curry the way he did in Game 2, over the course of a playoff series.

DP: So you're counting out LeBron in this one. You've already counted him out, the best player in the world. It's over, according to you.

ASB: Absolutely. I said that before this series started. And the reason why, is because as great as LeBron is — and without question, I think he's the best player on the planet and in this series, but I don't believe he can carry this team by himself. I don't believe that he can get enough contributions from his teammates, for the Cavaliers to win three more

games in this series. I can give him one, possibly two more wins. But I don't think they're going to get more than that, because I just think Golden State is too talented, too deep, and they have too many impact players at both ends of the floor.

DP: LeBron says that he has a secret motivation in this series. You have any guesses? I've been trying to sit here this morning and come up with something that we don't already know, and I just can't do it. But since you're on the scene and you cover these teams, I've got to at least ask. Do you have any guesses, as to what this secret motivation is?

ASB: Well I don't know how big a secret it is, but he's motivated by the fact that nobody believes he can win a title without a "Big Three." In Miami, he had Wade, he had Bosh. In Cleveland, for the most part this season, they were rolling along with Kyrie and Kevin Love. Those two guys are down now. Nobody believes that LeBron James can carry a team to win a title, a la Michael Jordan with the Bulls. And I certainly think that is a driving factor for him, a big motivating factor in the way he's putting up video-game like numbers in every one of these playoff games

as of late.

DP: Now, I'm not counting LeBron out of this like you are. Let's say LeBron does take the team on his back and has this "miraculous" run and wins the NBA Championship without those guys, you're right, there's motivation there, because you don't win a better title than that, if you're LeBron James.

ASB: If this season ends, and he's holding the Larry O'Brien trophy, LeBron James will be on the Mount Rushmore of all-time greats, and really, you could make the case at that point, that he may be the best of all time. Because when you look at his team, and you look at the team they're facing, there's no way that Cleveland should win this series, based on the fact of who they're playing, and who they're playing without. If LeBron James can put these guys on his back and get them a championship in a place that has been absolutely dying for a championship for decades, without question, his legacy is cemented. He can't do any wrong after that.
