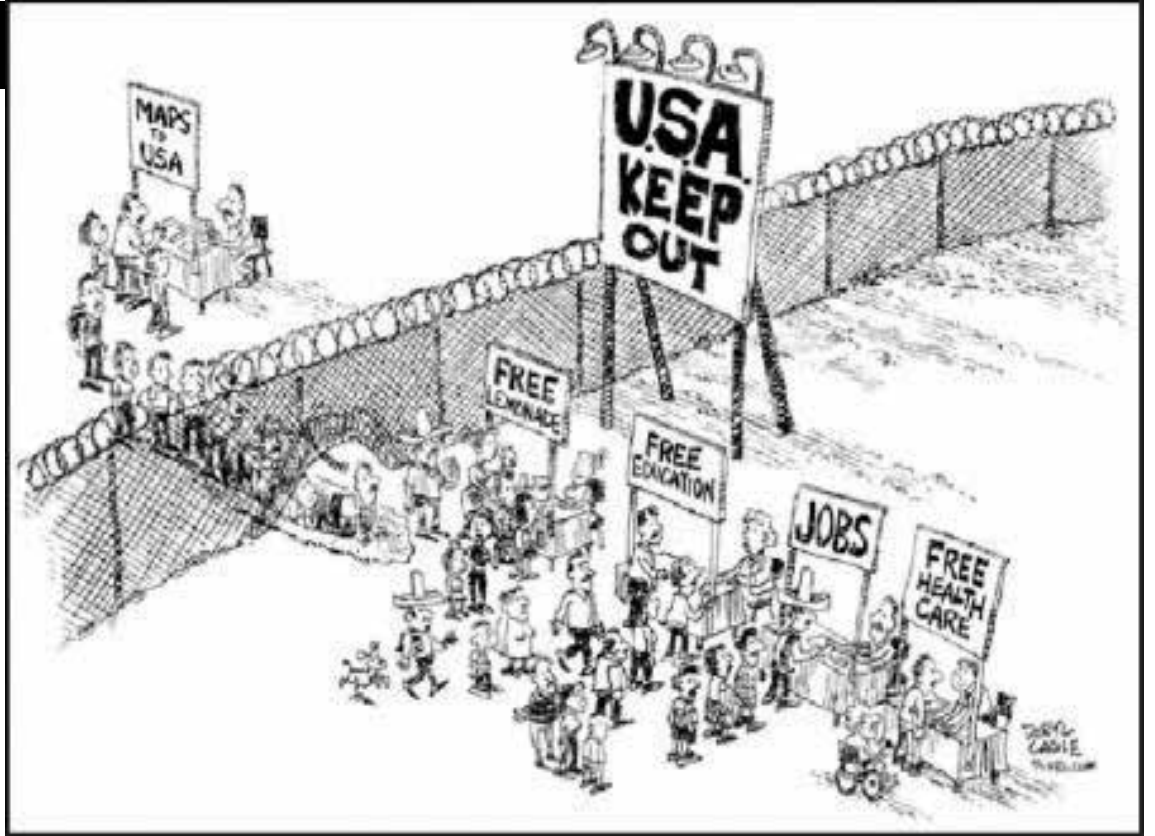
“Honestly”

Gate Of Heaven Neighborhood Assoc. Update

On Tuesday June 23rd the Zoning Board of Appeals went against a majority of the resident wishes and approved the “Old Gate of Heaven” for what else “Luxury Condos!” Even though the Gate of Heaven Neighborhood Association organized opposition to the project, having over 2,000 signatures from people in the parish/community, the condo development was rubber

stamped for approval. In addition, over 100 signatures were direct abutters of the school.

Representatives of City Councilors Mike Flaherty, Michelle Wu and Steven Murphy, State Senator Linda Dorcea Forry, State Representative Nick Collins and Suffolk Superior Clerk, Michael Donovan spoke in opposition to the project. Representatives of only two elected officials spoke in favor of the

luxury condo development, specifically City Councilor Bill Linehan and Mayor Marty Walsh.

The 75 people that were with the Gate of Heaven Neighborhood Association wished they all had a chance to speak. The Zoning Board only allowed 5 people from the community to speak in opposition. After 5 impassioned speeches from the Gate of Heaven representatives, the Zoning Board quickly gavelled through a unanimous vote in favor of the luxury condo development.

One glaring statement that stood out and had many of the Gate of Heaven people shaking their heads in disbelief was with Mayor Walsh’s representative Jerome Smith’s statement: “that the Mayor’s Office knew of no viable school interested in the building.” This left many people in disbelief that the Mayor’s Office would make such a statement when the Mayor and members of his administration had been in communication with Gate of Heaven Neighborhood Association and the interested charter school and knew just the opposite to be true. There is no way the Gate of Heaven Association would have gone through this much effort, if that wasn’t the case.

The hearing ended abruptly with many members of the community in complete disgust with the entire process. The people’s voices were not recognized. The people from the community thought the days of City Hall rubber stamping projects for favored developers were over. What we witnessed was “the same old same old” that has been going on for over 20 years in the City of Boston. We witnessed a travesty of the democratic process and witnessed misrepresentations spoken on behalf of the Mayor’s Office.

The Gate of Heaven Neighborhood Association will be moving forward, as we have hired an attorney to challenge the Zoning board of appeals decision in Superior Court. The variances that were granted did not meet the law’s requirements to obtain such variances, so we do expect to be successful. Thanks for all your support! And remember “Kids Before Condos!”



Bill Filed To Limit Road Races In South Boston

State Representative Nick Collins testified before the Joint Committee on Environment, Natural Resources and Agriculture on a bill which would limit the amount road races in South Boston. As written, the bill limits the number of special use permits the Department of Conservation and Recreation (DCR) may issue for road closures on Day Boulevard to four per calendar year. Equally important, the bill requires that those four special permits to be issued to individuals or entities who have a direct impact on the South Boston community.

“I have heard from residents loud and clear that road closures along Day Boulevard have been a quality of life issue for the neighborhood for quite some time,” said Rep. Collins. “I have worked with my colleagues at DCR to scale back on these closures in recent years, but this bill would provide much needed relief to the community by capping the number of road closures while ensuring that any event requiring road closures has a direct relationship with the South Boston community.”

The bill is now under review by the Joint Committee on Environment, Natural Resources and Agriculture.

Former Boston Uber Driver Linked to South Boston Serial Assaults

Suffolk County District Attorney Daniel F. Conley, State Police Colonel Richard D. McKeon, and Boston Police Commissioner William B. Evans today announced the identification of a suspect in a series of previously-unsolved sexual assaults on the Esplanade and in South Boston.

Authorities today obtained warrants charging ALEJANDRO DONE (D.O.B. 9/13/86) of the South End with rape in connection with a series of sexual assaults on

the Esplanade and in South Boston between 2006 and 2010. Done is currently held without bail pending trial in Middlesex County for a sexual assault in Cambridge and will likely be arraigned on the Suffolk charges later this week.

“Late yesterday, based on evidence gathered in the course of the Middlesex County investigation, State Police criminalists advised us of a DNA match connecting four of the South Boston and Esplanade attacks with Done’s open case out of Cambridge,” Conley said.

Boston City Council Hearing On Sidewalk Signs

The Boston City Council’s Special Committee on Small Business, Entrepreneurship & Innovation has scheduled a hearing to discuss free-standing sidewalk signs, sponsored by Councilor Michael F. Flaherty. The hearing will take place in the City Council Chambers on July 23, 2015 at 2:00 pm.

The hearing comes in response to the confusion around the varying regulations that govern free-standing sidewalk signs in current zoning code. The City of Boston zoning codes for such signs differ based on neighborhoods, business districts and sub-districts.

“Several small and local businesses have been cited for using sandwich board signs, which they have found to be a significant marketing tool for increasing sales in a competitive urban climate,” said Councilor Flaherty. “I hope this hearing will bring some clarity to the rules of signage and address content, placement, size, and safety across Boston’s diverse neighborhoods and business districts.”

After surviving a harsh winter in which many small and local busi-

nesses across the city were negatively impacted, business owners have been looking for creative ways to advertise their products and services to the surrounding community. “We need clear guidelines that allow our small business districts to thrive while protecting accessibility,” said Councilor Wu, who chairs the Special Committee on Small Business, Entrepreneurship & Innovation. “As a former small business owner, I know how effective sandwich board signs can be.”

Councilor Flaherty plans to include several city departments in the conversation about sandwich board signs, including Boston Transportation Department, Code Enforcement Division of Public Works, Inspectional Services Department, Disabilities Commission, and the Main Streets program within the Department of Neighborhood Development.

The Special Committee on Small Business, Entrepreneurship & Innovation encourages members of the public and local business owners to provide insight and participate in the discussion.

The identification of a suspect marked a major break in the investigation into a series of sexual assaults linked by DNA evidence and what Conley called an “unmistakable pattern” – assaults that targeted lone women walking late at night during the summer months, primarily on weekends, in the vicinity of Old Colony Avenue or along the Esplanade. The victims described a man whose height, weight, and appearance were consistent over a period of years.

“Despite a dragnet of investigators pursuing every possible lead in and out of Massachusetts, the assailant evaded detection – until now,” Conley said.

The linked attacks were:

1. Early morning of July 29, 2006, in Joe Moakley Park
2. Late night of June 16, 2007, along the Esplanade
3. Early morning of July 29, 2007, along the Esplanade
4. About midnight on July 13 into July 14, 2009, along the Esplanade

5. Early morning of June 13, 2010, near Preble Circle

The case was investigated by a task force of investigators that included Suffolk County sexual assault prosecutors, the Suffolk County State Police Detective Unit, and the Boston Police Sexual Assault Unit.

“Thanks to their work, this unknown assailant finally has a name,” Conley said. “He has a face. And he’s behind bars.”

Sexual assault can happen to anyone. While the victims of any crime are asked to call 911 in an emergency, the survivors of sexual violence in Suffolk County can also call the Boston Area Rape Crisis Center’s 24-hour hotline at 800-841-8371. The Boston Area Rape Crisis Center provides medical advocacy, legal services, counseling, and other services to victims of rape and sexual assault.

All defendants are presumed innocent until and unless proven guilty beyond a reasonable doubt.

"As a member of the Metropolitan Beaches Commission, I'm happy that such great programs are available for the public," said Rep. Nick Collins, who represents South Boston. "I'm looking forward to seeing what Marielle and Leonardo will put together and hope that people will come by Carson Beach to see their great work and enjoy our local beaches."

Abe Waterman of Prince Edward Island, Morgan Rudluff from California and Kevin Crawford from Australia will be on DCR's Wollaston Beach in Quincy sculpting a 20-ton Sand Castle.

This year the Revere Beach International Sand Sculpting Festival will be held on Friday, July 24 and Saturday, July 25 from 10:00 a.m. to 10:00 p.m. and from 10:00

and others are attempting to leverage the prospects of the Olympics as the catalyst for having uncomfortable conversations about the long term future of the City’s neighborhoods with some characterizing it as a legacy play.

But, for South Boston in the short term, the community has to deal with road races, Grand Prix races the next several years, hotel developments, a BRA sponsored ‘growth corridor’ initiative, the conversion of public housing to mixed income housing, the lack of a public policy on middle income housing, the expansion of U Mass Boston, and other development situations. On a political note, for example, given the rate of

development of high rises in the South Boston Waterfront, the influx of new residents could cause a reconfiguring of precincts and districts based purely on population growth.

The role of the neighborhood civic organizations as a result will, by default if not vested interest, be more critical as local watch dogs. The BRA is managing any number of initiatives city wide from Brighton to South Boston and Charlestown to West Roxbury. In the heart of Boston from Dorchester through Roxbury and Mattapan to Hyde Park, transit housing is the buzz word and civic groups are on top of things there as evidenced by the role of the Dudley Street Neighborhood Initiative’s ‘development without displacement’ program and the success of Viet Aid’s

affordable housing programs.

One initiative that needs vigilance is the BRA’s “growth corridor” program. The BRA website indicates that “in South Boston, the Dorchester Avenue corridor from Andrew Square to Broadway Station is undergoing a shift away from traditional manufacturing and industrial uses, as demand for residential and mixed-use development increases. For example, the BRA is reviewing a proposal for 235 Old Colony Avenue that would create several hundred apartments and retail stores on former industrial sites. Situated between two major Red Line stations and bus hubs, the corridor is ripe for transit-oriented development. The goal of the South Boston study will be to create new zoning that aligns the aspirations of the community with predictable development conditions.

Based on resounding feedback from neighborhood residents and South Boston’s elected officials, Mayor Walsh has asked the BRA to work with the community so that any new zoning recommendations maintain the character of this residential district

and place a renewed emphasis on architectural continuity. The BRA is soliciting nominations for two advisory groups to help guide the public process and provide a wide range of stakeholder input for each study area. Elected officials, community organizations, and residents are encouraged to nominate individuals. Community meetings are expected to begin in late July in both study areas. The BRA is taking a more creative approach to public engagement than it has in the past. In addition to traditional town-hall style meetings, there will also be “walk-shops,” where participants will be invited to tour the study areas with BRA planners, and other interactive planning exercises.”

Civic Groups from Andrew Square to West Broadway to Fort Point to City Point must be vigilant and engaged. Commercial and Industrial property owners will be on guard. Widett Circle is also on a transit corridor. They are not talking about a zoning change of 2 to 4 units, they are talking wholesale neighborhood creation. This is serious business for everyone.

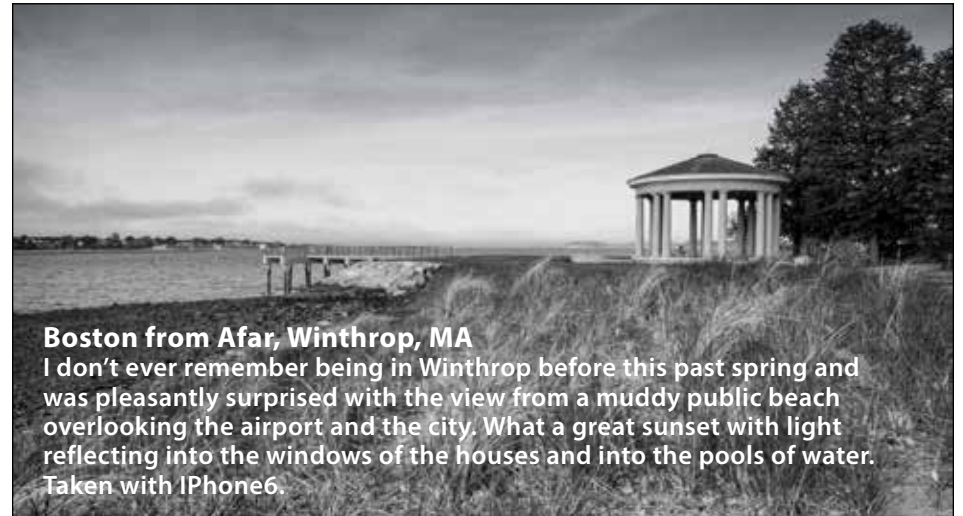

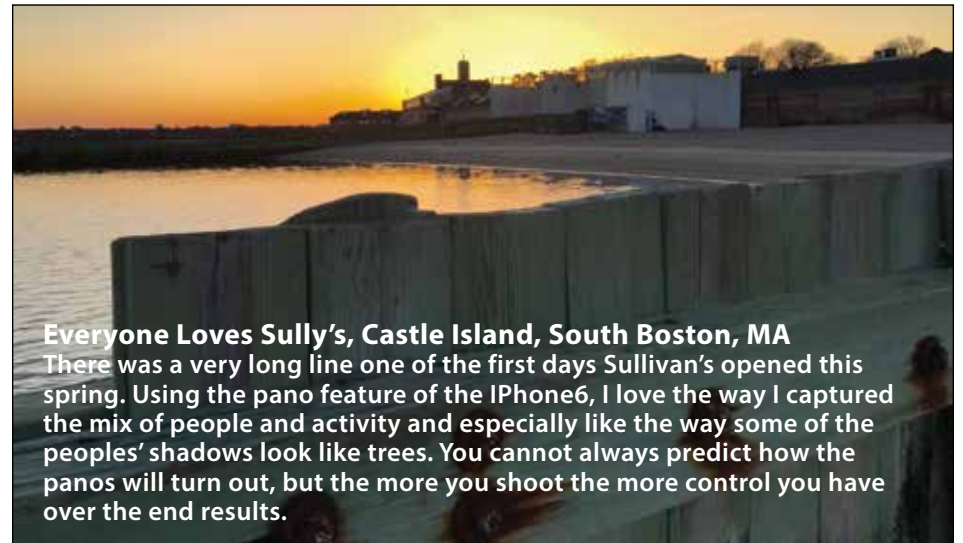
Gone Fishing, South Boston, MA

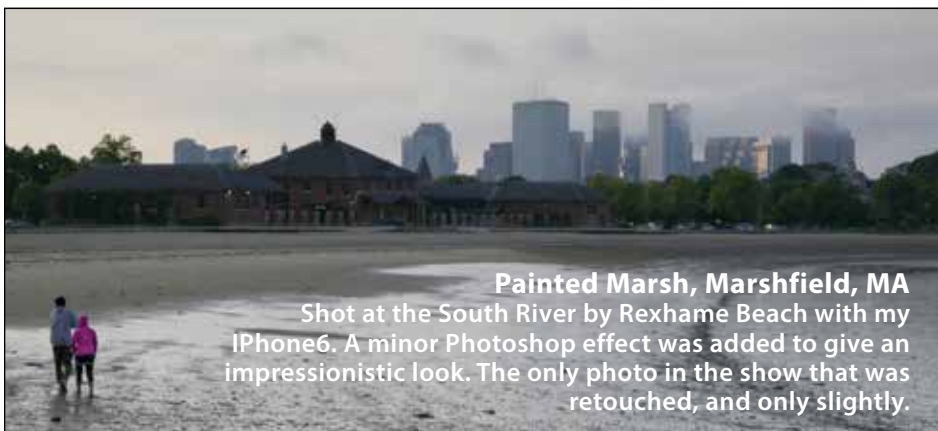
Boston from Afar, Winthrop, MA

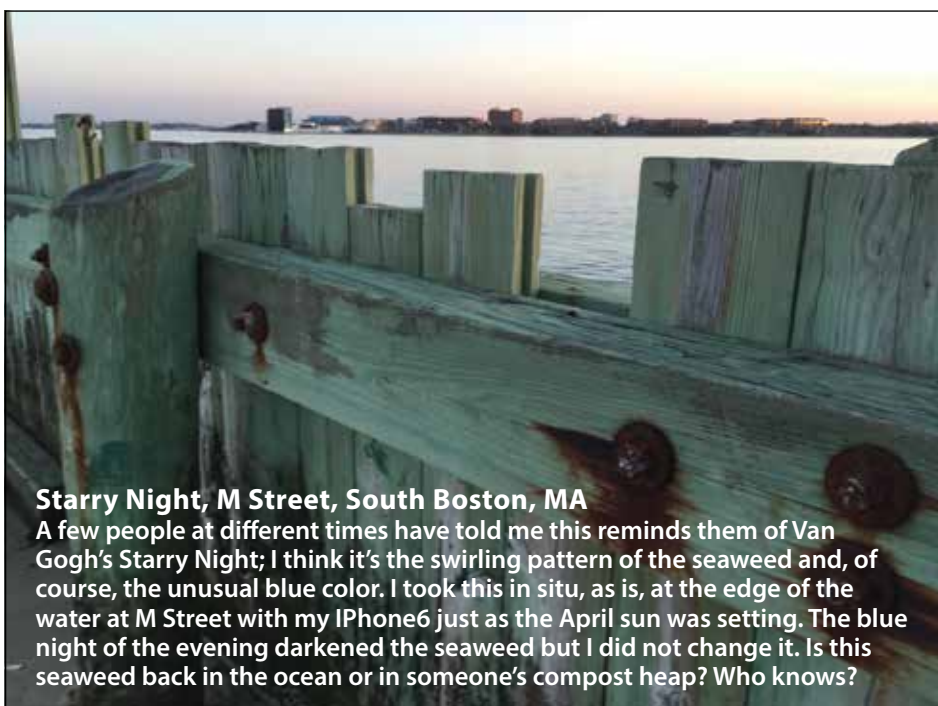
Everyone Loves Sully's, Castle Island, South Boston, MA

Jordan Spieth Is Everyone's 21 Year Old Son, Grandson, Brother

Grandmothers, mothers and sisters are loving Jordan Spieth. Professional golfers, while offering varying degrees of praise, are still trying to figure out how to compete with him this year. Not only is his game solid, the gods seem to be with him. Dustin Johnson 3 putts, Danny Lee incurs a penalty stroke and Tom Gillis duck hooks into the water on the second playoff hole.

There was no escaping Jordan

Spieth even before he arrived Monday at St. Andrews to resume his pursuit of golf's Grand Slam as the Associated Press reports. Behind the practice range, one British television network talked to any player willing to stop. After a few gratuitous questions about the weather (cool and cloudy) and the Old Course (magnificent shape), the reporter got to the point. What about Spieth's chances? "The odds are against him," said Soren Kjeldsen,

relying entirely on history.

Spieth is only the fourth player since 1960, the year Arnold Palmer proposed the concept of the modern Grand Slam in golf, to win the first two majors of the year. Each of the previous three saw his run stopped at the British Open. Palmer (1960) and Jack Nicklaus (1972) finished one shot behind. Tiger Woods was in good position in 2002 until he was blown away by the wind and rain at Muirfield and shot 81 in the third round.

Spieth only added to the hype by winning the John Deere Classic in a playoff Sunday for his fourth victory of the year. He flew on a charter flight from Illinois with other players at the John Deere Classic, arriving in Scotland about 10:30 a.m. and checking into a house before coming out to the Old Course to a quiet reception. Spieth and his manager walked through a group of about 100 fans who camped out near the entrance to the player lounge to get his autograph. Spieth signed everything shoved his way, turned and tossing the last item to a delighted young British boy.

The jet lag apparently wasn't an issue Monday. Spieth said he planned to hit balls and play nine holes if he felt up to it. He wound up going 18 holes with Woods right behind him. Woods used to tee off before breakfast, but waited until afternoon when most of the drizzling weather cleared out. They chatted briefly on the 16th green, and Spieth had some fun on the Road Hole at No. 17. He hit three shots out of the famous bunker, all of them onto the green. Then he headed toward the stone wall behind the road and asked a few fans still left, "Can you play it off the wall?" "I didn't come here to play boring golf," Spieth said. He tried it four times, and didn't reach the green with any of them.

"He beats you with better golf," Geoff Ogilvy said of Spieth. "He doesn't beat you because he hits it further. Tiger's intimidation was that he always did something amazing. Jordan -- don't get me wrong, his body of work is amazing -- but he doesn't beat you with a crazy par, or a crazy chip-in from the back of the 14th at Muirfield Village. He just beats you because he's better."

With his victory at the John Deere Classic, Spieth is within range of his goal of reaching No. 1 in the world. He would have to win the British Open this week to get past McIlroy, who is out with an ankle injury with no clear indication when he will be able to return.

The R&A put Spieth in the same group with Dustin Johnson and Hideki Matsuyama for the opening two rounds. Johnson had a 12-foot eagle putt on the final hole at Chambers Bay to win the U.S. Open in June. He three-putted for par, and Spieth was halfway home to the Grand Slam. More than the Old Course, the real challenge is the players Spieth has to beat.

Regardless of what happens, millions of fans, including grandmothers, mothers, sisters and maybe a few single and eligible young ladies will be among them watching this weekend. Corporate sponsors and the game of golf itself must be very, very happy.

DANNY PICARD: It's the MLB All-Star break, and the All-Star game obviously means something to the teams that have a shot to get to the World Series. One of those teams is not the Boston Red Sox. Or at least, that's how I feel. And at the break, the Red Sox are in last place in the AL East, 6.5 games behind the first-place New York Yankees. The Red Sox lost two-of-three to the Yankees over the weekend at Fenway. A lot of people are talking about what went down on Sunday, with David Ortiz being sent home due to an illness. And I've been kind of shocked as to how much heat I've been taking for defending Ortiz. How do you react to this Ortiz story, with him not only being unavailable on Sunday against the Yankees?

MIKE GIARDI: I think there are a lot of people who decided to turn that into the narrative and the talking point for this week and the slow news days. I mean, to me, David Ortiz is certainly not without his flaws. I think we've all come to see those during his time here. But if you're going to tell me that Ortiz was disgruntled because he didn't want to play first base, and that's why he went home, I don't buy into any of that stuff. If Ortiz

could have played, he is and always has been a gamer, and if he could have been on the field, I think that he would have been there. And I just think, honestly, I think people are just trying to come up with something to talk about this week, and they're not happy with this baseball team. They've underperformed, considering their payroll. And I think there are just grumpy people that are looking to find something wrong. And quite frankly, from a media standpoint, they're looking to latch onto something that will carry them until the Red Sox are playing again.

DP: Yeah, because that is just people making up a conspiracy theory, right? People try to tell me that David Ortiz showed up to the clubhouse on Sunday, saw his name on the lineup card playing first base — and as we know, he spoke out a couple days ago and doesn't want to play first base. And you know what Mike, I don't blame him, because he's not a first baseman, even though that's the position he sometimes plays.

MG: That's the thing people don't see. When you look at baseball, and you look at that position and say, "Well that's the easiest position to play, other than DH, because you don't

have to move a lot." Well, no, you do have to move a lot. And his body isn't built for that anymore. His body hasn't been built for that for five or six years. And anybody who covers this team and is around him on a daily basis, when he has to play first base he'll say he's sore, he's hobbling around after a couple days. It just doesn't fit for him, it doesn't work for him. It's one thing when it's if you're lucky enough to get into the World Series, and you have to play a couple games without a DH. But when you're talking about this scenario in an American League park, you're talking about a guy now at an advanced age, I just think it's foolish, it really is.

DP: And look, he plays first base because, like you said, when you're in a National League ballpark, you need Ortiz' bat in the lineup. There's no DH when you're there, so you need to put him somewhere. And you're not going to put him at second base, you're not going to put him at third, you're not going to put him at shortstop, you're not going to put him in the outfield. So first base is the only place you can actually put him and think, "Well, this won't be terrible." He's not a first baseman. But all of this first base stuff, people are trying to tell me that Ortiz

showed up to Fenway on Sunday, saw his name on the lineup card at first base, and then just left the building. I'm sorry, I can't buy in to that happening.

MG: Yeah, and I know that when you look at this year, one of the big questions is, "Does John Farrell have control of the clubhouse?" Well, Ortiz and Farrell have a good relationship. And because David complained about having to play first base, I didn't even regard it as complaining. I just regarded it as him being honest. And we want our guys to be honest, except when we don't want them to be honest. And this is one of those cases where he spoke and he was being truthful, and then we crucify him for being truthful, which is why, if I'm an athlete, I would stick to cliches because I can't trust people who have power to put it in the right context, instead of making it into this big thing which it really isn't. I appreciated his honesty. And he didn't tell me anything that I didn't know. Again, this is just a whole lot of searching for something to bitch about at this point of the year, because the team is under performing.
