



Boston Police Dealing With Summertime Crime

Two robberies that have local residents wary are under investigation by Boston Police. Back on June 22nd, a home on the 800 block of E. Fifth Street was robbed and semi-ransacked in the evening during the brief time that residents went out for a walk around the neighborhood. The occupants of the home left for their walk at 7:40 pm on this warm summer night and returned at approximately 8:45pm to find they had been robbed by one or more persons, who entered through the back door that residents say was locked when they left.

The B&E was a rarity for this area and had neighbors on the street

Action Required!

How many audits does it take to straighten out the BRA? It's not about the people at the BRA, it's about the governance. Do these two new board members represent true transparency?

Will the audit uncover and admit to how and to whom the community benefits money, earmarked for various communities - South Boston in particular where the lion's share of development has been occurring - has been spent and on what? Does the Mayor mean it when he says that the process will be conducted openly with the best

interests of the City, its people, its history, its economy and its future at the forefront?

Will developers spend their time and money planning to squeeze every square inch of land and air rights in order to turn profit into bonanza? Will they play fair or use consultants to badmouth competitors in order to better position their project since the playing field may be evened out? Will they have to hire insiders in order to get permits and zoning variances? Are the building trades and other unions that will benefit from the building boom going to continue to be reasonable

partners in the development process or will they leverage their obvious relationship with the Mayor to excess?

The late Mayor Tom Menino played a heavy hand with the BRA according to the audit(s). Mayor Marty Walsh is trying to play with an even hand. Experience tells us that is a risky approach fraught with uncertainty. If the ground rules put in place make the process fair and the process runs its course, then someone has to be decisive in the end. That is when the Mayor has to take decisive action. That's his job and that's what the public is paying him for.

Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

What's up

Labor groups plan to ask state pension fund managers to divest from oil, coal and gas companies, a goal of environmentalists that has concerned representatives of public employees who rely on the fund to produce retirement checks at the Pension Reserves Investment Management (PRIM) Board's Investment Committee meeting...Revenue Committee held a public hearing on a range of other bills addressing the sales tax ... The newly created MBTA Fiscal and Management Control Board held its first meeting this week to establish the role of the board, set board bylaws and determine its meeting schedule.

Time to make the sales tax holiday permanent, or semi-permanent

The sales tax holiday has been approved 10 of the last 11 years. Shoppers seem to love it. Retailers seem to make the most of it. For a brief weekend, it levels the playing field for retailers with New Hampshire and the Internet, diverting sales to local retailers to the tune of \$168 million. And yet every year, there is a Groundhog Day feel to the approval of the sales tax holiday. Not necessarily substantive debate. Only unnecessary delay, giving retailers limited time to market the tax holiday.

It stands to reason that if the

tax holiday were a reliable thing, rather than a year-to-year exercise, it would generate more benefit. Shoppers could plan, and forestall that Internet purchase or trip to the Granite State. Isn't it time to codify the sales tax holiday as a real holiday that we can put in the calendar and count on? Or pass a law to make it eligible for renewal every four years? That way we could see if giving the holiday a longer lead time generates more business for retailers.

Lynch would not picket DeLeo

Congressman Stephen Lynch, big-time union guy, was asked by Jim Braude on Greater Boston last night: Is organized labor wrong for (thinking of) picketing Bob DeLeo? "Yeah. Bob DeLeo is a good man. I would not have been picketing Bob DeLeo, that's for sure." On Sunday DeLeo told Jon Keller on Keller at Large that he was "disappointed" that unions were considering picketing a fundraiser he was planning to attend soon for Boston state Rep. Michael Moran at Carrie Nation, a restaurant on Beacon Hill.

Massachusetts: the high-debt state

The Commonwealth ranks 48th in the nation in fiscal solvency -- a ranking of states' structural deficits, long-term debt, and unfunded pension liabilities. The state's long-term liability per capita, for example, is \$5,947, more than double the national average. Indeed, Massachusetts traditionally has loved to borrow, and indeed, Commonwealth has a structurally unbalanced budget. Commonwealth's Gabrielle Gurel details the report, produced by the Mercatus Center at George Mason University, with some people saying it isn't as bad as it seems.

surprised. Speculation is that it could have been someone living close by or perhaps someone who was watching for an opening, which came when the husband and wife left for their stroll. Rooms were left in disarray and items of value were taken from the home.

On July 11th, two local women were walking together in the area of K and E. Eighth Street at approximately 2:45 am when a white car pulled up and the occupant, described as a black male, is said to have jumped out, pointed a semi-automatic handgun at them and demanded their handbags. The robber took the bag, got back into his car and sped away. Police sources say that though incidents like these are common in some other parts of the city, they are rare occurrences in South Boston as streets here are comparatively safe, day and night.

There are possible suspects being considered in the June home break-in, but as of yet, no arrests have been made in either incident. That the July armed robbery occurred early on a Saturday morning should be a cautionary warning to young women, even in a pair, who are out that late, to be prudent about their transportation options.

The investigations are ongoing and if more details are made available, South Boston Today will report on them and we will keep in touch with local police with periodic inquiries. Its crimes like these, however rare here, that have police continuing to urge local residents to call 911 to report any and all suspicious activity in your areas. Cooperation between law enforcement and private citizens is what contributes to keeping our streets as safe as possible. Working together helps maximize the protection and wellbeing of the people of South Boston and other communities.

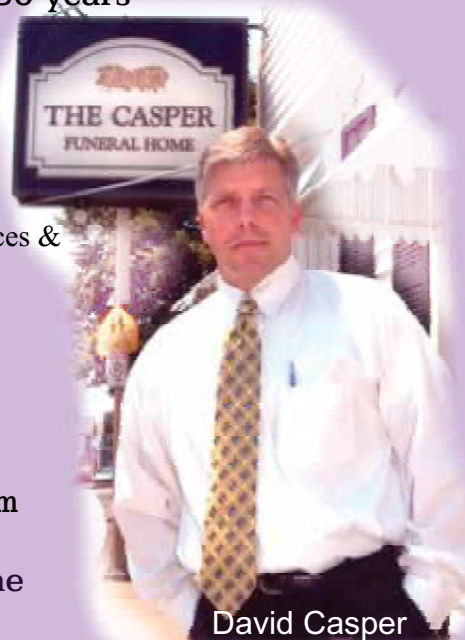

REP. COLLINS PARTNERS WITH STATE TREASURY

Rep. Nick Collins is working with State Treasurer Deb Goldberg to notify South Boston residents who have unclaimed property and assets. “We are excited to work with the legislature to reunite constituents with their unclaimed property,” said Treasurer Goldberg. “This partnership is part of our continued efforts to raise awareness about unclaimed property in local communities all across Massachusetts.”

“There are over 2,000 residents and businesses in South Boston with unclaimed money, property and assets” said Rep. Collins. “I am happy to work with Treasurer Goldberg and her staff to get this money back to its rightful owners.” Unclaimed property can take the form of uncashed checks, forgotten checking and savings accounts, stocks, dividends, insurance policy proceeds, and contents of abandoned safe deposit boxes.

Any citizen who is currently owed more than \$250 worth of unclaimed property will receive a letter with specific instructions on how to reclaim their property. Most accounts are considered abandoned and are turned over to the Commonwealth after three years of inactivity. For more information regarding unclaimed property, you can contact Rep. 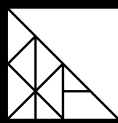

Last week, in the face of 2000 signatures and polls that showed 85% of residents in opposition, the Boston Zoning Board of Appeals voted in favor of allowing a controversial developer to build luxury condos at the site of the old Gate of Heaven School building. These politically connected developers received strong support from Mayor Walsh and even our city councilor, Bill Linehan. With the exception of the aide to Mayor Walsh and an aide to Councilor Linehan, not one person spoke in favor of the luxury condo development.

Over the past year, the Gate of Heaven Neighborhood Association met and talked with school officials about relocating a charter school to the location. Several schools expressed their strong support in moving to South Boston. However, at the ZBA hearing, a political aide to Mayor Walsh denied that a school was ever interested in moving to this site. Government assistants who shill for developers had been doing the same thing under the Menino administration for two decades. Looks like nothing has changed.

Alleged Serial Rapist Held Pending Dangerousness Hearing

An alleged serial rapist who eluded capture for nearly a decade has been ordered held without bail pending a dangerousness hearing next week, Suffolk County District Attorney Daniel F. Conley announced.

Alejandro Done age 29 of the South End was arraigned in South Boston Municipal Court today on one count

of aggravated rape and two counts of assault and battery in connection with a 2006 sexual assault in Joe Moakley Park. At the request of Assistant District Attorney David Deakin, Judge Michael Bolden ordered Done held without bail pending a dangerousness hearing under Ch. 278, Sect. 58A, of the Massachusetts General Laws, which allows a judge to hold a defendant accused of certain offenses without bail for up to 90 days pending trial upon "clear and convincing evidence that no conditions of release will reasonably assure the safety of any other person or the community."

That hearing is scheduled for July 27.

Done is next scheduled to appear in

Boston Municipal Court on Thursday for arraignment in connection with a subsequent assault that occurred on the Esplanade on July 29, 2007. The July 29, 2006, attack was the first in a series of assaults in which Done allegedly targeted women walking or jogging alone late at night, primarily on weekends, during the summer months. Deakin told the court that in the 2006 assault, Done allegedly approached a 30-year-old woman walking along Day Boulevard and violently assaulted her. The victim was able to provide Boston Police with a description of her assailant and underwent an examination during which DNA evidence was collected.

State Police criminalists recently matched that DNA profile to Done, who was arrested last year in another sexual assault in Cambridge. He is currently held without bail while that case remains pending in Middlesex County. Done may also face charges in connection with similar assaults committed on the Esplanade on June 16, 2007, and about midnight on July 13 into July 14, 2009, and an attack near Preble Circle on June 13, 2010. Anne Kelley-McCarthy is the DA's assigned victim-witness advocate. Done is represented by Tim Bradl.

All defendants are presumed innocent until and unless proven guilty beyond a reasonable doubt.



Councilor Baker Calls for Prohibiting the Sale and Use of Synthetic Marijuana

This week, Boston City Council considered an ordinance, filed by District 3 Councilor Frank Baker, that would ban the sale and possession of synthetic marijuana in the city. Synthetic drugs are a growing problem among young people across the country. According to the Office of National Drug Control Policy, one in nine 12th graders in America reported using synthetic cannabinoids in the past year. In Massachusetts, synthetic marijuana is often sold in gas stations, convenience stores and smoke shops.

"It is my hope this ordinance will give the Boston Police Department the authority to implement and enforce the prohibition of the possession and sale of any type of synthetic marijuana," Baker stated. According to the ordinance, synthetic cannabinoids can be

extremely dangerous. These synthetic drugs, often referred to as 'Spice' or 'K2,' can lead to several side effects including agitation, seizures, hallucinations, higher blood pressure and suicidal thoughts. Synthetic cannabinoids have been linked to hospitalizations and overdoses in New Hampshire and New York.

President Obama attempted to regulate several strains of synthetic marijuana as a part of the FDA Safety and Innovation Act of 2012, but manufacturers continually alter the compounds to produce new, unregulated synthetic drugs. The proposed ordinance would broaden the definition of synthetic cannabinoids, in an effort to prohibit current and future strains of the substance. If the ordinance is passed, any business found selling synthetic drugs will be fined \$300 for each day a violation occurs and if a person is found to be in possession of the drugs, a fine will be given and the substance will be confiscated and destroyed by the Boston Police Department.

"As a father of two young children, I want to see the end of dangerous designer drugs in our communities," said Baker. "These drugs are killing people."

State Police Presence Keeping Local Beaches Safe and Fun

When the weather heats up, especially on weekends, South Boston's beaches fill up fast. The Lagoon/Pleasure Bay, with its constant high tides thanks to the locks on the causeway gets crowded. This is the place where so many local families gravitate too. Carson Beach at or around the McCormack Bath House gets a decent crowd too, often because of its close proximity to the MBTA. But the area that is more often than not, thick with beach goers is the section between M Street and O Streets. Some of the visitors call it 'Southie Beach', but its real name is M Street Beach.

Several years ago, it was at M Street Beach that numerous complaints were generated due to heavy drinking of alcohol, dogs allowed to run without leashes and overall rowdiness that at times, disturbed and even frightened families, especially those families with small children. But that seems to have changed – for the better.

On any given day, especially on warm, sunny Saturdays and Sundays when the crowds can only be classified as massive, a consistent Massachusetts State Police presence is obvious and deliberately set up in plain sight for all to see. Because of this, the number of 'Red Solo Cups' is very much

diminished. Police, at the request of many members of the community, stand ready to move in on public drinkers, especially if they begin to get out of hand. This has brought a large degree of added tranquility to this beach and seems to be appreciated by local beach goers as well as visitors.

Now M Street Beach is enjoyed by all ages and everyone seems to be fine with this. Young adults gather in their groups while families do the same. The pressure treated wooden fence that separates the Curley Recreation Center and M Street is again often used as a spring board for local teens sharpening their diving skills, just

City Announces PARKBoston App

The City of Boston today announced that the ParkBoston app is now live through Back Bay, Fenway/Kenmore, Downtown, Beacon Hill, the North End, the West End and Charlestown, and will be active in South Boston, the South End, Mission Hill, Allston and Brighton by the end of the summer. The app allows drivers to quickly and easily remotely pay a meter with their mobile phone, avoiding the hassle of finding quarters or running back to the meter to add more time before it expires.

“The ParkBoston app is one of the many ways we’re making city

government more efficient and effective for Boston’s residents and visitors,” said Mayor Martin J. Walsh. “More and more of our drivers are taking advantage of ParkBoston and we’re excited to be able to expand into even more neighborhoods by the end of the summer.”

Earlier this year, following a successful pilot in a portion of the Back Bay, Mayor Walsh announced that the City’s over 8,000 metered spaces will be outfitted with the ParkBoston app. During the pilot, the Boston Transportation Department has worked closely with Passport, an indus-

try leader in mobile payments, to design a smooth and seamless parking experience for users. Over the last month, there has been a steady increase in daily transactions through the app, from 3,000 per day in late June to over 4,000 per day by mid-July.

Smartphone users can take advantage of the new service by going to park.boston.gov to create an account. iPhone and Android users can also get the free ParkBoston app through the App Store or Google Play. A pay-by-voice option is also available for those without web-enabled phones. To learn more, please visit park.boston.gov.

The pilot phase of Park Boston was supported by the Mayor’s Office of New Urban Mechanics, Mayor Walsh’s civic innovation team. Identifying and implementing ways to improve Boston’s streetscape for pedestrians, cyclists and drivers is one of the office’s core areas of focus. Recent collaborations with the Boston Transportation Department have included the TicketZen app to make it easier to pay parking tickets, a data partnership with Waze to improve traffic flow, and vehicle sideguards pilot that led to the a nation-leading safety ordinance for large vehicles performing city contracts.



Sheriff Tompkins Kicks Off 2nd Summer Enrichment Program

Suffolk County Sheriff Steven W. Tompkins kicked off the Speaker Series of the Department's Summer Enrichment Program this month. This initiative was implemented by the Sheriff in 2014. "This program was conceived with several purposes in mind," said Sheriff Tompkins. One purpose is "the opportunity that it presents to connect young people with positive role models

to help them along in their desire to become law enforcement professionals. I also wanted to offer students in Suffolk County summer employment. Too often we hear about the need for more job opportunities for our young people, particularly during the summer months when schools are closed and youth violence is typically on the rise. This is an example of what we can do to be

part of the solution."

Designed for students interested in law enforcement, the program operates as a paid internship for 26 Suffolk County high school juniors and seniors. Through providing a hands-on experience to learn about the inner working of the criminal justice system, this program also fosters a positive relationship between youth and the uniform officers who serve their communities. The program runs three days a week for seven weeks, beginning on July 6th and ending the week of August 17th. Participants recently earned their CPR certification and received a certificate of completion, as well as transferable job skills that they can utilize in their future careers.

Samantha Harrington, a Summer Enrichment Intern and student from Revere spoke about her interest in applying to the program. "I really wanted the opportunity to speak one on one with people who work with the criminal justice system for a living and dedicate their whole lives to the field. I applied so that I could be making connections and meeting people." Through job shadowing, weekly presentations by members of law enforcement, roundtable discussion, law enforcement-related

field trips and educational tours the interns will gain the opportunity to learn about multiple organizations and network with people from their particular field of interest.

Sheriff Tompkins joined the Summer Enrichment students as their first speaker during the series to introduce them to the field of criminal justice, his path to becoming Sheriff and to congratulate them for being chosen through the application process. "I don't believe in coincidence and chance, we have to make our own opportunities which is why you are all here, to make opportunities," said Sheriff Tompkins.

Following the Sheriff's discussion, Summer Enrichment Intern Christian Robles from Boston had this to say, "This is a great program for youth that actually want to go into law enforcement because it gives you a lot of insight. As a minor, you aren't really sure... specifically what you want to do when you are older. Now I get to see job opportunities and what they do and how that suits myself."

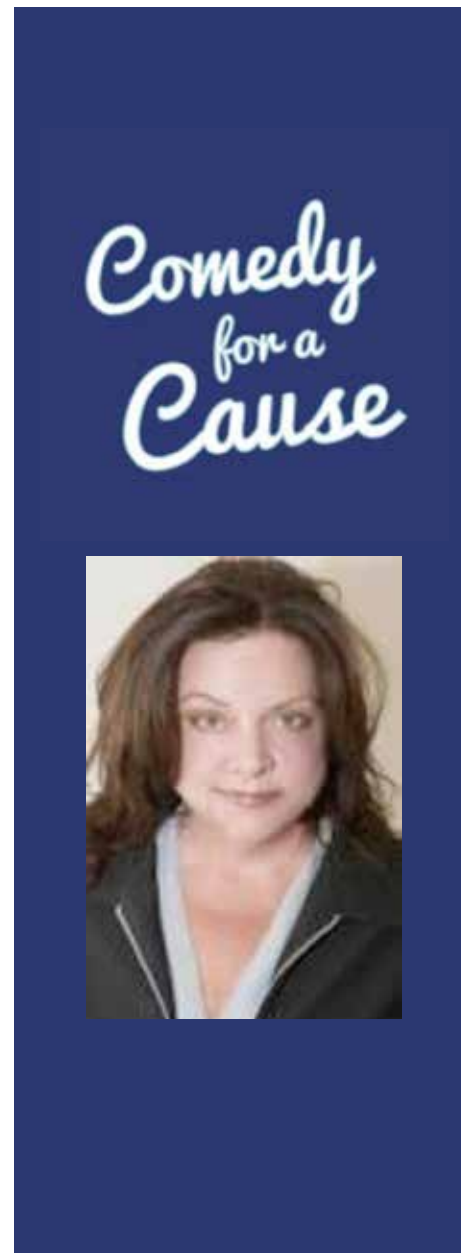

Red Sox Hope Young Pitchers Hold Up

At first look, Red Sox rookie lefthander Brian Johnson didn't have much control over the play that ruined his debut as reported from Houston by Jen McCaffrey. Johnson, tasked with a tough assignment of stopping one of the better teams in the league with a tired Red Sox squad behind him, worked through a few early jams, but had the game under control through four innings on Tuesday in Houston.

After he'd retired eight straight, the lefthander allowed consecutive singles to start the fifth. A fielder's choice put runners on the corners and when catcher Ryan Hanigan went to throw out Jake Marisnick stealing second, the throw deflected off Marisnick's arm and into left field, allowing both runners to score. But even though Hanigan's throw was off, he came out his crouch for a would-be pitchout. Johnson threw an 83 mph changeup, though, seemingly missing the pitchout sign causing Hanigan to hesitate. The catcher took the blame, but if Johnson had thrown a fastball, Hanigan might have had a better aim.

It may seem like a minor mistake, especially in a starter's major league debut, but it's the little mistakes the Red Sox will have to endure with a young core moving forward. With two starters from the start of the season not currently in the rotation in Clay Buchholz and Justin Masterson, the Red Sox don't have much choice but to deal with the ebb and flow of the staff. It's the position they've put themselves in. Boston's other rookie lefthander Eduardo Rodriguez has provided a boost for the team at times, but has also fallen into a habit of tipping his pitches, like he did on Monday against Anaheim. The Red Sox have only mapped out their rotation through the weekend and have little flexibility at this point other than what they have in front of them.

Johnson hadn't pitched in a game since before the All-Star break and admittedly was a little rusty at the outset. "A lot of it is schedule and circumstance," Farrell said of Johnson's break.

Bottom line is that with the uncertainty of the rotation caused by a confluence of unexpected physical, mental and mechanical issues with their pitchers, the Sox are continuing their work in progress on the mound. In the field and at bat, that's got its own set of issues as well. John Farrell has to hope that there is a lot of patience stored up in the front office.

This week, WBZ-TV & 98.5 The Sports Hub's Dan Roche joined the show:

DANNY PICARD: The Red Sox returned from the All-Star break and got swept by the Los Angeles Angels in four games. Entering the series in Houston against the Astros, the Red Sox are nine games out of first place in the AL East, and the last-place team in the AL Wild Card race. This is it, right Rochie? This season for the Red Sox is officially over?

DAN ROCHE: Yeah, you know, I looked at them and said, if they could have swept the Yankees before the All-Star break, I think they would have been within two-and-a-half games of the AL East lead. So then you would have been feeling pretty good about yourself going into the break. And low and behold, that Friday night game against the Yankees, they lay an egg. They win on Saturday. Then they just didn't look good and couldn't get the pitching that they needed on Sunday. And then the All-Star break hit and you're like, well maybe if they can kick off this West Coast swing a little bit and get going, something will happen for this team. And then they come out against the Angels and they can't score. They pitched okay, but they were facing a really good Angels team. They get swept, and you're sitting there saying, "Yeah,

this is the time where it's pretty much done." And if you're Ben Cherington and John Farrell and company, you start to look towards next year. These guys should still go out and try to win every single night; obviously that's your objective as a professional. But it would take a miracle, in my mind, for them to come back.

DP: Eduardo Rodriguez is the guy I feel most confident in, in this Red Sox rotation. The most disappointing thing in this Angels series was that I think Rodriguez was tipping his pitches again. The Red Sox say he wasn't, but what did you see? What did you think when you saw him pulled in the second inning in LA after allowing seven runs?

DR: The Red Sox say no, but it's tough to argue with what you just said. Jerry Remy said it as well, he let up seven runs on eight pitches. That's insane. So I started going back and forth a little bit with Alex Cora — who was once part of the Red Sox — and he said, "Once a tipper, always a tipper." In that, he may not think he's doing it, and it may not be a part of what you're looking at when you're breaking it down, but, there's something they might find that's even smaller than what he was

doing with his head and things like that when they first found it. So it's certainly a concern, especially if this guy is going to be your ace going forward, or at least, a guy that you're hoping to be that No. 1.

DP: So we're getting closer to the July 31 trade deadline, and I live my life playing the role of imaginary Red Sox GM. So I always put myself in the shoes of who's in that spot, and right now it's Ben Cherington. And the most frustrating thing about this upcoming trade deadline is Clay Buchholz, and the injury that he suffered. To me, the Buchholz injury and the trade value that he had before the injury, that's the most devastating thing for this Red Sox organization.

DR: It's interesting too, because, being around the game for so long, you tend to go back to the whole theory that if a guy is a career .220 hitter, then eventually he's going to go back to that level. If he's a .300 hitter, if he starts slow or has a terrible April, eventually he's going to get back to that level or somewhere close. And I look at a guy like Clay Buchholz, and unfortunately, we're seeing his career track path continue. To me, the most amazing number

was, when he came out of June, I think his career record in June is 16-1, but then it flies off dramatically in July and August. And having conversations with Clay, he was hoping in his mind that he could continue his success this year into July and August and become that ace. He went into spring training feeling physically the best he's felt in a long time. His shoulder was fine, everything felt good. So yeah, I'm with you. That is the most disappointing thing, the fact that Clay can't get over that hump at the All-Star break. And if I'm another general manager, I'm looking at that career mark now and thinking, "Do I really want to trade for this guy?" It's disappointing, but I don't think Clay's doing anything different than what we've seen over the course of his career. So now, you've just got to sit tight with him. Hopefully he rebounds and gets back on the mound in a month and is fine. But to me, now, there's no way anybody takes him. At least for this year, and probably beyond that.
