## The Real Meaning of the Patriots Day Holiday

We celebrate Patriots Day next Monday and in some places in certain states around the country, Massachusetts being one of them, it's a designated holiday. So this is as good a time as any to remind some of our readers who may be unfamiliar with the origin of the day and the significance given to it what it's all about. It might surprise some to learn that it's not just 'Marathon Monday', it doesn't have anything to do with our favorite NFL Team lead by Tom Brady and it's not just 'One Boston Day' as Mayor Walsh wants it called this year, referring of course to the Marathon Bombings.

## Window Into The State House

Window Into The State House provides our readers a synopsis of important issues of interest, past and current, that are being proposed, debated or acted upon by the Massachusetts Legislature. Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

### Charter compromise bill passes Senate, but still faces rocky future

Some wondered whether a compromise charter school bill recently unveiled by leading senators had enough support to pass even the Senate. That conjecture was proven dead wrong on Thursday. In fact, the controversial legislation - which would increase the cap on charter schools in Massachusetts in exchange for significant funding increases for all public schools - easily passed the chamber on Thursday and is now headed to the House, where its future is not quite as rosy, reports Matt Murphy of the State House News Service.

But most observers continue to believe that, no matter what happens on Beacon Hill, the issue

of expanding charter schools in Massachusetts will ultimately be decided in a ballot-question showdown in November. So that raises the question: Why do some opponents of charter schools say they welcome a November showdown?

**As Garrett Quinn of Boston Magazine** notes, a new poll shows overwhelming support in Boston for lifting the cap on the number of charter schools. Granted, the poll was sponsored by the Massachusetts Charter Public School Association. But a recent WBZ and UMass Amherst statewide poll found 51 percent of likely voters supporting a ballot question that would lift the cap on charter schools, while 23 percent oppose the proposal, Quinn notes.

So why the confidence by some opponents that they can prevail in November? Maybe it's all part of the game of political chicken.

### Campaign office says Baker can accept huge sums from outsiders

The state Office of Campaign and Political Finance has concluded that the Massachusetts Republican Party can give federally raised donations to Gov. Charlie Baker's campaign committee, in a decision some critics say is a blow to state control of campaign finances, the Globe's Frank Phillips reports.

### First GE, now ... Aetna?

Public records released in connection with General Electric's relocation to Boston show the city and state may be after another prize from the Nutmeg State, Jessica Bartlett of the Boston Business Journal reports. Emails reference officials noting that Boston is likely one of several locations trying to entice insurance giant Aetna, a Fortune 500 company, to move its headquarters from Hartford.

### 'We've never been a big hit with socialists'

Back to the topic of GE, it was sort of refreshing to see General Electric chief executive Jeff Immelt firing back at Bernie Sanders for recently saying companies like GE are tearing apart the "moral fabric of America." Why? Because moralists who tend to see life in simplistic good-versus-evil terms need to be pushed back now and then when they make grossly over-simplified and unfair statements about who is and isn't moral. From Immelt's Washington Post op-ed: "GE has been in business for 124 years, and we've never been a big hit with socialists. We create wealth and jobs, instead of just calling for them in speeches. We take risks, invest, innovate and produce in ways that today sustain 125,00 U.S. jobs." And he notes that, yes, GE does pay taxes and it employs 1,000 people at an aviation plant in Rutland, Vermont, a

facility Sanders has "never bothered" to visit, Immelt says.

### Meanwhile, Warren unloads on Republican senators ...

While Immelt unloads on Bernie, Massachusetts Senator Elizabeth Warren unloads on right-wing Republican senators who she says have "laid the foundation for their presidential front-runners," Donald Trump and Ted Cruz. Writing in the Globe, she says Republicans have been obstructionists from day one of President Obama's presidency, right up to the current fight over Supreme Court nominee Merrick Garland. "Show some courage and put that oath ahead of party politics. Do your job - and start by considering the president's nomination to the Supreme Court."

### GE launches local media blitz

OK, one last GE item, from the Herald's Matt Stout: "General Electric Co. isn't done pitching itself as a good bet for Boston. The multinational behemoth - which is fending off criticism of the plum \$145 million package of city and state perks it took to relocate its headquarters to the Hub - has launched a two-week radio blitz that lavishes praise on Boston and declares itself ready to begin a 'world-changing digital industrial revolution.'" The ads are running on 98.5 The Sports Hub, WBZ NewsRadio 1030, and WBUR.

### Globe launches a 'reinvention initiative'

Dan Kennedy at Media Nation reports that Globe editor Brian McGrory has issued a challenge to his staff members to completely rethink how the Globe newsroom operates, amidst a continuing revenue decline hitting all newspapers. The Globe is also bringing in some outside consultants "who have thought long and hard about these issues and are deeply knowledgeable about what's been tried at other news organizations and how it's worked," McGrory writes in a staff memo.



# Reading Between The Lines

## “Thank You Lynne”

This is probably the “kiss of death” for Boston Latin Head Lynne Mooney Teta but at this point it may not matter. Nevertheless, for the parents of one Latin student we are forever grateful for her dedication, hands on stewardship of our city and nation’s most prestigious public school. With my friends growing up in the Boston school system we were always the “cool kids”. Everyday as school was dismissed we’d hang in front of school, smoking cigarettes, making jokes, laughing at the nerds and geeks lugging armloads of books, while us cool kids were lucky if we had a rolled up notebook in our back pocket. We were all from the same social and economic backgrounds but somehow us “cool kids” settled for what our high school degree allowed, while the nerds and geeks who took the test and were admitted to Boston Latin had a world open up that had no ceiling.

Because Boston Latin has always been the real deal, the great equalizer, there was no political or financial hook to get you in the back door. Wealthy suburbanites have been known to purchase 600-thousand-dollar Beacon Hill condos in an attempt for their children to by pass residency requirements, all for naught. Either you pass the test or you don’t. No exceptions.

It is why Boston Latin is the last, best, hope for city kids with the brains, but not the finances to be recognized, recruited and accepted to our most elite and expensive colleges and universities.

All city kids. Black, White, Asian, Spanish, Mid Easterners, all are eligible no matter what part of the city. That’s because Boston Latin is not a “neighborhood” school and doesn’t save places for students in the

neighborhood they’re located in. It’s an exam school. A standard they’ve always had and continue to maintain. It’s that commitment to excellence that has schools tripping over themselves to admit Latin kids. The universities even include the presence of Latin alumni in their recruitment brochures to impress applicants.

Nevertheless, this impressive record and the person ultimately responsible is under fire amid calls for a Justice Department Civil Rights investigation.

It might better be described as a “racial envy” investigation. It could be argued, precisely because we don’t have the same level of racial animosity evidenced in other parts of the nation, that some “activists” want to become part of the national story and embellish facts. A pattern is emerging nation wide of people looking to be offended.

In Albany, N.Y., the local university president issued a condemnation of an attack Jan. 30th by “10-12 white men and women” on three Black women on a bus. One “victim” spoke at a campus rally. OOPS! The bus had a camera which showed, in fact, the three “victims” attacked the white passengers without warning. University police have issued arrest warrants.

Then comes the GAP commercial showing a group of diverse young girls with one taller “white” girl resting an arm on the head of a much smaller “black” girl. The outrage so great the ad was pulled. It turns out the “white” mother explained the two girls were sisters of an inter-racial marriage.

Did you miss the video of the “white” guy with dreadlocks waiting for an elevator when a “black” woman, also with dreadlocks, screams at him that he doesn’t have the “right

to wear a “black” hair style? Usually the media has no problem printing the most outrageous details of a story front and center.

Obviously, there is still racism, from all sides, in the world and especially young kids can say some stupid, hurtful things. That is probably true in this Boston Latin case. Yet, the major complaint that seems to have put this controversy in motion, is that a white student texted the “racism in Ferguson, Missouri was fomented by the media who incited protesters and not the

police”. It seems the two female Black students felt even holding that opinion is racist and a number of “front runners” jumped on board.

The two students might want to consider that Attorney General Holder oversaw the Ferguson investigation and President Obama oversaw him. The witnesses, who were Black, backed up Officer Wilson and not one witness stated anything different despite the “hands up, don’t shoot” lie that led to the creation of this spurious “Black lives matter” group.

# Common Tax Mistakes To Avoid

**T**ax filing day is quickly approaching and the filing deadline will be here before you know it. If you haven't filed your taxes yet, it's time for action. You should get started by getting your tax return together, organizing all of your information and double checking your returns to make sure that they are complete and accurate. In order to help you file your tax return right the first time, here is a handy checklist of the seven most common tax mistakes that you should avoid.

## 1. Missing/Wrong Social Security Number

According to the Internal Revenue Service, one of the most common errors that people make when filling out their tax form is forgetting to include their Social Security number. The IRS receives thousands of tax returns each year with no Social Security numbers attached or with the wrong Social Security number.

Failing to include the right Social Security number for yourself or your dependents will hinder processing of your tax return. If you enter the wrong Social Security number, the IRS will reject all deductions and exemptions that you claim. This will hold up any refunds that you are owed and can leave you subject to late fees if you owe the IRS money. You can avoid making this mistake by double checking your Social Security number and those of claimed dependents before submitting your return. Verify every number by looking at Social Security cards.

## 2. Failing to Include All Sources of Income

You have to include documentation of your income with your tax return. Be sure to include copies of all W-2 forms that you received during the year. Make sure that you add in any 1099 income and miscellaneous income that you earned as well.

Failing to report any income that you received will make the IRS think that you are hiding something and they may seek to take a closer look at your return. This could be in the form of asking for additional documentation or even an audit. If you

know that you earned income from a company during the year and have not received the appropriate forms, contact the company. Request a W-2 and 1099 from all employers. You don't want to find out that you are liable for additional taxes after the fact.

## 3. Math Mistakes

Despite the increasing number of options available for tax filing, many people still file their returns manually. Filing manually may save you money but it also leaves you open to the possibility of making common mathematical errors. Too many tax filers file incorrect returns because of a simple calculation error or placing the wrong digit in the wrong column.

This may be a small error but it can leave you owing a large amount of money. The IRS will charge you based on the amounts that you write on your tax return. If you make the mistake of claiming too much income or too little in deductions, you could find yourself having to pay more in taxes than you would otherwise have to. You can avoid making mathematical mistakes by double checking all of your numbers with a calculator or using tax preparation software. Tax software does the calculations for you, and significantly reduces the likelihood of errors in your return.

## 4. Claiming the Wrong Amount of Credits and Deductions

The biggest mistake that tax filers make is claiming either too many or too few deductions. Both mistakes are detrimental. Millions of Americans claim credits and rebates that they are not eligible for. Taking too many illegal deductions could be construed as tax evasion by the IRS and leave you at risk of being audited. In a worst-case scenario, tax evaders can face jail time. It's best to play it safe when it comes to paying your taxes. If you owe the money, pay it.

That said, not taking advantage of deductions that you are legally entitled to is foolish as well. You could end up with a larger tax liability than you need to. Take advantage of every legal deduction and tax credit that you are eligible for. Be sure to

deduct all charitable contributions, gifts and contributions that you can write off. If you are unsure about what credits and deductions you should apply for, contact a qualified tax professional.

## 5. Forgetting to Sign and Date Your Return

Don't spend hours filling out your tax return and making sure that every number is correct only to forget to sign your name and date the return. You would be surprised how many times this mistake happens. If you forget to sign and date your return, the IRS will not accept it and will list your account as having not filed. In this case, your return will be considered late, which will leave you liable for penalties and interest.

Take a minute and make sure that you and your spouse have both signed and dated your tax return. If you want to skip the headache of signing, you can file your return using E-file. E-filing allows you to submit an electronic signature, freeing you of the burden of signing and mailing your return.

## 6. Failing To File Your Taxes

Filing your taxes late is perfectly legal as long as you have requested an extension in advance. Too many people skip this step and fail to alert the IRS that they will be missing the April 15 deadline. Failing to file an IRS tax return in a timely manner will result in additional expenses.

If you are going to be late filing your taxes, be sure to file your extension request in advance. You can download Form 4868 from the IRS website. Once approved, you will receive a six-month automatic extension that gives you until October 15 to file your return. Filing late does not exempt you from having to pay

# Boston City Council to Hold Hearing on the Boston Sister Cities Program

**T**he Boston City Council's Committee on Arts, Culture, and Special Events has scheduled a hearing to address the Sister Cities Program in Boston. The matter, which was sponsored by Councilor At-Large Michael F. Flaherty, will take place in the Iannella Chamber on April 21, 2016 at 11:30 am.

Sister Cities International was founded in 1956 by President Dwight D. Eisenhower and has since expanded to 545 United States cities and towns with 2,100 partnerships in 145 countries. The program has focus areas in cultural and educational exchanges, economic partnerships, and humanitarian assistance.

In order to foster an understanding, awareness, and appreciation of the world in which we live, Boston has partnered with Kyoto Japan, Strasbourg France, Barcelona Spain, Hangzhou China, Padua Italy, Melbourne Australia, Taipei Taiwan, Sekondi-Takoradi Ghana, Belfast Ireland, and Praia Cape Verde. During the hearing the Committee plans to explore additional programming to allow Boston to further benefit from our existing partnerships.

"I look forward to discussing ways to enhance opportunities for Boston residents to benefit from our relationships abroad," said Councilor Flaherty. "Whether it be learning a new language in a student exchange program, or communicating new business and trade ideas, Sister Cities programming has the potential to offer our citizens invaluable and unforgettable cultural experiences."

# Ed Hamilton Honored at US Naval Museum in New Orleans

Over the years, South Boston has had its share of celebrities. Pro sports stars, famous politicians, movie stars and others. But probably the South Bostonians most near and dear to the hearts of this town are its veterans. This is a neighborhood famous for pride in and respect for the men and women who have served our country with honor and residents make every effort to sing their praises. And one of Southie's most famous veterans of all is of course, Ed Hamilton; the World War II veteran of the Pearl Harbor attack who stays active as he spends large parts of his days walking around his home town; socializing with his many friends and neighbors.

As South Boston Today (SBT) has reported in several stories, Ed Hamilton isn't just well known for his service in his home town, he is also a celebrity of sorts in different parts of our country. SBT has reported on the trips back to Pearl Harbor with his family where he was an honored guest of the US Navy and treated like royalty while he shared his experiences with current navy personnel as well as visiting tourists. He has appeared on Hawaiian news channels and in that state's newspapers while receiving awards.

Ed Hamilton's most recent trip, 2 weeks ago, along with his daughter and son-in-law Laura and Coli McDonagh was to New Orleans where he donated a flag that flew during the attack on Pearl Harbor. Ed was stationed on the USS Bennett, a destroyer which was in the middle of the battle as the Japanese bombers attacked the base at 'Pearl' which set off America's entry into WWII. The US Naval Museum's Curator, Larry Decuers, in charge of the facility gave Ed and his family a private guided tour of the museum's archives. The tours, pomp and ceremony of the naval facility were fascinating and very educational and an experience they will never forget.

And here again, Ed Hamilton was treated like a visiting celebrity with rock star status.

While in New Orleans, the family got to sample some of the food the city is so famous for and immerse themselves in the unique culture found only in that city. They visited Bourbon Street, took in some of the live jazz music and got a ride on the Natchez Dinner Cruise Ship that travels the Mississippi River. Even

on the cruise ship Ed and his family members were honored. They were brought to a reserved table decorated with Red, White and Blue flowers and flags in Ed's honor. Quite a lot of activity was crammed into this 5 day New Orleans visit which was more like an adventure.

Next December will signal the 75th anniversary of the attack on Pearl Harbor and Ed has been invited by the Navy to return once again. He and the family are already making plans and looking forward to returning.

## Six (not so) Dumb Tax Questions You're Too Embarrassed To Ask

Unless you're an accounting geek, chances are you don't like thinking about taxes.

But when it comes to the IRS, you can't just bury your head in the sand and claim ignorance. Here are answers to a few seemingly dumb and super-simple questions that actually are neither.

### **Do I really have to file a federal tax return?**

Probably. The only time you're not required to file is if your income is less than your personal exemption plus your standard deduction, both of which are determined by your marital status and age. You will use the IRS table to figure out your personal situation. But generally, if you made more than \$23,100 in 2015, you will have to file. But here's the thing: Even if your income is too low to have to file, you may want to anyway. Why? You could be owed a refund. Too much tax may have been withheld from your paycheck or you

may be entitled to a refundable tax break like the Earned Income Tax Credit, which pays money to qualified filers even if the credit exceeds their tax bill.

### **How long will it be before I get my refund?**

Most filers get refunds and the vast majority of them get their refunds in hand within 21 days from the day they file their returns.

### **Is it true the IRS can withhold my refund?**

Yes, there are four situations in which the IRS will not send you part or all of your refund: If you're behind in paying federal student loans, child support, or state income taxes; or if you got too much of a government subsidy to buy health insurance on a federal or state exchange.

### **What if I know I owe money to the IRS but can't afford to pay?**

First, file anyway. If you don't, you'll be hit with a failure-to-file penalty, which is steep.

Second, take a deep breath. There are different payment plan options you can work out with the IRS so that you don't have to pony up everything all at once. If you owe more than \$10,000, it's advisable to have a tax attorney, enrolled agent or CPA with experience setting up payment plans to represent you. If you owe less than that, you still might want to seek a tax professional's help if all this stuff seems too daunting.

### **Okay so when do I have to file?**

The deadline this year is Monday, April 18. (Usually, it's April 15.)

If that doesn't fit into your schedule, you can file an automatic 6-month extension form.

Remember, though, an extension to file is not an extension to pay. Any remaining money you owe for tax year 2015 is due April 18. So if you think you'll have to cut the IRS a check, estimate how much it will be and pay it when you send in your extension form.

If you don't, you'll owe interest on the amount due and could be hit with a failure-to-pay penalty.

### **Will I get audited?**

Probably not. Audit rates are very low these days -- thanks largely to budget cuts at the IRS. But that doesn't mean your return will always escape scrutiny, especially if you go out of your way to invite it. Be sure to report all your income. The IRS has copies of any tax forms you get -- from employers, banks, brokers, educational institutions or partnerships. And it uses an automated form-matching system to cross-check the numbers on your return match the numbers it has on file. If there's any discrepancy, that could trigger an audit. You'll also call attention to your return if you blatantly try to claim tax breaks you don't qualify for -- say, trying to deduct all your housing costs for that home office you don't have or reporting several years of losses for a small business that's nothing more than a hobby.

taxes and fees on any money owed.

### **7. Forgetting To Include Your Payment**

Check the envelope to make sure that you included your check or money order with your tax return.

If you do have a tax liability, write your Social Security number, tax form number and tax year on the check or money order. This will make sure that your payment is processed properly and keep you from having to pay interest

and late fees. You can also e-file, which will let you make your payment electronically. If you are unable to pay the full amount, contact the IRS to make payment arrangements.

### **The Bottom Line**

As you can clearly see, it pays to have a checklist when filing your taxes. Spending a few extra minutes double-checking your return can save you all the trouble of having missed something important.



**M**iddle school students from Saint Peter Academy in South Boston had the opportunity to visit the MassPort STEM Expo at Logan Airport to view and learn about the science, technology, engineering and mathematics that are the elements for successful and safe air and ground travel.

In addition to St Peter Academy's attendance, more than 1,500 students from 44 Greater Boston schools attended the Aviation and Maritime STEM Education Expo at Boston Logan International Airport. The Expo is an annual education event where representatives from industry,

government, and academia introduce students and educators to the opportunities and experiences offered by the aviation, maritime, and transportation fields.

"It is essential for organizations like Massport that students are exposed to careers in science, technology, engineering and math," said Massport CEO Thomas P. Glynn. "Boston is home to a number of industries including life sciences, technology and innovation. We need our young people to have the interest and motivation to study the STEM disciplines so we can continue to generate the good-paying jobs and economic

impact that propel the Commonwealth."

More than 50 displays and information booths representing various aspects of the industries served as the backdrop for the event at the Delta Hangar. There were 21 aircraft including airplanes, two helicopters, numerous airport operations vehicles, as well as a Massport Fire Rescue airboat. In addition to several Massport departments, exhibitors included The Museum of Science, the Federal Aviation Administration (FAA), National Oceanic and Atmospheric Administration (NOAA), U.S. Coast Guard, U.S. Customs and

Border Protection, Mass Maritime Academy, Massachusetts Air and Space Museum, Massachusetts State Police, Boston MedFlight and the Transportation Security Administration (TSA).

"Hundreds of careers at our airports were represented today," said Massport's Director of Aviation Ed Freni. "We rely on the engineers who design and build the planes, the pilots who fly them, the electricians who keep runways lit and radars working properly, the air traffic controllers who make sure aircraft travel safely in the sky, and many more. Showcasing the various career paths at the STEM Expo will hope-

Matthew McDonald, a ninth grade student at St Peter Academy was honored to have an in depth conversation with members of the World War II Tuskegee Airmen who are the first United States Army black aviator fighter pilots. “I really enjoyed learning about the P-51 and the P-40 aircrafts and how they operated. We also discussed the movie Red Wings which is about the Tuskegee Airmen and we talked about the facts in the movie. He is a smart man and I’m glad I had the chance to meet a Tuskegee. They’re part of our history.”

Josie Correia, another St Peter Academy middle school student, is contemplating becoming a pilot based on her visit to the Expo. “I’ve asked my parents to help me investigate flying lessons. Justice, in and of itself, and the disagreement over the proper and legal constitutional process. The Tea Party Republicans, many of whom were elected in the mid-term after Barack Obama’s 2008 election, have threatened both the process of government and the careers of many members of Congress, not to mention effectuating the early retirement of the good and decent former House Speaker, Republican John Boehner of Ohio in their pursuit of ‘smaller, less intrusive government.

In a similar and parallel vein, the 2016 presidential campaigns, both Democrats and Republicans, are a case study in the emergence of a Republican oligarchy (a small group of people having control of a country) attempting to replace a democracy, because they don’t agree with the will of the people.

Cases in point, nationally, are at least two.

Donald Trump, currently the leading candidate for the Republican nomination, has apparently been victimized by an arbitrary process in the State of Colorado that inexplicably awarded his closest competitor and latent Republican establishment preference Texas Senator Ted Cruz 34 delegates without any votes being cast by citizens in a traditional primary process. Democracy be damned it appears. But, citizen backlash may be severe as the Republican nomination process unfolds.

Next, the competitiveness of the democratic-socialist movement that Vermont Senator Bernie Sanders has championed and that has him currently winning more states than Hillary Clinton - albeit she has a majority of the actual votes cast - may well be undercut by the phenomenon of the party-endorsed Super Delegates. These Super Delegates are partisans who have no independence and are vetted by the Democratic Party, before they are

allowed to be super delegates.

Intimidation is the order of the day locally in two cases with a common thread.

Recently, the State Democratic Party ousted one of their well-regarded minority state representatives, Ben Swan of Springfield, because he cast an anti-transgender rights vote before switching and supporting a later version. The progressive left party wouldn’t tolerate that situation and voted him off of the state committee. They also voted off Cambridge City Councilor Leland Cheung because he has the temerity to challenge State Senator Pat Jehlen, a popular liberal.

Secondly, and on the topic of transgender rights, the so-called bathroom bill has intimidation tactics being used on both sides. Opponents fear that allowing for unfettered access to women’s bathrooms by persons identifying themselves as transgender lack safety protections and are simply a license for criminal and other offenders to attempt to

take advantage of the loophole. Proponents oversimplify it as an anti-discrimination measure that protects transgender persons from being barred from certain restaurants. Celebrities and politicians have taken it on as an opportunity to champion a LGBT cause by trying to legislate a ban on travel to and cancelling concerts and events in North Carolina, because it recently passed legislation limiting certain access. Dueling rallies were held recently with smear campaigns be incited by both sides.

Ideological demagoguery, cultural disruption and outright threats and intimidation have taken the place of reasoning, civility and discourse. Civil disobedience has given way to uncivil thuggery. It’s a wonder why anyone seeks public office at any level. There may be less and less room for a campaign that offers a ‘good and decent public servant’ as a choice, at least in Massachusetts. However, the citizen usually gets it right in the end. Time will soon tell at the national level.

The Fourth Church has an array





this age bracket if interested just show up @ 7pm there is no fee.
