



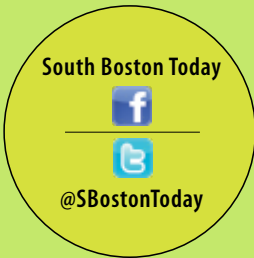
## South Boston's Fort Point Attracts Another Tech Leader

## More Terrorist Attacks But We “Shouldn’t Jump to Conclusions”

## Window Into The State House

They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

### Taking aim at AIM's clout on Beacon Hill

There's no doubt: The Associated Industries of Massachusetts has definitely emerged as the most outspoken and effective business group on Beacon Hill, especially in the House. And that concerns more liberal-minded lawmakers, who say the business group has recently played a key role in blocking all sorts of progressive legislation, such as recent pregnancy rights, wage theft and non-compete bills, reports the Globe's Frank Phillips. "From my experience, AIM exercises veto power in the House," says state Sen. Daniel A. Wolf, Senate chair of the Joint Committee on Labor and Work-

force Development.

That's mostly sour-grapes hyperbole, but AIM is indeed influential – and part of the reason is that it's just plain good at researching and tracking bills, communicating its concerns with lawmakers, and, unlike other don't-rock-the-boat business groups, it isn't shy about blasting away if it doesn't like something. It actually loses its share of legislative battles on Beacon Hill (particularly on energy and environmental matters, it seems), but it is indeed effective, as Phillips notes.

Btw: AIM's arch nemesis and equally effective counter-force on Beacon Hill? The Conservation Law Foundation.

### John Stumpf, meet Elizabeth Warren

Observers are expecting a very hot seat indeed for Wells Fargo CEO John Stumpf today when he appears before the US Senate Banking Committee—especially with outspoken critic Sen. Elizabeth Warren ready to grill him. Matt Egan of CNN reports that banking analysts are predicting a tough day for the CEO as he faces off with Warren, who is on record as saying Stumpf and other executives should give back some of the tens of millions of dollars in bonuses they received based on incentives achieved with the creation of fake bank accounts and false overdraft charges. The company has already been fined \$185 million in connection with the controversy.

### Lynch: Rail system is tempting soft target for terrorists

In the wake of multiple bombing attacks in New York and New Jersey, U.S. Rep. Stephen Lynch is sounding alarms about the security of the heavily traveled Northeast rail system, Matt Stout of the Herald reports. Lynch notes that unlike airports, train depots such as South Station offer multiple points of access, making them inherently more difficult to secure. "The rail system is a point of particular concern for us because you've got five times as many people traveling by rail than you do by air every single day," Lynch said.

### Baker still defying gravity

Morning Consult has a new survey showing that Gov. Charlie Baker is maintaining his sky-high approval ratings in Massachusetts. He may no longer be the most popular governor in the country, but with an approval rating of 70 percent, that's no concern for Baker.

**Why are Dems giving Baker a pass on patronage scandals?**

The Herald's Hillary Chabot wonders why Democrats aren't pounding into Gov. Baker in the wake of reports of blatant patronage hirings at the Department of Conservation and Recreation and, most recently, within his cabinet-level office of energy and environmental affairs.

We're going to take a wild guess, but we think the hesitancy might have something to do with the Morning Consult poll above and other surveys.

### To improve Red Line service: new cars, not refurbished cars, please

The MBTA's board members were told yesterday what they already know (or should know): To really improve capacity and service on the Red Line, the T's most heavily used subway line, it will take buying new train cars, not just refurbishing older cars, reports SHNS's Colin Young at WBUR. It's really not that complicated. Any transportation company – from airlines to ocean cargo firms to trucking companies – can verify that nothing beats the reliability of new planes, ships and vehicles. The question always comes down to money.

### NBC inches closer to severing it ties with Channel 7

In the end, we thought NBC and WHDH-TV, Channel 7, would find a way to end their feud and make up, keeping Channel 7 within the NBC affiliate family. But it sure doesn't look like that's going to happen. The Globe's Shirley Leung reports that NBCUniversal has agreed to buy a low-power television station, WTMU-LP in Boston, that could play a role in how the network launches its own Boston station in January. It's not a huge investment by NBCUniversal (\$100,000), but even corporate giants like NBC don't casually throw money around like that.

## “Chaplain Filth”

“If you forgot my death then I died in vain”. Familiar words that are always somewhere in the back of our mind, but never more powerful than when we are actually standing in front of our Viet Nam monument and we see them engraved in the black granite. It was standing in front of the monument exchanging pleasantries and profanities with a couple of the veterans that we realized that ‘the guy in the black suit’, who shook his head while smiling at us was a Marine Chaplain. Younger than any Vet present, a recent story on Chaplains made us marvel at his dedication.

At a monthly veteran’s meeting, a veteran’s magazine article had been handed to me. The article detailed how a Pentagon bureaucrat had taken up the cause of an atheist group. They demanded and the Obama administration acquiesced and removed all Bibles from the Walter Reed Military Hospital. That is until outraged patients, their families and veterans, demanded the return of the Bibles.

While thwarted, the haters weren’t deterred. Presently, they have succeeded in forbidding Chaplains from saying the name of Jesus Christ or advising soldiers seeking comfort to follow church teachings. This same Pentagon official is quoted as saying, “the only honorable thing for Chaplains to do is fold up their uniforms, turn in their papers and resign. If not the Pentagon should take steps to rid itself of intolerable “Chaplain Filth”

WHAT? “Chaplain Filth”? In Feb. 1943 the troop transport USS

Dorchester, carrying 900 souls, was steaming through the frigid North Atlantic off of St. John’s Newfoundland, when it was struck by a torpedo. Conditions on board were so hot and overcrowded that, in violation of orders, many had removed life jackets and uniforms. When struck, the ship immediately began to founder and list on its starboard side. The confusion was great but, in the middle of the chaos, there was one tranquil spot. Protestant Chaplains George Fox and Clark Polling, Rabbi Alexander Goode and Catholic Chaplain John Washington had gathered by a locker and were passing the life belts to the troops in a calm orderly fashion. As fortune would dictate, four soldiers were left without their lifebelts. Without hesitation these four holy men of different faiths gave their own life belts to the four troops.

675 men died, but some of the 250 survivors recalled the last sight of the four chaplains kneeling side by side in prayer as the ship disappeared.

“Chaplain Filth”?

In 1960, the U. S. Congress created the “Chaplain’s Medal”. It is not listed among military awards, but exists only for Chaplains. It is second only to the Congressional Medal of Honor, our nation’s highest award. In 1961, it was bestowed on the families of the four chaplains and has never been awarded since.

Today, of course, it is a sign of “progressive” credentials to proclaim disdain for organized religion, which is a right we enjoy as Americans. Freedom, right? What of the freedom, though, of those

who do believe? Don’t they have the right to be free from government discrimination.

As a stark reference, Ft. Hood murderer Major Hassan would give lectures on military bases on the right to wage jihad. He carried a business card with the legend S. O. A., soldier of Al-lah. Yet, after military personnel complained that they were warned not to interfere with his rights, thirteen murdered soldiers later the Pentagon is waging “Jihad”

against chaplains? Or “Chaplain Filth” to be precise? Huh?

“If you forget my death”. No we haven’t and won’t forget the sacrifices the Chaplains have made. Nor the 25 young men on our monument or the countless veterans since and now who have and continue to put themselves in harm’s way to guarantee those freedoms. Freedom is not free but real Americans will always fight to guarantee it for all.

Last Sunday, St. Brigid Church was filled to capacity at the Memorial Mass for the rededication of the South Boston Vietnam Memorial. After the Mass, the crowd still flocked to the site itself across the street at Medal of Honor Park for the ceremony.

draws current and former residents by the hundreds to remember the 25 young servicemen from South Boston, who bravely gave all in defense of freedom during the Vietnam War.

The South Boston Vietnam Memorial Committee, made up of the loyal friends and fellow Soldiers, Sailors, Marines, Air Force members and Coast Guardsmen who also served during that conflict made sure that no detail in the preparation was left un-

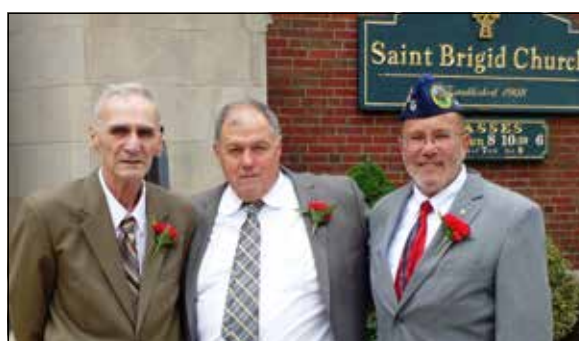
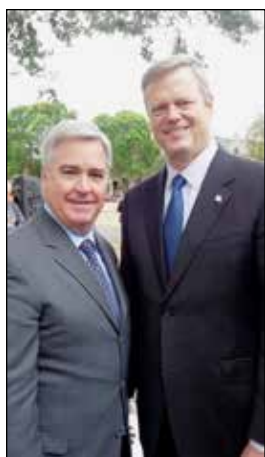
done and set to perfection. It's what they do. It means a lot to them and to the proud community that holds these men in such high esteem.

At the podium, South Boston's elected officials spoke eloquently about the sacrifice this neighborhood's fallen heroes had made. Congressman Stephen Lynch, State Representative Nick Collins, City Councilors Mike Flaherty and Bill Linehan were joined by Governor Charlie Baker, the only sitting governor ever to attend this event.





Governor Baker makes it a point to show up each year. Adding to the impressive lineup of speakers and welcomed with cheers and applause were some of America's Congressional Medal of Honor recipients, which this year included the newest and youngest recipient, Ryan Spitz from New Hampshire. Ryan served multiple tours in the Middle East, as well as did our former US Senator and Secretary of the Navy James Webb.

There was the threat of rain throughout the proceedings, but as it

always seems to do, it held off to be a beautiful morning and early afternoon. It's often said that God won't allow this particular day to be ruined by inclement weather. This year was no exception.

When the speakers finished with their heart felt words of praise for both the fallen, it was time to lay the wreaths at the base of the Memorial. The spoken name of each hero that appears on the monument was accompanied by a red rose placed in their honor, either by a fellow Vietnam Vet-

eran of a family member in what can only be thought of as a truly moving moment as the hundreds in attendance remained silent throughout.

Following the laying of the roses, TAPS was played by the bugler and the day's official itinerary came to an end. But, many stayed at the park just the same. It then became a time to reflect on this day of remembrance, where true heroes were honored once again. The crowd mingled and longtime friends, who in some cases have moved apart get to see

each other only on this day every year. The rededication of the South Boston Vietnam Memorial is special in the hearts of so many, who return each year to be part of this unforgettable experience.

Once again, the Committee did an outstanding job. Their loyalty has spanned decades and shows no signs of fading, no matter how many years pass. More than 35 years ago, these men made a vow that they would never let their fallen brothers be forgotten. They have certainly kept that promise. ## FORT POINT ATTRACTS TECH LEADER CONTINUED FROM FRONT PAGE

According to the Boston Globe and the Boston Business Journal, Red Hat has leased 40,000 square feet of offices at 300 A St. in South Boston's Fort Point neighborhood. It is a brick-and-beam office that's adjacent to the future headquarters of General Electric Co. The office is expected to open in spring 2017.

The 300 A St. office will be Red Hat's first major presence in Boston. It is expected to include an executive briefing center, where clients can see firsthand the work the company does. Red Hat, which is an international provider of open-source software and related services, also operates out of a 175,000-square-foot office in Westford. That site is expected to stay open following the Boston move. As of 2014, the company said it had around 300 employees in Westford with enough space to house about double that number if needed. Paul Cormier, Red Hat president of products and technologies, told the Globe that will employee up to 150 people at the new location and most will be new jobs.

Last month, the Fort Point Channel Landmark District Commission approved a signage package for Red Hat at 300 A St. That signage included "painted signage with external light fixtures at the third floor on Necco Street." Peter Dominski, the director of strategic accounts for CBRE/New England, said at the time that the signage would be "essentially painted-on brick."

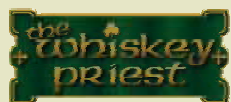
