



Bus Service In South Boston A Hot Topic



The impact of busses during rush hour and other peak times adds to the existing stress from the vehicular traffic traveling through residential streets on the way into downtown Boston, the school bus schedules, parents dropping off school children, Uber and Taxi

drivers, and active public and private construction sites.

Elected officials and residents have been pushing for the T to complete its plans for the South Boston Bus Stop for Routes 5, 7, 9, 10 and 11 and Service Improvements Project. The goals to be discussed with regards to this effort include enhancing service reliability, optimizing bus stop locations and spacing for safety, efficiency, and minimal parking impacts and improving bus stop accessibility for seniors and persons with disabilities.

“Now is the time for residents to come and be heard”, said Rep. Nick Collins. Collins added, “We are looking for a collaborative approach between the T and the residents.”

While this particular meeting is focused on the MBTA Bus Routes, the commuter rail and rapid transit schedules, parking issues and the vehicular traffic routes through South Boston all contribute to the impact. Solutions must be coordinated among all of the responsible government agencies.

A recent column which contained a reminder for drivers to use their turn signals or 'Blinkas' when taking a corner or changing lanes got some feedback. First, what prompted me to make mention of it were complaints by residents; new and longtime neighbors alike, that people seem to be disregarding the law and the common courtesy of using their turn signals. The reminder was made in the form of a 'Turn Signals Use 101' description of what these devices are and where to find them on your vehicle. It even came close to getting physical at one time. The exact same scenarios were playing out at the other monitored intersections.

At the corner of L & Broadway it got even touchier. On a recent warmish day, an SUV and a local on a motorcycle; no names please, were stopped at the lights with both pointing up towards M Street. Neither one had a 'blinka' on. The biker planned to go straight, so he didn't need to signal and he assumed the SUV would too, but, the SUV instead made a hard right turn heading

into the biker, who escaped by a fraction of an inch because he was alert, he gunned the accelerator just in time and was able to get out of the bigger vehicle's way, because his bike was fast enough to avoid a collision. We all know that a car only has to tap a motorcycle to send it flying through the air and cause serious injury to the rider. Would you like to know what kind of four letter words were exchanged here? Ah, sorry, some things are better left not repeated.

Ok, we all know it's starting to get crazy out there. This town is getting so crowded some are surprised that we haven't sunk into the ocean yet. Look left and look right, it is difficult to find a

Window Into The State House

These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

Poll: Pot legalization is way ahead, while charter schools are failing the test

A new WBUR poll shows that support for the legalization of marijuana is growing among likely voters in Massachusetts, with 55 percent of those surveyed saying they back Question 4. That's up from 50 percent last month, while opposition to legalization is falling, from 45 percent last month to 40 percent this month.

On the charter school front, the WBUR poll suggests that Question 2, which would lift the cap on charter schools in Massachusetts, may be headed to defeat, with 52 percent opposing the ballot initiative and 41 percent in favor. But keep in mind:

The polls on Question 2 have been all over the map this election cycle. The contest is still up in the air, if other polls are factored into the guessing-game equation. On Question 3, voters overwhelmingly support passage of the ballot initiative that calls for more humane care of farm animals, while opposition to creating a new slots parlor in Revere is strong and getting stronger, the 'BUR poll show.

Revere voters reject slots parlor

In a non-binding election, voters in Revere dealt a major, though not necessarily fatal, blow to the proposal to add a slots-only casino in Revere, reports Adam Reilly at WGBH. The question, which proponents had hoped would act as springboard for next month's state-

wide vote on Question 1, was defeated by a vote count of 2,970 to 1,574. "We have now taken out of their arsenal the talking point that Revere wants this, because we don't," Mayor Brian Arrigo said. And judging by the new WBUR poll results, statewide voters don't want it either.

O'Malley tries to rally the faithful against Question 4

The polls show opponents of marijuana legalization are facing an uphill battle. But that isn't stopping Cardinal Sean P. O'Malley, who met yesterday with dozens of interfaith leaders to discuss strategies to defeat Question 4. "To me, this is greed trumping common sense and also undermining the common good," the Roman Catholic leader told the Globe. "It will change the culture of this state if this legislation is passed."

Meanwhile, the Globe's Adam Vaccaro looks at the big bucks the liquor industry is pouring into the Question 4 opposition efforts. Their motives really aren't a mystery: Marijuana is a competitive vice.

Spending money to save money, T hires \$1M privatization consultant

The T better get its money's worth, because this doesn't look good. Both Nicole Dungca at the Globe and Matt Stout at the Herald are reporting that the MBTA has agreed to pay \$1 million to McKinsey & Company to study ways to save money, largely through "new operating models," i.e. outsourcing. Technically, the story is ultimately about the T's ongoing privatization efforts. But the office-cooler talk this morning is going to be about that one million smackers and why the rest of us didn't get into the consulting racket. **Cambridge courthouse reuse has statewide implications**

A battle over the redevelopment of a former courthouse in East Cambridge could have ramifications for state properties across Massachusetts, Jon Chesto of the Globe reports. Neighbors and opponents of the pro-

posed redevelopment are challenging whether the state can pass its exemptions from local zoning rules to a private developer—something that Attorney General Maura Healey's office argues could impact the state's ability to reuse up to 200 properties statewide. This is a big deal involving big bucks for the state. It could also mean many future developments.

Question seeks to lower drinking age to 19

Voters in the 3d Hampshire District—which includes Amherst, home of the University of Massachusetts—will vote on a nonbinding referendum on Nov. 8 that asks lawmakers to look into lowering the legal drinking age from 21 to 19, Scott Merzbach of the Hampshire Gazette reports. Former Massachusetts resident Matthew Malone is responsible for the question, which would only lower the drinking age for wine and malt beverages and keep the current age for hard liquor. Although the district covers Pelham and Granby, all but three of the 310 signatures gathered to get the question on the ballot were gathered in Amherst, which is represented by Senate President Stan Rosenberg.

Trying to apply artificial intelligence to Donald Trump

First, let's get the public-service side of this story out of the way: The MIT maker of a bot that spits out semi-coherent Donald Trump-like tweets, based on an artificial intelligence algorithm of Trump's past mutterings, has announced—or actually his bot, DeepDrumpf, has announced—it's helping crowdfund a campaign aimed at raising money for "Girls Who Code," a nonprofit focused on closing the tech industry's gender gap by teaching females STEM skills, the BBJ's David Harris reports. Now for the fun part: You gotta check out DeepDrumpf's past AI rants in general. They're hilarious. One of our favorite tweets: "Together we can save America and use her weapons to defeat accountability and take back the world's money."



Some officials have stated that there is potential for problems if this continues. With faces hidden and identities not known, criminals



SEN. FORRY, REP. COLLINS UNVEIL TRANSPORTATION PLAN

\$11 million in funding to improve transportation without new taxes or fees

State Senator Linda Dorcea Forry and State Representative Nick Collins announced a comprehensive transportation plan to improve public transit while reducing congestion.

Building off the progress made in the South Boston Waterfront Sustainable Transportation Plan, **Sen. Forry and Rep. Collins** spent the last two years pushing officials from the Massachusetts Department of Transportation, the Massachusetts Bay Transportation Authority (MBTA) and the Department of Conservation and Recreation (DCR) to continue working on transit issues in South Boston.

As part of that effort, Sen. Forry and Rep. Collins urged the MBTA and MassDOT throughout 2016 to include South Boston in its Capital Investment Plan for FY17-FY21. As a result of their advocacy, approximately \$11 million has been earmarked for transportation needs in South Boston. The Capital Investment Plan includes:

- \$9.7 million for the Cypher Street extension from D Street to E Street and reconstruction of E Street to extend from Cypher Street to Summer Street;
- \$700,000 to study Kosciuszko Circle;
- \$500,000 to plan, design and construct parallel parking along Columbia Road from I Street to Preble Circle;
- \$135,000 to upgrade the traffic signal at the intersection of I Street and Day Boulevard; and
- \$100,000 to facilitate transportation needs on Columbia Road.

“I would like to thank **Highway Administrator Tom Tinlin** and MassDOT for addressing Day Boulevard and Kosciuszko Circle in their Capital Investment Plan,” said **Rep. Collins**. “It is my hope that these recommendations will address long-standing issues at these two intersections, relieving traffic congestion and increasing the quality of life for our residents and commuters alike.”

“I am pleased the MBTA and

MassDOT are committing to a review of services in South Boston,” said **Senator Linda Dorcea Forry**. “These agencies will also analyze the best ways and solutions to upgrade Day Boulevard and Kosciuszko Circle which suffer from gridlock and are serious public safety concerns. Ensuring safe roads and reliable transportation options to our residents are critically important,” concluded **Sen. Forry**.

Currently underway is an examination of South Boston bus systems by MassDOT and the MBTA. As part of that conversation, **Rep. Collins and Sen. Forry** have advocated for a series of short-term and long-term fixes to improve service in South Boston. Short-term proposals include:

- Revitalizing the City Point Bus Terminal on East First Street to accommodate passenger platforms and other amenities; and
- A review current bus routes for inclusion of express routes.

A public meeting will be held later this month to discuss MBTA route improvements.

However, cognizant that some of the long-term transportation needs in South Boston and throughout Massachusetts require substantial funding, **Rep. Collins and Sen. Forry** have urged the MBTA to examine the possibility of capturing value from existing MBTA assets by leasing air rights above the Red Line layover tracks at Cabot Yard. Significant money raised by a similar project in Hudson Yards, New York, was used to improve public transportation without increasing the tax or fee burden on riders and taxpayers.

“By capturing value from existing assets, the MBTA will be able to realize significant sources of income and in turn can make the necessary investments in transportation infrastructure which will benefit commuters in South Boston and the system as whole,” said **Rep. Collins**. “Examples of these improvements may include infrastructure upgrades for bus service, traffic



signals, and congestion relief in one of our busiest neighborhoods. This would help set the T in the direction of economic sustainability and provide funding for much needed infrastructure upgrades without new fees or taxes. These kinds of creative

solutions are necessary to address financial woes before we resort to privatizing services.”

The MBTA, in response to the lawmakers’ requests, are currently studying the potential value of this proposal.







HISTORICAL SOCIETY PUBLISHES PARADE HISTORY

In this most enjoyable and informative work, *South Boston on Parade*, author Paul Christian traces the Parade's history from 1901 to the present through hundreds of photographs and historical details. He guides us through the several changes that have occurred over the past century, from a march commemorating George Washington's first military victory, to a procession celebrating Irish heritage and the Patron Saint of Ireland, to a general day of good cheer. "The Evacuation Day/Saint Patrick's Day Parade is an integral part of South Boston. Few other annual events in the city have attracted more attention over the years. The parade has changed as much as the town has changed, and it was my goal to document the roots of the parade, how it evolved over the years into the celebration it is today" said Christian, former Commissioner and Chief of Department, Boston Fire Department.

Robert Allison, President of the South Boston Historical Society referred to Paul Christian's newly-released book, *South Boston on Parade*, as "the definitive history of the Evacuation Day/Saint Patrick's Day Parade". Allison is a well-

known author and chair of the History Department at Suffolk University.

"George Washington certainly never met Saint Patrick" added Marty Kane, Christian's collaborator on the project. "But they share a joyous commemoration every March in South Boston's Evacuation Day and Saint Patrick's Day Parade. George Washington's first victory of the Revolutionary War took place on March 17, 1776, Saint Patrick's Day, in what is now South Boston. In *South Boston on Parade* Paul Christian shows how the celebrations became entwined."




The Art of Collaboration at St Peter Academy

Mr. Peter Witts second grade students have been studying the War of 1812 and recently finished their collaborative project on “The Attack on Washington.” After doing little more than a read aloud on the event the students were set loose to research more about the topic. With use of technology each student came up with a list of interesting facts and a paragraph as to the attacks significance to the war. Jacki remembers, “From there we made a few drafts of our work to improve each time. Then we went and typed up our words so they would look really

good on the final project.” Although all students did a rough draft of the picture when it came to the final step of collaboratively drawing the poster the students hit an obstacle. In Riley’s words, “we got off to a rough start, but don’t worry we fixed it up!” While Mr. Witts was worried about the high number of literacy and technology standards he had included throughout the unit, he had not anticipated drawing to be the hardest task. As each student brought a unique vision to the drawing, visions clashed and obstinacy set in. At the end of the first time allotment they looked at

their progress and talked. They all decided that it was not their best work, and that they would like to try again next class. The following class they wrote down a list of acceptable guidelines: 1. What they wanted to include in the picture, 2. Assign tasks, and 3. How they would behave. From the moment Gillian added, “That we needed to respect one another by talking instead of arguing” the mood changed and the quality of work improved drastically as shown by their rough vs. good draft photos. After the picture was done each student printed the facts they had previously found and glued them

to the area of the picture which they matched. For example, Callan insisted upon adding little bits of fire to each window to illustrate the burning of the White House. ‘The Attack on Washington’ project is the second of three projects that comprise the War of 1812 learning unit in Mr. Witts second grade class at St Peter Academy. The last phase of the unit will culminate with an independent research project and individualized assessment. Mr. Witts used this first social studies unit to go well beyond the content and lay the groundwork for how students will

INCREASED HOURS AT CITY’S COMMUNITY CENTERS

Operational Shifts Will Provide Boston’s Families With More Access and Programming

Mayor Martin J. Walsh today announced operational changes at the City’s community centers that will increase operating hours and provide more opportunities for Boston’s families. These changes take effect October 15.

“These operating shifts will allow our community centers to be open and fully staffed, offering programs when our families need them the most,” said Mayor Walsh. “Our community centers are important resources for residents, and all across the neighborhoods I have heard from people who would benefit from having more access to their neighborhood centers.”

Boston Centers for Youth & Families (BCYF) operates 36 facilities, including 20 free standing community centers and pool buildings and 16 based in school buildings. Over 2,500 people visit BCYF community centers daily. Shifting employee hours and redeploying some staff will allow BCYF to keep all free-standing centers open Monday through Friday, from 6:30 a.m. to 9 p.m. On Saturdays, the centers will be open 9 a.m. to 5 p.m. Five centers will be open seven days a week. BCYF centers in school buildings will operate from 2 p.m. to 9 p.m., Monday through Friday.

Select school sites will be open on Saturdays. Morning programs for children and seniors in school-based buildings will still be offered as will school vacation week and summer programs.

“Taking a critical look at our staffing levels and hours of operation

yielded these changes which will add value for our participants, add value to the neighborhoods and add value to our staff whose time will be better utilized,” said William Morales, Commissioner of BCYF.

This week, Danny gave "Pic's Picks" for Week 7 in the NFL:

As we enter Week 7, there's only one sure thing in the NFL: the New England Patriots will not only win, but they'll also cover. I took the Pats as a nine-point favorite at home over the Cincinnati Bengals. With their 35-17 win, it made the Patriots my most reliable pick of the season. So why run from them now?

Here are my picks for Week 7:
NEW ENGLAND PATRIOTS

(-7.5) over Pittsburgh Steelers

-Some here in New England are acting like Ben Roethlisberger's knee surgery is such a bad thing for the Patriots, because they might not have a "real test" before the playoffs begin. Well, last time I checked, the Patriots still play Seattle at home and the Broncos in Denver. Also, something's telling me that an injury to Big Ben isn't going to affect the Patriots in a negative way. If anything, it just makes the road to the No. 1 seed in the AFC that much more realistic. Sure, Roethlisberger's absence has increased the spread, but with the way Tom Brady is playing since returning from his Deflategate suspension, the Patriots would need to be a 21-point favorite for me to even think about scaring me away from this one. Pats win by 20 in Pittsburgh.

MINNESOTA VIKINGS (-3) over Philadelphia Eagles

-Another road favorite, the Minnesota Vikings are coming off their bye week as the only undefeated team in the NFL. I expect the Vikings' dominant defense to force rookie Carson Wentz to throw his second interception of the season. Wentz and the Eagles got off to a great 3-0 start, but since whooping the Steelers 34-3 in Week 3, losses in Detroit and Washington have taken Philadelphia back down to Earth. Against the two best pass defenses he's faced this year, Wentz threw for under 200 yards in each game: a Week-2 win in Chicago, and last week's loss in Washington. Now, he faces a Minnesota defense that has allowed a league-best 12.6 points-per game. And oh yeah, former Eagle Sam Bradford might have a little extra incentive to make this one sting for Philly. I can't bet against that.

OAKLAND RAIDERS (+1) over Jacksonville Jaguars

-The 4-2 Raiders are coming off a loss at home to the Kansas City Chiefs, a game in which Oakland scored only 10 points. I don't care that the Jaguars are riding a two-game win streak, the Raiders' offense is for real, and Derek Carr will prove just

that in a big bounce-back win in Jacksonville. I honestly expected Oakland to be a three-point road favorite in this one. At 2-3, Jacksonville is coming of a 17-16 win in Chicago. Before that, the Jaguars defeated the Indianapolis Colts 30-27 in London. I don't see those two wins as a sign that the Jags have arrived. What I do know is, the Raiders are here, and they are still at the top of a very tough division. Last week's loss to a solid Kansas City team won't be enough to ruin their season. Give me Oakland and the over.

KANSAS CITY CHIEFS (-7) over New Orleans Saints

-I just mentioned the Chiefs defeating the Raiders in Oakland last Sunday. Now, at 3-2, Kansas City returns home to host a 2-3 Saints team that just won two straight shootouts, scoring a combined 76 points in wins over the Chargers in San Diego and over Carolina at home. The Saints are the second-highest scoring offense in the NFL, putting up 31 points-per-game this season. But their defense has allowed the most points-per-game in the league at 33.6. The Chiefs' defense ranks 10th in the NFL, allowing 20.4 points-per-game. Knowing New Orleans can score,

the seven points might scare people away from the Chiefs. But with the game being in KC, I think the Chiefs make their defensive mark on the league with a statement win at home.

ATLANTA FALCONS (-6.5) over San Diego Chargers

-I picked Seattle to beat Atlanta last week, and I got that right. However, I also picked Seattle to win by six, and it was only a two-point win for Seahawks. It snapped a four-game winning streak for the Falcons, who have surprised me big time this season. At 4-2, Atlanta stands alone in first place in the NFC South. The Falcons' high-powered offense shouldn't have any problem scoring on San Diego. It's the highest over-under of the week at 53.5, and for good reason. Neither defense is any good, and the last time the Falcons were home, they scored 48 points in a 48-33 win over the Carolina Panthers in Week 4. Have fun trying to figure out the San Diego Chargers. They're coming of a 21-13 win over the Denver Broncos. But San Diego is 0-3 on the road this year, which nearly makes Atlanta the lock of the week.
