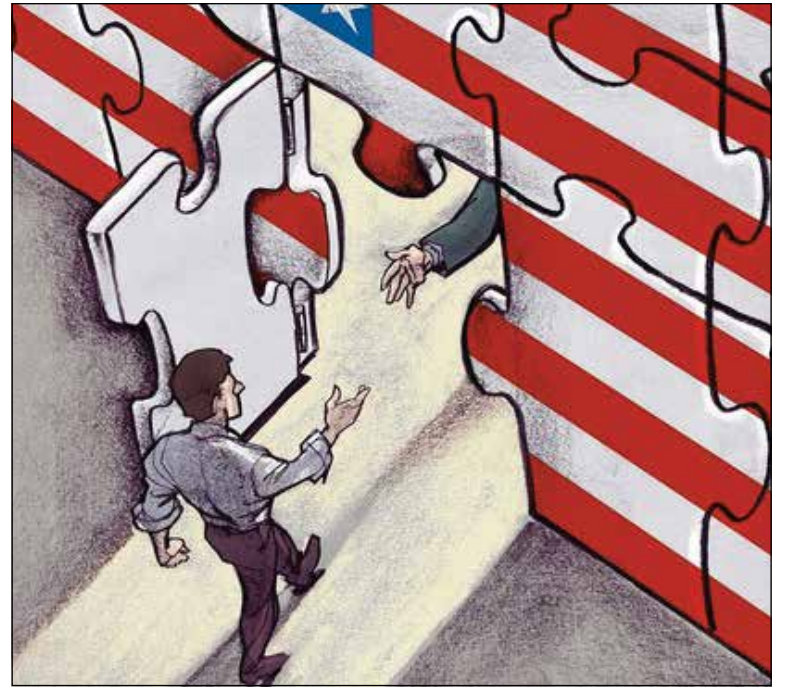
consequences."

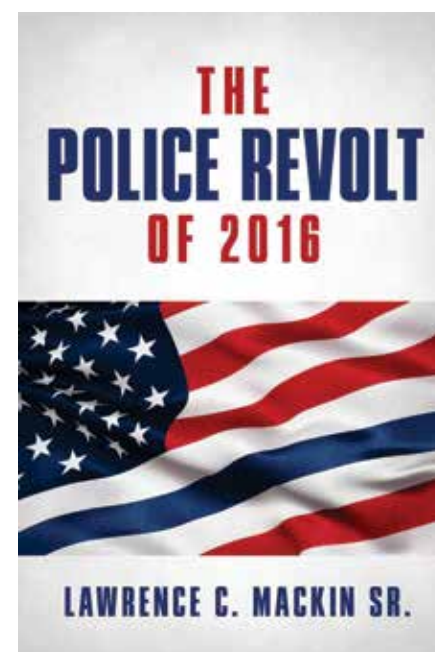

“Victory”

The early morning election result led to a sunrise visit to “M St. Park to share the victory with the 25 men on the Viet Nam Memorial, who gave more than anyone to win this day.

While it is true that they died in Viet Nam, that was not their war. They had nothing for or against the Vietnamese. Viet Nam could have been on the other side of Andrew Square for all most of them knew. Their world was Southie and what they were taught of America.

Their war began March 15, 1965. Prior to that day, America had been experiencing dramatic change. Many of these 25, as young teens, sat in front of black and white TVs, alongside their parents, horrified as black civil rights marchers were set upon by fire hoses, police dogs and riot police. Most were also filled with admiration for the people, led by Martin Luther King, Jr., who maintained a non-violent response and proving the justice of their cause. This only made our 25 lads love America more. Here was proof that while there was hate and injustice everywhere, even in America, America was the one place in the world that would confront its own shortcomings and seek to correct them.

At the same time the Civil Rights Act was being created, America was becoming more heavily engaged in a Viet Nam war that was explained to America as a battle between the ruthless Northern Communists and a peace loving Southern Democracy. The truth was hard to find and is still debated. Then, however, opposition was rising mainly on colleges. A draft, mainly among the working class, was supplying the combat

troops. For the most part the anti-war college protests were viewed from South Boston with disdain. At the same time, the right to do so was grudgingly acknowledged. After all, Muhamed Ali famously declared, “I ain’t got nothing against no Viet Cong,” and elected to be stripped of his title and go to jail rather than be drafted. A stance some disagreed with, but all admired Ali’s courage of conviction.

Too many college kids, however, were coming off as self-centered, pampered wimps unwilling to emulate Ali, but instead engaging in various forms of criminal acts. Among them blocking ports and military installations. The Black Falcon Terminal was both and when protestors singled out and tried to shut it down, longshoremen “detained” them until police arrived and arrested them. Their court date was months later in March. Why they chose Southie seems to be their correct perception that this was a town where fathers and brothers had always served, war or not. Where people were raised in and believed and cherished America’s Revolutionary history.

South Boston sons were already serving in harm’s way, so on that March morning on the steps of the Southie Courthouse, when those anti-war defendants arrived early and began taunting kids on their way to High School those same kids gathered and struck their own blow in the War and gave the demonstrators the beating they richly deserved.

While honest opposition to the war grew a small group of “leaders” engaged in plots and violence against the idea of America itself. One particularly loathsome group supported a plan to kill white peo-

ple, make it look like black killers, hatch a “race” war and emerge from the chaos and take over.

Some of these same believers tried to blow up a Christmas party at Ft. Dix, targeting soldiers and their families. A few managed to go on the run after detonating a bomb accidentally killing most of these anarchists in 1970. Going “underground”, these America haters changed their tactics. Like rot in the beams of a house they wormed their way into America’s institutions.

By 1974, the 25 looked down with sadness as they saw their beloved South Boston High sacrificed allegedly to ensure racial integration, but, in reality, a device to destroy the social and cultural anchor of the town and its pride. The war continued Christmas, another mainstay of American culture, was attacked.

The rot spread as the haters, like a fungus, spread into all aspects and levels of society. Colleges first began the breeding ground of this hate.

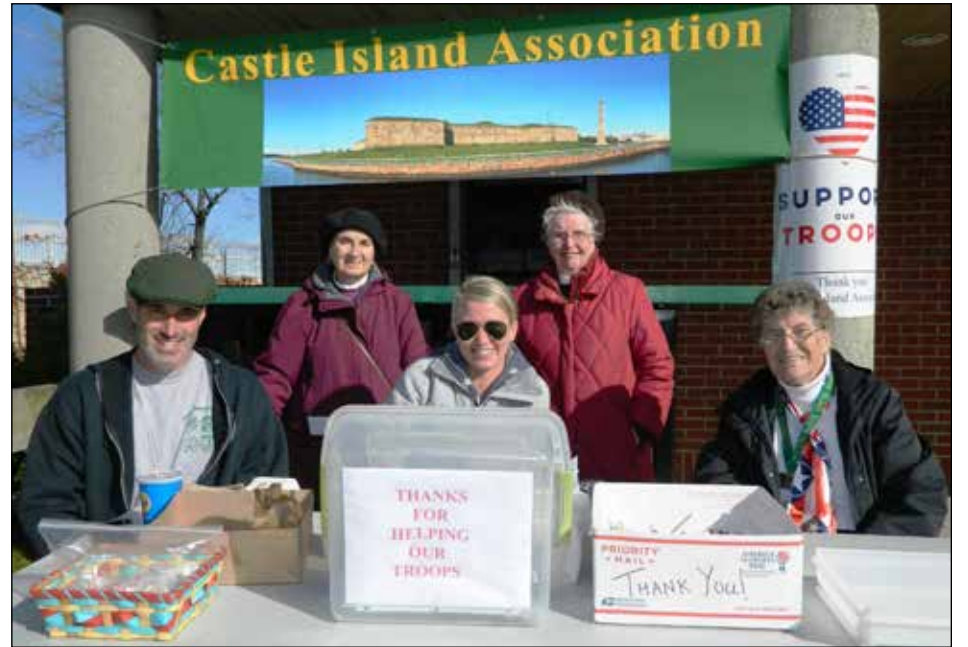

Mayor Walsh Celebrates Patriot Homes Veterans Housing

Mayor Martin J. Walsh joined Congressman Stephen Lynch, Councilor Bill Linehan, Senator Linda Dorcea Forry, Representative Nick Collins, Veterans Affairs Commissioner Giselle Sterling, the South Boston Neighborhood Development Corporation and Caritas Communities, Inc. to celebrate the dedication and ribbon cutting for Patriot Homes in South Boston. The

more than \$12 million redevelopment of the former City of Boston C6 police station will create 24 new affordable apartments for veterans.

"Our veterans who have fought to uphold the values of American freedom deserve access to safe, affordable housing," said Mayor Walsh. "By working with South Boston Neighborhood Development Corporation and our partners, we were able to transform an

underutilized City-owned property into housing for veterans. Through this project, we are one step closer to housing all our Boston veterans."

The 16,979 square-foot development included the rehabilitation of the former South Boston C6 Police station into 12 units, and including the new construction of 12 units on Athens Street which created a total of 24 affordable housing units. The new

housing has 12 studios, 2- 1 BR and 10 - 2BR apartments geared to the Veteran community. Six units will serve veterans at or below 30% AMI, while eight units will serve veterans at 50% AMI and ten units will be for veterans earning 60% AMI. Residents will also benefit from a multipurpose community room, and the South Boston Neighborhood Development

Corporation will also occupy one of the building's two ground-floor commercial spaces.

In accordance with the City of Boston's Green Affordable Housing Program, the redevelopment of former station utilized several green building design techniques, earning it the distinction of being LEED-Homes "Silver" certified by the U.S. Green Building Council. The project also meets the U.S. Environmental Protection Agency's Energy Star standards.

"South Boston has a long history of military service and a higher percentage of Veterans than many other neighborhoods in the city," said Donna Brown Executive Director of South Boston NDC. "With rents rapidly increasing, Patriot Homes will help deserving Veterans to continue to live here, in our community, with the resources they need. We are grateful to have had strong support from the City of Boston, as well as the Commonwealth of Massachusetts, to complete this project."

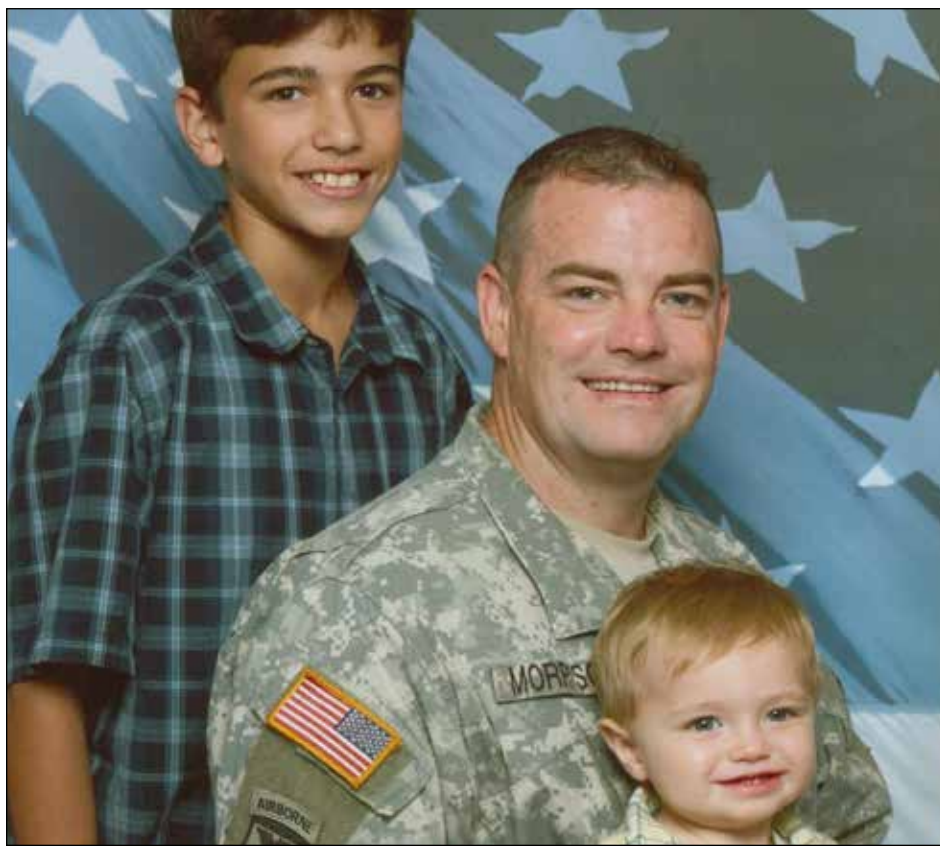

This week, Danny gave "Pic's Picks" for Week 11 in the NFL:

Usually, this late into the season, everyone has at least one team that they just stop putting their money on. Well, for me, entering Week 11, that team is the Green Bay Packers. They've lost three straight, and I've had them as part of my picks the last two weeks. I'm officially done with Green Bay.

Who am I relying on this weekend? Read up, I'll tell you about it. Here are my picks for Week 11:

MINNESOTA VIKINGS (+1) over Arizona Cardinals

-What in the world happened to the Minnesota Vikings? They began the season 5-0, but have since lost four straight, and are coming off a 26-20 loss to the Washington Redskins in Week 10. They return home to take on a 4-4-1 Arizona Cardinals team that just barely beat the San Francisco 49ers on Sunday. -I said it before the season began, and I'll say it again: nobody is talking about the Baltimore Ravens, and it kind of scares me. Now, do I believe they'd be able to come into Gillette Stadium and knock off the Patriots in a playoff game? Not at all. But they certainly have the ability to make it interesting. And at 5-4, they'll make it interesting this Sunday in Dallas against an 8-1 Cowboys team that has officially moved on from Tony Romo. Dallas has won eight straight, and is coming off a wild 35-30 win over the Steelers in Pittsburgh. Baltimore has a defense that can keep this one close. And while I'm not convinced the Ravens can pull off the upset on the road, having the best run defense in the league has to be worth something against the best running back in the world. I'll say take the Cowboys to win the game, but this one will be close, so I'll take the points.

MIAMI DOLPHINS (-1.5) over Los Angeles Rams

-It sounds like the LA Rams

will be turning to No. 1 overall pick Jared Goff at quarterback in Week 11. The 4-5 Rams host the 5-4 Miami Dolphins. And while Goff's NFL debut will be the talk of the town, Rams fans shouldn't completely overlook the fact that Miami has won four straight and is coming off a 31-24 win over the Chargers in San Diego. Meanwhile, LA just barely beat Bryce Petty and the lowly Jets 9-6 in Week 10. This isn't an impossible game for the Dolphins to win. I'm not in love with either team, but I'll take the streaking Dolphins with a low spread over a QB making his NFL debut.

SEATTLE SEAHAWKS (-6.5) over Philadelphia Eagles

-Both the Seahawks and Eagles are coming off huge wins against overpowering offenses in Week 10. Seattle went into New England and defeated the Patriots 31-24, and Philadelphia defeated the Atlanta Falcons 24-15 in Philly. Now, they'll meet in an NFC battle in Seattle, where the 6-2-1 Seahawks are 4-0 this season. The Eagles are 1-4 on the road, and I would never pick them to win this game, even though I did correctly pick them last week to beat the Falcons. Seattle should win this one by seven, which

would be just enough to cover.

NEW ENGLAND PATRIOTS (-13) over San Francisco 49ers

-You know it's a bad week for picks when the only sure thing in the NFL lets you down. That's what happened in Week 10, as the Patriots lost to the Seahawks at Gillette Stadium. The Pats were obviously favorites to win that game, but it didn't work out as I thought it would. So, now what? Well, first and foremost, even after Sunday night's loss, the Patriots are still the No. 1 seed in the AFC with a 7-2 record. And there's no AFC opponent for New England that brings to the table what Seattle does, both offensively and defensively. So, big picture, the Patriots are going to be just fine. I mean, it could be much worse. They could be the 49ers, who have lost eight straight after winning their first game of the season. San Francisco allows the most points per game in the NFL at 31.4.
