




## *Could Super Bowl LI Patriots Victory Become A Trojan Horse?*

## Window Into The State House

Window Into The State House provides our readers a synopsis of important issues of interest, past and current, that are being proposed, debated or acted upon by the Massachusetts Legislature. Many issues that are not related to local city government services are acted upon and have a direct impact on daily life. They are tax policy, transportation infrastructure, judicial appointments, social services and health, as well as higher education. We will excerpt reports from the gavel-to-gavel coverage of House and Senate sessions by news sources focused on this important aspect of our lives. These sources include a look ahead at the coming week in state government and summaries and analyses of the past week, re-caps of a range of state government activity, as well as links to other news.

### ‘Journalists can’t run around with their hair on fire for the next four years’

Medic critic Dan Kennedy has been following the harsh criticism of Donald Trump by conservative Tom Nichols, a professor at the Naval War College and Harvard Extension School, and thinks he’s earned the right to also criticize the media’s often over-the-top coverage of Trump. Dan: “There are multiple reasons to think that Trump represents a unique threat to democracy. But journalists can’t run around with their hair on fire for the next four years. The best way to cover Trump is with calm, fact-based reporting — not with hyperbole that does not hold up to scrutiny.”

### Watertown historian: Bannon not only thrives on crisis, he firmly believes in its historic inevitability

Instead of running around with their hair on fire, maybe members of the media can slow down to actually try to understand what makes Trump’s supporters tick. Dana Forsythe at Wicked Local has done just that by interviewing Watertown historian David Kaiser, who discusses how he once talked with current White House aide Steve Bannon for Bannon’s documentary “Generation Zero,” which basically follows a theory by amateur historians that says America is hit about every 80 years with some sort of catastrophic crisis. The idea is key to understand-

ing Bannon, Kaiser says.

### Why is the left embracing the right-wing’s anti-Warren meme?

WBZ’s John Keller, writing in the *Globe*, isn’t overly surprised that conservatives are bashing away at U.S. Senator Elizabeth Warren. But why are many liberals also bashing away? From Jon: “The irony is striking. Amid a golden age of political trash talking, the leading female critic of the political establishment is cast as a somewhat unhinged hypocrite by the right, a meme now being channeled by the left.” The answer, we think, is partially tied to the fact that most of her critics, left and right, are ideological purists.

### Lynch hears it loud and clear from constituents: Start opposing Trump -- or else

The moderate U.S. Rep. Stephen Lynch, who faces a primary challenge from the left next year in the Democratic primary, got an earful from constituents in Milton last week, some of whom demanded to know what’s he doing to do to oppose President Trump, reports Mike Deehan at WGBH. “You are in a very safe district,” one constituent told Lynch. “We have a strong history of liberal causes and fighting tyranny. ... Be out there, and we want to see you. Take this guy and hold this guy’s feet to the fire.”

### ‘God of persistence, God of ... our own modern day patriots’

Speaking of SHNS, our friends there sent us this prayer that House Chaplain Father Rick Walsh apparently offered yesterday (bold emphases are his):

“House Prayer - February 6, 2017 -- God of persistence, God of hope – we pray today for the members of our legislature. Today we celebrate and honor the historic achievement of our own modern day patriots. Just when our hopes were deflated, we witnessed a performance of super proportions. May the members of

this House be ‘embradied’ to champion seemingly lost causes and to persevere in their team efforts to craft just legislation and to promote bills that are creative and strategic. May God continue to bless our Commonwealth.”

### Bitter embarrassment: *Globe*’s early edition prints wrong Pats outcome

Far be it for MASterList to point out others’ mistakes (see our last buried item today on our own Pats coverage), but this one is a whopper, as reported by Jen McCaffrey at MassLive: The *Globe*’s early editions in Florida got the Super Bowl outcome wrong, with the massive headline “A Bitter End,” apparently written and printed before the Pats’ spectacular come-from-behind Super Bowl victory on Sunday. ... The Herald’s Howie Carr pounced on the blunder.

### Skepticism greets Patrick’s ‘absolute privilege’ claim at SJC hearing

At least one Supreme Judicial Court justice at a court hearing yesterday didn’t appear overly impressed with claims by attorneys for Deval Patrick that the former governor is protected by “absolute privilege” from defamation suits connected with his duties as governor, reports the Herald’s Bob McGovern. “What if we had a governor who had no respect for the truth and in a situation like this said: ‘I fired this person because we found child porn on her computer?’ said SJC Chief Justice Ralph Gants. ‘It turns out to be totally false and absolutely defamatory.’” McGovern has all the details of the case.

### Healey shifts her focus west and beyond

Attorney General Maura Healey is throwing her support to a lawsuit in Washington state that’s seeking to block President Trump’s controversial immigration rules, now that a similar case in Boston appears moot, the Herald’s Chris Cassidy reports.





## Jimmy Flaherty Kick-off Breakfast Set for Saturday February 25th, 2017



### Federal judge launches probe of fee padding by law firms

From the Globe’s Andrea Estes: “A federal judge plans to appoint a special master to investigate whether prominent law firms in Boston and other cities padded their legal bills by millions in a class-action lawsuit against State Street Bank, saying

the lawyers may have to pay up to \$2 million, in advance, to fund the investigation.” The fee of the managing partner’s brother jumped from \$53 an hour as a court-appointed lawyer to \$500 an hour, Estes notes. **Won’t be missed: T gives heave to parking-lot operator**

From Commonwealth’s Jack Sul-

livan: “The MBTA’s oversight board voted to approve a potential 15-year contract with one of the country’s biggest parking management companies, ending a troubled relationship with its longtime lot operator that resulted in missing revenues that went into the millions.” At least the vendor won’t be missed.



## ‘BRING YOUR OWN BOTTLE’ PERMITS AVAILABLE

Mayor Martin J. Walsh and the City of Boston’s Licensing Board announced that applications for ‘Bring Your Own Bottle’ (BYOB) permits are now available online for restaurants who meet certain eligibility requirements. Applications will be accepted beginning on Monday, February 6.

“For the first time in our city’s history, restaurants are allowed to take advantage of BYOB,” said Mayor Walsh. “This measure will bring increased economic opportunity to Boston’s neighborhood restaurants and help our city’s economic growth overall. I would like to thank the Boston City Council and Boston Licensing Board for their work on this initiative, and look forward to the great results.”

“I’m excited to see Boston officially open license applications for BYOB, creating a new way

for neighborhood restaurants to thrive and more options for consumers to dine local. Thank you to Mayor Walsh and the Boston Licensing Board for working with the City Council to make this a reality for our city,” said City Council President Michelle Wu.

A restaurant who wishes to apply must meet the following eligibility requirements:

- Common Victualler license holders must obtain a BYOB permit prior to allowing patrons to bring alcoholic beverages into their premise;
- Common Victualler license holders with a capacity of 30 or less may apply;
- Only Common Victualler license holders who offer on premise dining with table service provided by wait staff may apply for a BYOB permit;
- Restaurants holding any type of alcoholic beverage license granted by the Licensing Board

or the Massachusetts Alcoholic Beverages Control Commission (ABCC) are not eligible to hold a BYOB permit;

- The licensee, manager of record and all employees must complete an in-person, insurance industry-approved safe service of alcohol training program, prior to issuance of a BYOB permit;
- Restaurants in the Downtown, North End, South End, Bay Village, Fenway, Chinatown, Seaport, West End, Beacon Hill and Back Bay neighborhoods are not eligible.

Patrons dining at a restaurant that obtains a BYOB permit may only bring no more than 750ml per person of wine and 64 oz per person of malt beverages. Distilled spirits, liqueurs and cordials are not permitted.

Once a BYOB application is filed with the Boston Licensing Board, a hearing will be scheduled.



## Helipad Construction on Hold: An Update

For those following the issue of the proposed Boston Helipad and haven’t yet heard, the building of it and the location are both on hold, at least for now.

It seems that city and state officials were listening and paying close attention to objections raised by not only local residents but also business owners who have voiced strong concerns at the least and some outright opposition.

The hearing on the project which was scheduled for last Monday, which would have been the second meeting, was cancelled with no word as to when or if there will be another.

The Raymond L Flynn Marine Park was the proposed site of the helipad but concerns about noise and traffic and even if there was a need at all for it, considering the area’s close proximity to Logan Airport and the Ted Williams Tunnel have put all plans in limbo.

The proposal for the Helipad was made as part of a 120 million dollar incentive to bring the General Electric Company to Boston. These funds would come from State Funds; taxpayer’s money which is another reason for opposition on the part of some residents. Officials have now stated that other potential sites for the helipad will be considered in the ongoing search for a suitable location.

A recent article in the Boston Globe had a quote from Jay Ash, who is an economic development aide to Governor Baker saying the following: “We want to make sure we’re doing the right thing. GE would benefit from it but so would other companies.”

Doing the right thing is by far what is needed. Said one local opponent of the Helipad in response to the comment by Ash: “Doing the right thing should always be the way to go. And listening to the legitimate concerns of impacted businesses and residents should always be a priority before considering any project in the City of Boston or anywhere else for that matter.”

So as it stands at this time, the Helipad is on hold with no decision made at the current time as to its future - at least publically.


The National Honor Society Officers welcomed the guests and





Super Bowl LI Patriots Victory

Boston's history has always attracted it fair share of tourists, especially families and conventioners visiting the USS Constitution, Faneuil Hall, Tea Party, Plymouth Plantation and the Mayflower, Old North Church and the Freedom Trail. But the growing sports dynamic that has had owners investing millions in its venues, a la an expanded Fenway Park, TD Bank Garden and Patriot Place, has enlivened the discussion about siting a soccer stadium to bring Major League and World Soccer to the burgeoning international population of Greater Boston. Super Bowl LI has likely emboldened the owners of the New England Patriots, who also own MLS New England Revolution, to move aggressively on bringing a 5th major professional team to Boston in the hope of enhancing the prospect of adding to its market growth and international appeal.

Major League Professional Sports is big business, in general. Soccer, in many big cities worldwide, is, comparatively, almost as big as Major League Baseball and as big as the NBA and NHL combined. To quote our new President – It's Yuge! In the United States, the NFL generated



\$13 billion. The MLB generated \$9.5 billion. ML Soccer, \$3 billion; plus, the Premier Soccer League, \$5.5 billion: total \$8.5 billion. The NBA, \$4.8 billion. The NHL, \$3.7 billion; combined, \$8.5 billion. The NFL outpaces them all.

The Kraft Group is a savvy enterprise. A new and market-appropriate size stadium is only part of the formula, but a necessary one. The real value is in the opportunity for merchandising to a rabid soccer constituency here in Greater Boston. As has been reported here, the stakes are high for The NE Revolution and the Krafts,



but they are just as high for the City of Boston, UMass Boston and the future of the real estate holdings around Columbia Point, which is the target of their game plan. If the positive effect of Wynn Boston Harbor on Somerville and Everett's job opportunities and real estate values are as significant as predicted, then any remaining opposition here could be mitigated over time, if Kraft uses the same strategy.

With the fan euphoria so high after the Super Bowl victory and celebration, it is easy to understand the power that successful sports teams have over human psyche, impulse buying, community

spirit and the attendant mass marketing strategies of advertisers. It possibly rivals even politics and elections.

Robert Kraft instinctively knows this and the Super Bowl LI historic comeback tale may emerge as a psychological boost for the acceleration of negotiations among the stadium stakeholders, but could become a Trojan horse for unsuspecting residents of the Dorchester and South Boston, who are likewise not immune from the effect of euphoria. Again, residents would do well to pay attention to the process. Remember, sports is big business.



That's right, trailing 21-3 at the half, I still felt as if the Patriots had a chance to win. I wasn't happy, by any means, but I knew that Brady wasn't going to go down like this.

Then the third quarter began. The Patriots forced the Falcons offense to a three-and-out on the first possession of the second half.

Here we go. This was it. The Patriots were going to march down the field and make it 21-10.

Not so fast.

As Julian Edelman dropped a pass right in his hands on 3rd-and-12 at their own 45-yard line, I started to lose hope. The Patriots had a golden opportunity to get back in the game, and instead, they went three-and-out.

Atlanta then drove 85 yards and scored its fourth touchdown of the game, taking a commanding 28-3 lead with 8:31 left in the third quarter.

If that wasn't the moment I gave up on the game, then Julian Edelman's incomplete cross-field double-pass on 3rd-and-3 during the ensuing possession was. Brady took the snap and threw it slightly behind him and to his left, where Edelman caught it and then sent a pass of his own across the field to a streaking Dion Lewis down the right sideline.

The incomplete pass brought up a 4th-and-3 at the Patriots 46-yard line. It also had me wondering how I could keep hope alive if the Pats had already given up. And to me — even though Edelman was a quarterback and college and has completed this type of pass before — if that's the play they drew up on third down with the Super Bowl on the line, then they had essentially

pulled out all the stops.

And if they couldn't beat them with the kitchen sink, that would be the unfortunate end to the season.

Then Brady found Danny Amendola on 4th-and-3 for a first down. Seven plays later, James White scored the Patriots' first touchdown of the game. When Gostkowski missed the extra point, I still didn't feel too good while trailing 28-9 with two minutes left in the third quarter.

The Patriots forced the Falcons to punt, and Gostkowski's second field goal to make it a 28-12 game with 9:44 left had everyone playing out the scoring scenarios in their head.

"Get a turnover, score a quick touchdown and a two-point conversion, get the ball back, and score another touchdown with no time left, and tie the game with another two-point conversion."

Almost as fast as you could play out that perfect scenario in your head, Dont'a Hightower hit Atlanta quarterback Matt Ryan on 3rd-and-1 and forced a fumble, which was recovered by New England defensive lineman Alan Branch at the Falcons 25-yard line. And five plays later, Brady found Amendola for a touchdown with 5:56 left in the fourth quarter. Then, James White ran in a direct snap for a successful

two-point conversion to make it a 28-20 game.

Time was still a factor. So when the Falcons drove down to the Patriots 22-yard line, it was a sobering moment, realizing that they were suddenly in field-goal range, and a field goal would have ended the game.

But after Trey Flowers sacked Ryan for a loss of 12 yards, and an offensive holding call pushed Atlanta back to the Patriots 45-yard line, a comeback was once again realistic.

Atlanta pinned the Patriots inside their own 10-yard line with a punt, giving Brady 3:30 to drive 91 yards, score a touchdown, and put in another two-point conversion.

That's exactly what he did, and the Patriots tied the game at 28, sending it to overtime, where Brady cemented his legacy as the greatest of all time.

Brady led an eight-play, 75-yard drive and James White dove into the end zone, just far enough to get the ball to cross the goal line, and the Patriots completed the greatest comeback in Super Bowl history.
