Track 61 Project In Fort Point/ Seaport Has Conditions Imposed

rack 61 is on some kind of track. The questions in the minds of the residents, who are directly affected by what happens there, are both how the MBTA construction process will affect the quality of their health and safety and the enjoyment of their homes; and what is the future of the rail, once the Red Line testing program is completed.

The Boston Conservation Commission has produced a list of

conditions that are to be imposed on the pre-construction and construction phases related to environmental aspects of the project. These aspects relate to dumping, disposal, dust containment, demolition, wetland resources, drainage, erosion control, sediment containment, storage of hazardous material, rodent control, flood control, equipment monitoring, fluid discharge, staging, snow management, on site management,

oil spill management and prevention and fuel tank storage security. There is a further stipulation that everything needs to be taken out and down when the testing is done. This oversight affirms the fact that the Track 61 project is moving forward.

Back in 2013, the project was under serious consideration and had been quietly placed on a fast track, because the state already owns

Miss Massachusetts looks to unseat Cape Republican

Now for a completely different kind of pageant: The reigning Miss Massachusetts has launched a campaign to unseat Republican Rep. David Viera of Falmouth in the 3rd Barnstable District, Geoff Spillane of the Cape Cod Times reports. Elizabeth Barlow, a Democrat, is a manager at the American Red Cross and the wife of an active Coast Guard cadet.

Kafker sworn in as newest SJC justice, following retirement of Hines

With little fanfare, Supreme Judicial Court Justice Geraldine Hines quietly retired last Friday, a few months before her mandatory retirement at the age of 70, ending her distinguished tenure as the first African-American woman to serve on the SJC, as reported at MassLive.

Yesterday, Scott Kafker, the former Appeals Court chief justice, was sworn in as her replacement in a private State House ceremony, according to the governor's office, as reported by SHNS's Katie Lannan at the Salem News. The appointment of Kafker, a Swampscott native who was nominated by Gov. Charlie Baker and who once served with Baker in the Weld administration, was previously approved for the SJC post by the Governor's Council. Kafker is now the fifth justice Baker has placed on the high court bench, Lannan notes.

Armed militia member among those arrested on Saturday

How close was Boston to becoming the next Charlottesville? Closer than many skeptics seem to appreciate. Besides the arrests of a slew of left-wing extremists at Saturday's Boston Common right-wing rally and counter-rallies, an out-of-state member of the Liberty State Militia was arrested for bringing body armor and a gun to the event, reports the Herald's Marie Szaniszlo. Can't stress this enough: Boston dodged a bullet on Saturday, figuratively, if not literally. There's a long, ugly history of extremists on

both sides violently going at it at such events.

Artists, historians and Alex Beam: Maybe slow down a bit on the post-Charlottesville cultural revolution?

Though they have no sympathy for far right-wing causes, many artists, museum curators and historic preservationist are getting increasingly nervous about the speed with which some Confederate statues and memorials are being taken down across the country in the wake of the Charlottesville tragedy, reports the New York Times. Ditto for many historians, reports the Boston Globe's Michael Levenson. The Globe's Alex Beam hates to admit it, but he says maybe Donald Trump was right when he suggested that after the Robert E. Lee statues are toppled, next to fall might be the statues of George Washington and Thomas Jefferson. It's already going beyond ex-Conderates and slave owners. Some are now going after Teddy Roosevelt.

'Then compassion replaced resentment'

The Globe's Steve Annear has a nice follow-up piece on Imani Williams, who helped save a Donald Trump supporter from a rough and ugly crowd at Saturday's Boston Common rally, even though she was there as a counter demonstrator to the right-wingers. Among her new admirers: author JK Rowling.

Holyoke school district, state hit with suit alleging discrimination against Latinos

A federal lawsuit alleges human rights violations and discrimination by the Holyoke Public Schools for failing to provide parents who speak limited English adequate translation services for a wide range of documents related to their children, including notices of meetings, evaluations, disciplinary notices and other materials, reports Michelle Williams at MassLive. The Massachusetts Department of Elementary and Secondary Education, the state education board and Holyoke public behools receiver Stephen Zrike are among those named in the suit.

T officer gets six months for beating Roxbury woman

From Bob McGovern at the Herald: "The former MBTA police officer convicted of beating a Roxbury woman at Dudley Square Station and then filing false reports will spend at least six months behind bars after a judge said he wanted his sentence to send a message. 'These crimes go to the heart of the honest public service that we have the right to demand from the police officers who exercise very substantial powers,' Suffolk Superior Court Judge Douglas Wilkins said."

Kennedy Compound, meet Shriver Compound

The Kennedy family empire on Cape Cod has geographically expanded. Timothy P. Shriver, the son of the late Eunice Kennedy Shriver, and his wife, lawyer Linda S. Potter, have bought a \$3.3 million, six-bedroom abode in Hyannisport, a half mile away from the famous Kennedy Compound, reports David Harris at the BBJ.

Lindstrom officially declares Senate candidacy, bemoans D.C. 'finger-pointing'

As expected, Beth Lindstrom, a former executive director of the state Lottery and former head of the state GOP, yesterday officially declared she was a candidate for the U.S. Senate, positioning herself as an "independent-minded Republican" and calling for the end to "trading insults" and "finger-pointing" in Washington, reports SHNS's Katie Lannan at the MetroWest Daily News. Lindstrom joins state Rep. Geoff Diehl, entrepreneur Shiva Ayyadurai and, possibly, businessman John Kingston in seeking the GOP nomination to take on U.S. Sen. Elizabeth Warren, a Democrat.

Berkshire Eagle story on decades-old abuse opens victim floodgates

Over the weekend, Berkshire Eagle reporter Bob Dunn published a disturbing and deeply reported story detailing allegations of sexual abuse in the 1970s by a former school custodian in Adams—some of which were confirmed by the now 94-year-old former custodian himself. Dunn now reports that five more men have stepped forward in the days since the story ran, saying they too were victimized.


PREGNANT WORKERS FAIRNESS BILL SIGNED INTO LAW

State Senator Linda Dorcena Forry and State Representative Nick Collins recently joined their colleagues to pass a bill that would ensure pregnant workers are given reasonable accommodations in the work place. The Legislature sent it to the Governor's desk where it was signed into law last week. I am immensely proud to support this bill that is important to women, important to families, and

important for our Commonwealth" said Rep. Collins. "This is the right thing to do to support healthy families and secure fundamental rights to reasonable accommodation. I am proud to work with my colleagues in the legislature, Senator Forry and Governor Baker to make this law."

The legislation makes it illegal for an employer to discriminate against, refuse to employ, or terminate an individual due to pregnancy or a condition related to pregnancy. Although some employers voluntarily abide by these standards, solidifying these regulations into law guarantee these rights to all women employed anywhere in the Commonwealth. Reasonable accommodations may include time off to recover from childbirth; more frequent, longer paid or unpaid breaks; procuring

or modifying equipment or seating; obtaining temporary transfer, job restructuring, or lighter duty; and private non-bathroom space for expressing breast milk, among others. The bill directs companies to engage in a collaborative, good faith process with employees and prospective employees to determine effective and reasonable accommodations, and goes into effect in April 2018.

Many of South Boston's young people will be heading off to college as either returning students or freshmen. It's the end of summer rite of passage that has heads swirling with all the preparations and final touches needed to make the move. It's hectic and at times can be mind boggling. But, this time of year also comes with something else regarding what should be considered their civic duty by people of every age group, including departing students – VOTING.

Yes, voting is a right for every citizen over the age of 18 to take serious and make a priority. And just because you may not be at home on primary day or final Election Day does not mean you cannot

vote and make that vote count. You can vote by absentee ballot, in advance, and make your voice heard for the candidate of your choice.

This year's municipal elections are promoting the interest of many. Some great candidates will be on the ballot from the mayoral races to candidates for the Boston City Council; both at-large and district. If you are a student who will not be in Boston during this year's primary or the final election, read on to learn how to vote by absentee ballot.

To vote before you leave for school or even if you are not a student and will be out of town on a trip, you can go in person to the Election Department at Boston City Hall and fill out a ballot. Bring an ID with you. Hours to do this are Monday through Friday from 9am to 4:30pm. It only takes

a few minutes to do.

You can also go online to boston. gov/election, click on the 'absentee ballot' link and download a form and request an absentee ballot be sent to your home address. You can even call the city hall main number at 617-635-4000 and ask that an absentee ballot be sent out to you.

When you receive the ballot, it will ask for the reason for wanting/needing to vote absentee. Again, as long as you are over the age of 18, are an American citizen and have been living in Boston with a permanent address since November 8th, 2016 you have the right to vote in this year's Boston primary and final election.

But there is another requirement. You must be registered to vote. If you are not yet registered and want to do so, and South Boston Today urges everyone to do so, you have until September 6th to register if you want to be able to vote in this year's primary which will on September 26th. To vote in the final election this year, you'll need to register by October 18th. This year's final election will be held on November 7th. You only need to register to vote once. Then you are on the rolls to vote from then on. There is no need to register for future elections unless your information; address etc changes.

Voting by absentee is quick and easy and the perfect way to make your voice heard if you cannot go to the polls in person. Again, it's your civic duty, generations of patriots have fought and died to give every American citizen this right. We honor those who fought for that right by voting.




Flynn Testifies On Used Drug Needles And Public Safety

Flynn said, "Combating addiction and supporting those in recovery is critical to saving lives and making our city a safer and healthier place to live and raise a family. I applaud Councilor Essaibi-George, Councilor Flaherty, and Mayor Walsh's efforts to tackle these pressing public health and public safety issues. For the past decade, I've worked closely with residents whose lives have been ravaged by addiction, and I want to continue this advocacy as City Councilor. Furthermore, I want to make sure that all residents of District 2 always feel safe in public spaces where they live, work, and play."

Mayor Walsh Issues RFP For Creative Industries Program

To create pipeline for Boston residents to jobs in the creative industries

o create pipeline for Boston residents to jobs in the creative industries Mayor Martin J. Walsh announced the City of Boston has issued a Request for Proposals (RFP) for a consultant to design and implement a Creative Industries workforce development program within the Mayor's Office of Workforce Development (OWD). The initiative is a joint venture between OWD, Emerson College and the Massachusetts College of Art and Design (MassArt) and will identify how to create opportunities for Boston residents to gain employment in the Creative Industries.

The RFP builds off of a core component of Mayor Martin J. Walsh's Boston Creates Cultural Plan to prioritize, coordinate, and align public and private resources to strengthen the City of Boston's creative capital over the long term. The City of Boston will provide \$75,000 in funding for the execution of this feasibility study.

"In order to support and strengthen our creative industries sector, and to work to diversify its ranks, we must ensure that our young people and adults can access pathways to the careers where there is a demand," said Mayor Walsh. "I thank Emerson and MassArt for their partnership on this important initiative that will bring together public and private resources to create more opportunities for our residents."

"Emerson College is excited about the possibilities and opportunities this new partnership with the City of Boston could bring to area residents and the local creative economy," said Ruthanne Madsen, Vice President for Enrollment Management at Emerson College. "The findings of the study could assist us in identifying new educational pathways and programming to support student access, community engagement, and cultural enrichment."

"This partnership enables MassArt to better achieve our mission -- to prepare students from diverse backgrounds to participate in the creative economy," said Daniel Serig, Associate Vice President for Academic Affairs at MassArt. "Boston students need and deserve access to these careers that continue to grow and expand."

The report will be used to increase knowledge within Boston Public Schools, to create more opportunities for Boston's young people to access careers in the creative economy. In a recent report, the Boston Planning & Development Agency found that creative employment in 2014 totaled 29,762 jobs in business establishments - this is 5.4 percent of Boston's total private sector payroll employment. An additional 6,483 people were self-employed in the creative industries. Including this self-employment measure, Boston's Creative Economy totals 36,254 workers. The 29,762 workers on payrolls across Boston took home over 2.4 billion dollars combined, averaging \$81,179 in annual wages. The RFP was released on Monday, August 21 and proposals are due by September 21 at 5 p.m.

About Boston Creates

In June 2016, Mayor Walsh announced the Boston Creates Cultural Plan, a ten-year initiative that will align public and private resources to strengthen cultural vitality over the long-term, and weave arts and culture into the fabric of everyday life. Cities with high levels of creative capital encourage, reward and integrate imaginative thinking into all aspects of community life. Boston wants to better understand the creative capital of Boston and develop a plan that will prioritize, coordinate, and align public and private resources to strengthen this creative capital over the long term.

our crowded streets.



The Wine Guy

Look on the White Side!

s I'm writing this column, which I believe you'll see on August 24th, it's the weekend before, a Friday afternoon and the burning question in my small, but focused mind is: "Red or white?". It's breezy, but trying to become more humid, so I'm leaning towards the whiter side of things. Take a further look to see some wines that will get you enjoyably through the last days of August and into Labor Day.

If you think it's been hot in our area lately, it's been far worse in Tuscany, where temperatures have been in the high 90's for much of the summer. But the people there don't seem to mind; and, why should they? When they've got white wines like the 2015 Dogajolo Toscano Bianco, I.G.T., (\$13.99). It's a centuries-old recipe of Northern Italian Chardonnay, blended with a slightly sweet Grichetto and drier Sauvignon

Blanc. Floral and herbaceous notes on the nose and a really nice finish combine to make this one a natural for anything with cheese on it or in it. You can also have it with shellfish and white meats.

Over in France right now, the hot and breezy days and nights, (especially in the South, where the "Mistral" comes down from the mountains in the north) demand a white of stature and body. While wines from Burgundy usually come to mind, I wanted to point out a region that isn't usually associated with white wine, but really should be. In the Rhone Valley, best-known for its reds, there are some tremendous whites. One of the best is the 2014 Domaine Alain Graillot Crozes-Hermitage Blanc, (\$28.99), a native grape white with all the right components-great balance, low acidity, supple notes of pears, apricot and honey. A seriously long finish makes this one



easily complement to duck, pheasant, quail or cornish hens. They've been making wines in this region for over 1,000 years, so they've had plenty of time to get it right!

Moving further east, France's Alsace-Lorraine offers some of the best Rieslings on the planet. This region is also an ancient one, with Roman historian Pliny noting the quality of the area's wines nearly 2,000 years ago; probably the last time an Italian paid a French wine a compliment!

The Hugel family, located in the beautiful town of Riquewihr, have been making wine for almost four hundred years and their 2015 Riesling Classic, Famille Hugel, (\$21.99), is the epitome of all of this region's best- supple flavors of honey, pear and melon with the structure to let it complement any kind of poached or grilled seafood.

Another one of the most famous

family labels in this area is that of the Trimbachs, who've been making some of the world's best wines since 1626-thirteen generations. From the current line of Reserve wines comes their 2014 Trimbach Pinot Gris, Reserve, Ribeauville, (\$17.99). Fresh fruit flavors, low acidity and great balance, with hints of grassiness and herbs on the palette give this one a flexibility that can let you serve it with any part of a meal. Great with cheese and fruit, grilled seafoods, even dessert courses. This wine also lays down well and will improve in bottle for the next five to ten years.

So, when you hear about heatwaves and health warnings from Europe, don't feel too worried about themthey've got plenty of "options"!

the track, after buying a bunch of rail lines from the freight operator CSX in 2009. Manufacturers were rolling out a more affordable rail car, known as a diesel multiple unit, or DMU, that cities across the country were eager to try. Rich Davey, then Transportation Secretary under Governor Deval Patrick, was quoted at the time saying, "It's not much to look at and we own the line. We control our own destiny. It's not that complicated, as a transportation project goes."

Jim Rooney, then Executive
Director of the Mass. Convention Center Authority, expecting a
DMU station outside of the Boston Convention and Exhibition
Center, said, "A direct train would be a huge feature from a competitive standpoint. If you think about it, you can walk outside the door and get into the Copley complex, which connects 3,000 hotel rooms
— Sheraton, Westin, Marriott."

As a matter of background, DMUs were once known as Budd cars. They are self-propelled trains that do not rely on locomotive engines, making them ideal for short distances and frequent stops. Manufacturers are now making federally compliant DMUs, prompting more cities like Boston to look at them as a low-cost alternative to traditional rail. A DMU train car can cost about \$4 million, compared to about \$10 million for a locomotive train.

All of this backdrop begs the question of the reality of extending this rail to the Back Bay as a transportation option to facilitate passengers into the South Boston Waterfront. Two miles separate these two sections of Boston and it is a further reality that those two miles might as well be twenty miles. Traffic clogs thoroughfares during the rush hours, and it can be hard to get a seat on the Silver Line at peak times, forcing commuters to wait it out for the next bus.

The bottom line is that the State and the MBTA should be upfront with the South Boston residents, and Fort Point in particular, about their long-term plan. The residents of South Boston are not naïve nor should they be treated as such.



He's also a strength coach and trainer along with other coaching duties which includes baseball. Like all good coaches, high up on the list of concerns is the safety of his players. But even though it's old, he and the City of Boston/Boston Public Schools make sure that it meets safety standards as it is sent out each year to be refurbished. But helmets for example, have a 10-year life span on average, but still have to be sent out before the next season begins to be checked and repaired when needed. This is a priority. But again, nothing lasts forever.

The Knights' first game is September 16th and they plan to be ready. We asked Coach Settiewhite how his team looked. With pride in his voice he replied that "They are a young team but very talented. They

work hard and give each game and practice everything they've got." They will be prepared for the 10-game season. Like most teams, the Knights are a close knit and tight group. They all love the sport and make sure they give the fans and spectators quite a show when they take to the field. They are like family and enjoy what they do.

The sport of football, especially when it comes to young players, has undergone much controversy in the past few years. Safety concerns, particularly head injuries, are a problem. So, it's important that the equipment used be tested and safe. Add to this the need of all the new high-tech items that help bring the sport into the 21st Century and it can get expensive. And as head coach Germaine Sattiewhite emphatically stated, the City of Boston provides all the support it can. But to make the Knights competitive, like most high school sports clubs, additional funding is needed and that's the reason for the appeal to the community to consider donating to this effort. 






East Boston Savings Bank Babe Ruth League Champs

ast week, the South Boston Babe Ruth league held the Championship Series down Moakley Park, between the defending champions, East Boston Savings Bank and Boston Home Inspectors. The league dedicated the series to the memory of Colleen Tallent (McMurray)

Styles retained the United States Championship, and Dean Ambrose and Seth Rollins had a mini "Shield" reunion while winning the Raw Tag Team Championship. I thought the best match of the night was Styles vs Kevin Owens, with Shane McMahon the special guest referee.
